Motion passed. F.N. will direct Comptroller to issue the check.

Worthy Faithful Navigator and Scribe,

Below is my Faithful Comptroller report for April:

- Exemplification scheduled for April 22nd cancelled. We have one candidate, Brother Robert Durden, who we will submit for the next opportunity. Waiting on Faithful Navigator signature on digital Form 4. Check has been received. FC needs to submit voucher for check to Georgia Master Fund.
- New members from previous exemplification have now been added to assembly roster. FC will print member cards this week for new members.
- Fr. Avery has been transferred into assembly. No resolution yet on transfer of SK Peter Johannes. I'm waiting to hear back from SK Peter.
- Final dues notices were sent out.
- Total in Patriotic fund allocation (from July 4th fundraisers) = \$2,674.62. This fund is "in support of the patriotic activities of the 4th Degree". \$500 will be deducted from this amount for pending donation to McGivney Military Chaplain Scholarship.
- Total in Veterans fund allocation (from Veterans Day fundraisers) = \$990.84. To be deducted from this amount is \$747.57 for VA Hospital donations (see below).
- Total in Chalice fund allocation = \$400
- Total in Uniform fund allocation = \$300 (\$300 to be deducted from this amount for SK Al Johnson uniform reimbursement). \$250 donation received last weekend from Council 6514, but not deposited yet.
- Total remaining in Operating fund = \$6,566.48
