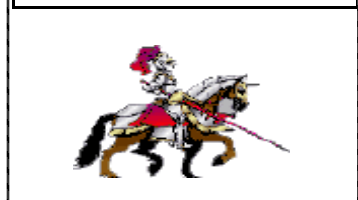

### Grand Knight's Report

The Grand Knight explained that the open position of Lecturer has been appointed to Brother Joe Passanise. The Knights in attendance congratulated Joe on his new position.

The GK reviewed our principles of Charity, Unity, Fraternity, and Patriotism and he feels that we should be doing a better job as a Council when it comes to Fraternity. As such, he has appointed Brother Mike Korpak to the position of Family Activities Director in order to organize more family life and social events.

The GK thanked Brother John Cuneo for his help with the Memorial Mass. Ideas from all Knights are encouraged for improvements to the Mass next year.

The GK attended the State Quarterly Meeting and there were six discussion groups regarding forms, membership, building the domestic church, service awards, ceremonials and the family Rosary. At this point 75% of our Knights are at least 3<sup>rd</sup> degree but the others are 1<sup>st</sup> or 2<sup>nd</sup> degree. We want to encourage them to reach at least the third degree. He reviewed the three options for 1<sup>st</sup> Degree Exemplification: a live 1<sup>st</sup> Degree Team (preferred); having the parts read by members instead of having them memorized; or by using a video created by Supreme as a stand-in. We should consider offering a Family Rosary on an ongoing basis and this will be discussed later. The other topics at the meeting were procedural in nature.

The Grand Knight presented the Knight of the Month Award to Brother John Cussen for his work in running the Blood Drives and all that he does to help in other areas. The GK also thanked John for his additional work while Brother Nick Maselli has been out.



## New Business, Upcoming Events, Committee Reports

### **Membership Director – Chuck Mack:**

Brother Chuck will be working on the article for the bulletin which is needed in November. The VIP Club (Very Important Proposer) was brought up by the Grand Knight and that certificates are available from Supreme for Knights who propose new members.

### **Program Director – Nick Sarbanis:**

Town 4<sup>th</sup> of July Celebration

Brother Nick Sarbanis said that this will not happen next year per the Civic Club.

Hampstead Lakes Race

The date for this is to be determined and Brother Nick is working on having the route changed and having it certified. If it becomes part of the race circuit it will result in more publicity and greater participation.

Golf Tournament

Brother Nick is looking at either the first week of September or the third week of June of 2018 for the tournament. Both slots are open but the September timeframe is preferred, although it is a busy month with other Council activities.

Monthly Dinner

Brother Nick reported that we had 32 take outs last month when he expected 16 as the turnouts continue to be strong. He is buying the food in bulk which is saving the Council money. Doing take outs in our meeting room and having two cashiers worked out well, along with moving the dessert table down to provide more room for foot traffic. Brother Nick is advertising the dinners with flyers along with ads in five local newspapers and on our website.

### **Youth Director:**

### **Projects in Progress:**

Brother Nick reported that the dates for the charity card games have been pushed back to January 10 and 11.

Brother Joe Passanise is leading the project to refurbish our Knights of Columbus sign. The work is in progress and the sign is now painted blue. He still needs to hand paint the gold letters and put the K of C logo on it. The sign broke into two pieces but he has repaired it. It should be completed in about two weeks.

Brother John Keisling updated the Council on The Coats for Kids Drive. 35 coats were collected after the Masses and more came in afterwards for a total of 45 coats. They are being distributed now.

### **Family Activities Director – Mike Korpak:**

Brother Mike announced the Family of the Month which is Bill and Marie Mullen. Deacon Bill is involved in

many areas of the parish including baptisms and funeral preparation as well as providing great homilies. His role as a Knight, Deacon, and his family life are being recognized with the award. In order to be eligible one must be a Knight and exemplify excellent family values. Certificates will be presented to each Family of the Month from now on.

Breakfast with Santa is being proposed for Sunday, December 17<sup>th</sup> with four sittings of 50 -60 people at 8, 9, 10, and 11am. The Knights would provide a free breakfast to kids and their families along with a small gift and a meeting with Santa. Reservations will be required. A motion was made on whether to have the breakfast and it was seconded and passed. A secondary motion by Carl Orio to fund the breakfast with \$500 was made, seconded and passed. This event will need to be coordinated with the Fellowship Ministry.

### **Scholarships**

Brother Nick reported that he is going to be proposing three \$1,000 scholarships for next year. He will be having a Scholarship Committee Meeting to work through the details.

### **Social Media**

Brother Dan Beaulé gave an update on the new website. He is looking for a content provider and would like any interested Knights to see him. The minutes are now on the website along with email addresses and phone numbers in the Member Only Section. There are also new Officer pictures which were taken at the Memorial Mass, along with additional content, links, and stories. The Events Calendar is updated and is a great way to sign up for upcoming events. Dan invites anyone who is interested in joining the committee, which meets the second and fourth Monday of each month at the Historical Society, to come to one of the meetings. The next meeting is on Monday, November 13 at 7:00 PM.

Brother Carl asked about those members who do not have access to the internet and could they possibly be reached by mail. This will be looked into. Brother John Keisling has looked at email usage by the Knights and of the 90 email addresses on Mail Chimp 70 had opened at least one email.

### **Blood Drive**

Brother John Cussen reported the next blood drive will be held on November 17. John has openings for helpers late in the afternoon. He is also looking for volunteers at 6:30 PM to help set up the Church Hall for the Christmas Fair which is on that weekend.

### **Unfinished Business**

The GK verified that the First Degree Video can be downloaded for free. Brother Chuck will take a look at this. The Hudson Council offers a First Degree Exemplification once per month.

The tabled motion to allocate \$1,000 for the needy at Christmas time was discussed, voted on, and passed. \$25 gift cards will be purchased and then will be distributed by Aline Wall.

The need for a new church van which was discussed and tabled last month was brought up. The possible \$2,000 donation toward the purchase of the new van is on hold for now as the church is waiting for a response from the bank.

### **New Business**

The GK asked for input on whether we should make another donation to the Daughters of Mary. Our previous donation of \$100 was made in June. There was no motion offered for this.

A motion was made, seconded, and passed to donate \$100 each to Kerri Liss, a novice, and Stephen Cunniff, a seminarian for Christmas. Gift cards will be given to both. At the State Quarterly Meeting the

GK learned that Kerri Liss is still a novice.

Brother Nick Sarbanis requested \$500 for the purchase of gifts for the golf outing. A motion was made, seconded, and passed to provide \$500 to Nick.

Brother Nick Sarbanis will be ordering navy blue K of C sweaters. Those interested should email Nick with your size and whether a V-neck or crew neck is preferred. The cost will be about \$24. The possible purchase of soup bowls was brought up by Brother Nick. These could be used at our dinners for chowder or soup.

Help is needed to make two dump runs on this coming Saturday. Nick needs 3-4 guys at 10:00 AM to help dispose of items that we are storing that are no longer needed by the Civic Club.

A motion was made, seconded and passed to donate \$100 to Saint Anne's Parish.

A motion was made, seconded and passed to donate \$100 to Saint Anne's Outreach Program.

Brother John Cussen requested that \$25 be provided to pay for blood drive expenses. He expects to need this about every four months. A motion was made, seconded and passed to provide \$25 for this.

We need at least **8 Knights** to help move the Creche on Saturday Nov 25<sup>th</sup> at 10:00 AM

Within the next two weeks we will be scheduling two meetings: one with our Grand Knight to review criteria for the Columbian Award and another with Nick Sarbanis and all the Programs Directors and Committee Personnel to discuss next year's calendar of events

The Council is looking to have a New Year's Celebration on one of the first 3 Saturdays in January, from 7:00 - 11:00 with Music & Dancing, This will just be a relaxing evening for council members and family without any cost and with nothing required to be brought. We will be sending out a survey asking for attendance numbers and preferred dates as well as the format of the event. The proposed dates are January 6<sup>th</sup>, 13<sup>th</sup> or 20<sup>th</sup>. Hope to see you there.

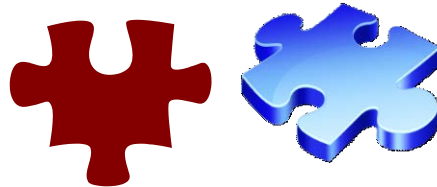
