
Grand Knight's article, continued

From Our Chaplain



The visit of our Holy Father, Pope Benedict XVI to the United States was truly a remarkable event. What initially strikes me is the amount of coverage his visit received. I cannot think of another person, whether religious leader or head of state, whose activities have been broadcast live for a week. I was happy with the generally positive nature of the cover-

age and am proud of the Church's position in our society.

Such extended coverage reflects an unspoken sense of the importance of this man. Questions had been asked whether the more reserved Pope Benedict could command the crowds and enthusiasm of Pope John Paul II. The answer is now quite clear. It shouldn't come as too much of a surprise because the importance is not so much about the man himself, but rather about whom he represents.

The crowds gather because they want to be close to Peter. It stems from that familiar encounter we know from Scripture. When Jesus entrusts the keys to Peter, he did so to make himself present in the world. The Pope holds the Keys of the Kingdom and, without fully understanding, people realize something unique is found in his presence.

To be sure, there are critics, and I had to run a gauntlet of them trying to get on the subway after mass. But even to a media often hostile to the Church's message, the presence of Peter put those voices in a different context.

Pope Benedict was direct in speaking of the problems the Church is dealing with, but even acknowledging real problems did not temper the enthusiasm of the people. With Peter comes the message of Christ, and it is always a message of hope and life. Joseph Ratzinger understands this well, and so chose as the theme of his visit, "Christ our Hope." That was the message supporting each address he gave. That was the message behind his smile and waves. That was the message carried by those who, with no regrets, waited hours for only a glimpse as the popemobile passed by.

His visit was truly remarkable, but the impact can be felt long after the cameras move on. For us Catholics he is our shepherd. We should not move on so quickly, but rather allow his message to remain in our hearts and lives. I encourage you to look more closely at his words. The entire schedule and each text can be found from many sources (such as www.vatican.va). I invite you to come to St. John's on May 7 as I make a presentation about the significance of his visit.

Notes from Your K of C Insurance Field Agent

We all know the old adage, "the grass seems greener on the other side of the fence." When it comes to replacing your existing K of C life insurance with coverage offered by another company, the adage holds true. Perceptions are deceiving. A move to the other side of the fence might seem like a good one, but it can leave you with less green in your wallet—in some cases, a lot less. That's why it pays to remember another old saying. Read the fine print.

There are many reasons to keep your existing coverage in force, whether that coverage is with the Knights of Columbus or with another company. I'll focus on the potential pitfalls of replacing coverage here—pitfalls that an agent trying to convince you that the grass actually is greener might neglect to mention.

First, all life insurance contracts contain a contestability period, which allows the insurer to contest claims made for a period, typically two years, after the contract is issued. Chances are this is no longer an issue with your current coverage.

Secondly, it's unlikely that you can obtain the same amount of coverage, for the same premium, that you were able to obtain with your existing contract. The two factors that determine how much you'll need to pay for life insurance coverage are age and health. You're older now than you were when you took out your current coverage. There's no way around that one. And you have to ask yourself whether your health has changed during that time. Is your blood pressure the same? Your cholesterol? Have you gained weight? All these factors affect the amount of coverage you'll get for your premium dollar.
