In addition to furniture of all kinds, including clean mattresses and box springs, the council needs almost all kinds of household and garage articles ranging from kitchen items to linens, pillows, decorator items, art, books (fiction, biography, children's), toys and games (if complete), tools, electronics, including television sets, large appliances, etc. We cannot use broken items or outdated electronics, such as the earlier computers, printers, and VCR's. In addition, experience has shown us that old luggage (without wheels) and window blinds do not sell. Neither do medical books, encyclopedias, and other outdated books.

Without your donations we obviously cannot fulfill our mission to help those in need. Besides assistance to individuals, we currently give donations to Jackson House (\$500 monthly), residents of Hot Springs Housing Authority (variable but at least \$300 monthly), Charitable Christian Medical Clinic (\$200 monthly), Project Hope (food bank) (\$200 monthly), St. Vincent de Paul Society (two \$500 donations annually), Focus (\$50 monthly toward support of St. John's parishioner **Tanya Cenac's** campus mission work at University of Nebraska), and St. John's School (\$1000 at St. John's Bazaar plus other amounts from other council projects such as pancake breakfasts and annual golf tournament).



Grand Knight's Report

bursed by the council for such things as payments to Morning Star Fire Department and taxes and insurance on our buildings, which are paid by Knights, Inc. The council borrows money from Knights, Inc. for various purchases and repair/remodeling costs such as for the cost of our two kitchen ranges and cost of kitchen and restroom remodeling. Then the amount borrowed is repaid as funds become available. Knights, Inc. is our umbrella in the event that we should be sued. The organization currently holds assets in CD's, savings accounts, and other investments. I bring this up only to give our members a better understanding of the relationship between Hot Springs Knights, Inc. and Knights of Columbus Council 6419.

The council is facing significant and unexpected bar expenses detailed by Treasurer **Dennis Bosch**. Please read his important article "Bar News" on page 2.

On January 20, thanks mostly to council member Hans Purkott and his wife Ilse, our council provided dinner for the participants in the current Wednesday night classes at St. John's Parish Hall. Hans and Ilse prepared 25 pounds of German goulash, red cabbage, German cucumber salad, and dinner rolls. Joe Giompoletti, Stan DeGruccio, and I were on hand to roll out the Bavarian potato dumplings for the goulash topping. **Newton White** helped us serve the dinner. Fifty-five people were served, and comments let us know that it was a blow-out success. (Hans says that the water in which the dumplings were cooked makes a good stock for potato soup. In fact, he will prove his point at our February 11 council meeting when he will serve potato soup to council members for \$5.00 a person. Hans says to come to the meeting hungry. There will be plenty of soup.) The council will serve dinner to the R.C.I.A. participants again in March with council member Iturba Percefull taking the lead.

Bar News (or Bad News)

Each year I have given a report regarding the operation of our bar. This year we have a new situation. The bar is considered a "private club" by the state and requires a special license currently costing \$500 per year. No license is required by the federal government, but we have recently learned the county does require a license fee of one-half the state fee. The license is held in the name of Knights, Inc., although the council is required by agreement to pay all bar expenses as well as revenues or loss.

Knights, Inc. received a letter from the county informing us of the license and a 5% mixed drink tax which has been in place 1969. I suspect, based on my visit to the county, some incompetence in the tax assessor's office was the reason we were not notified. We are not liable for any back taxes or fees, but must conform in the future.

Now for the additional bad news! The county tax assessor's staff provided me with state license fees for the 12month period starting July 1, 2010. The state fee will triple to \$1500, and since the county rate is 1/2 that, the county fee will be \$750.

Assuming we choose to renew both licenses and assuming we have the same receipts as in 2009 (with no price increases), we will have a net loss on the bar of \$1994 for

The above does not include direct or indirect expense for the bar which I estimate an average of \$700 annually.

Gentlemen, we have a big problem!

From Our Chaplain



What is on the mind of the world at this time is the devastation in Haiti. I'm sure this is a need that will continue for a long time to come. This need is of particular interest to the Catholic community of Hot Springs now that we have made an effort to support the people of Calladere. The

members of our parishes that have gone to Haiti tell us that it is hard to comprehend the poverty that is the daily reality for the people there. That was before the earthquake.

The interest in this disaster has filled the news in the days since the earthquake. There have been many stories of terror and stories of triumph. As a I write (now nine days after) there are still stories of people being discovered alive under the rubble. Yesterday was the story of a five-year-old boy found with no injuries, suffering from severe dehydration but recovering. It is only one story, but it a story that renews hope.

The response of the Catholic Church has been crucial in the relief effort. Haiti is a country that is 80 percent Catholic. Many members of our family of faith have been directly affected. We have all heard the news of the death of Archbishop Joseph Serge Miot as well as priests and seminarians living in Port-au-Prince. Images of the ruined Cathedral have been shown frequently. Even CNN has covered the role of the Church in this tragedy. Catholic Relief Services responded immediately, and the generosity of Catholics throughout the world is finding its way to our brothers and sisters in need. Of course the material and spiritual needs are ongoing.

We have been grateful to hear from the people of Colladere that their homes and lives were not immediately disrupted. As time passes, however, the fallout from this enormous tragedy spreads to all the people of Haiti. It is hard to grasp how fully that entire country depends on its capital for all aspects of life. Every person in Colladere has family and friends who have died.


Our Haiti Mission team has been in contact with Fr. Benive and others in the area since the beginning. Our two Hot Springs parishes contributed over \$14,000 with the first collection. We are taking the steps necessary to respond directly to the needs of our friends in Haiti. As we continue that communication and assess the growing needs oft the people, we will send what relief we can. While our Mission trip for March has been suspended, our resolve to help has only grown. We look forward to the time when we are able to return in person, but our prayers and money will continue to be offered.

At his Sunday Angelus, Pope Benedict prayed for the people of Haiti and entrusted them in a particular way to their patroness saving, "May Our Lady of Perpetual Help, patroness of Haiti, protect her children." We join our prayers with his, confident in God's love for his children in Haiti.
