From Father George Sanders: "Puppy Love"



love"....these puppy words were made Paul immortal in Anka's song (which was better known to тy generation through Donnie Os-

mond). This song kept running through my mind recently as I visited with a patient (whom we will call John) at St. Vincent's Behavioral Health unit. John is suffering from dementia and depression. As we visited, I asked him what he really enjoyed when he got to go home. He told me he loved his dogs. His face lit up as he told me that when he came down the long drive to his house, the dogs knew that he was coming. He described how each one was so excited to see him and vied for his attention. As I looked at John, he was unimpressive: approximately 50, thinning blond, stringy, shoulder-length hair. He was missing many teeth, had a scraggly beard and a deeply pitted face from previously uncontrolled acne.

"And they called it He could barely hold a conversation and would frequently lose his thought and just pause until he cold catch up with himself. He was what the medical profession would call non-functional, unable to live on his own. But his dogs loved him, just as he was. That is the way dogs are, you know. They are color blind (literally) and furthermore can't seem to recognize social status or intellectual giftedness. Dogs don't care who your father is or what company you work for or even if you can hold a job or drive a car. They are just glad to see you. They love you just as you are, with all your shortcomings.

> I guess that is similar to how God loves me. There is nothing I can do to merit his love or favor, though my actions do matter and can either bring a

smile to his face or a tear to his heart. I've also noticed that dogs have relatively short memories. When our dog, Rebel, gets in the flower bed at home, he will get what-for from me, hoping to adjust his wayward behavior in the future. As I rail at him, he will tuck his tail and cower off (apparently remorseful), throwing a glance back at me every few steps to see if I have changed my mind yet. Very soon I will find him easing up to me, tail wagging with sad, hopeful eyes looking for any sign that we are buds again. As soon as he sees a smile on my face, he will lick my hand passionately as if nothing is more precious to him than my approval. I chuckled the other day as I saw an appropriately dressed man in the posh neighborhood of West Little Rock apparently scolding his pure-bred large boxer dog who had gone around a telephone pole only to rejoin his master on the sidewalk. Spotlight on Stan and Gwen DeGruccio

Today it's often the Internet that brings couples together; back then, before the Internet, it was often a blind date.

Country song "On the Road" should have special meaning to the De-Gruccios. attention to members and wives who go far beyond ordinary council involvement, it's time for **Stan and Gwen DeGruccio** to be front and center. Sometimes together, sometimes apart, they have done wonders for our council, especially our Rummage Sale charity work.

No council member is more involved with donation collections than Stan. No one pulls the council trailer all over Garland County than Stan. He is the #I go-to man. Unless he has an important conflict, he's ready to help. And does. His involvement goes far beyond the workings of the Rummage Sales and the council Charity Committee. He involves himself with other projects such as the periodic pancake breakfasts at St. John's Parish Hall, helps with the annual council-sponsored spaghetti dinner for St. John School's Bazaar, and our annual picnics for parishioners of St. John's and St. Mary's Churches. Aside from the council. Stan also serves as one of the St. John's bus drivers who collect parishioners requiring transportation to Sunday Mass.

Gwen is one of the core participants who put together the attractive presentation of Rummage Sale items in **Spirit Hall**. Gwen's involvement is concentrated with linlinens, stitchery, and fancy handwork. Much of this work she does at home, laundering, removing stains, pressing and creating. **[See example of Gwen's handiwork, p. 8]** Gwen's completed display of handiwork is impressive with everything in perfect order.

Before moving to Hot Springs in November of 2003, the DeGruccios' residence had been Round Rock, Texas, just outside Austin. But from July of 2000 until their move here, they traveled the country and Canada in their RV.

Though Gwen was born in Illinois and grew up in California, she has close family ties to the Higdons and Roes of Hot Springs. Her grandmother was a Higdon who married a Roe. When she was growing up, she came to Hot Springs on multiple occasions to visit relatives, a practice that continued even after she and Stan married. They always liked Hot Springs, In March of 2003 they interrupted their travels to visiting Gwen's aunt and her husband on Amity They learned that they had Road. placed their next-door property on the market. The house was on the home place of Gwen's grandmother. Stan and Gwen decided to buy it. They made the purchase but continued traveling the country until November when they became local residents.

Following his graduation from Loyola Marymount University in Los Angeles, Stan became a career man as a pilot with the Air Force. Early in his career, it was Stan's roommate and Gwen's roommate who brought them together on a blind date. Gwen was in X-Ray training at Queen of Angels School of Nursing. That blind date led to their marriage on August 27, 1966.

Stan's Air Force years, typically, took their marriage to many locations: Arizona, North Carolina, Florida, Texas, South Carolina, Germany, Dayton, and back to Texas. The only assignments that separated them were Korea and Viet Nam.

They are parents of two children— Greg and Chele Greg, after graduating from Purdue, followed his father into a military career, the difference being that Greg chose the Navy. He has recently retired in Pensacola, Florida, where he has taken a new job as a Flight Training instructor. His wife Tanya teaches in Little Flower Catholic School. They are parents of two young boys.

Chele, a graduate of University of Texas, and the School of International Training in Vermont, chose a life of service abroad. She has spent several years in Africa, a brief period in Geneva, Switzerland, and more recently as a Program Director for Syrian refugees

Good-bye to Bill

On October 8 members of Council 6419 and their wives were stunned to learn of the unexpected death of beloved member Bill Thompson. Even though he had gone into National Park Hospital for major surgery several days before his death, we all were optimistic that he would bounce back quickly and return to work alongside us as he had done so many times since he became a council member. His Mass of Christian Burial was celebrated October 14 at the Catholic Church of St. John the Baptist with many friends and family members present, including an Honor Guard from the Fourth Degree Assembly.

I wrote the following tribute to Bill on the day he died: "Today--Tuesday, October 8--Bill died. I feel a huge loss. All who made up his band of brothers, along with our wives, feel this horrible devastation. Several of us had broken for lunch, interrupting our feverish preparation for our second big Charity Rummage/Furniture Sale of the year. Then, shattering the camaraderie over good food, the news comes. Bill is dead. How could that be? Only a few days before he seemed so well. He was working alongside us. He was laughing. He was joking. He was just Bill, the Bill that we all loved. Dawn, his lovely wife, whom we also love, was working with us too, as she always did. And so sudd e n l y h e is g o n e.

Bill Thompson was two days shy of a year younger than I. But he was so strong. It hasn't been two weeks since he was helping move donated furniture, heavy pieces, to our Knights of Columbus property for our approaching sale. In the posted picture from last year Bill is on his Kubota alongside the clean-up crew, pushing cut-down trees and other debris to the big burn pile. And now he is gone.

I wrote the following passage as part of a feature article on him and Dawn in August for our monthly newsletter, *Knight Watch*: 'His mechanical and carpentry skills perhaps were honed when he and Dawn came to Hot Springs [from Chicago] in 1986, purchased 120 acres of land off Hwy. 7 North near the Village, and began construction of their new retirement home. Since Bill did most of the work himself, it would be a few years before the house would be completed since he still maintained his job as purchasing agent with United Airlines in Chicago until February of 1993, when he finally became a permanent Arkansan. Between 1986 and 1993 he could come to Hot Springs to work on the new home only on weekends and vacations. The finished result was truly a home to admire.'

Bill became a member of our council only four or five years ago, but he has been instrumental in almost every council accomplishment since that day, even co-chairing our annual Christmas dinner and dance with Dawn last year. He possessed so many talents and was always ready to share them. And now, so quickly, he is gone.



opportunity to meet with the new director and make judgment on whether our donations would be well used with Safe Haven. An additional possibility for our assistance Is The Area Council on Aging on West Grand Avenue, which we believe provides a valuable community service without government assistance. Committee members want to look further into that possibility before making a decision to donate.

Finally, the group decided to repeat its evangelization effort of last Christmas by purchasing 750 copies of Scott Hahn's conversion story Rome Sweet Home from Ignatius Press for distribution at Christmas Masses at St. John's and St. Mary's Churches. The object especially is to reach those occasional Catholics who make an appearance at Mass only on Christmas and Easter. The committee is taking advantage of a one-time offer of bulk buying at a cost of \$1. per book. Last Christmas we distributed copies of Matthew Kelly's Rediscover Catholicism from Dynamiccatholic.com. Those who attend Mass regularly hopefully will also read Hahn's book and then pass it on to a lapsed Catholic or to a non-Catholic who is interested in or who may become interested in the Church.

Amazing Carol : Covering All Bases

Carol Andrews, wife of Council Member Jack Andrews, does lots of jobs for our council, totally initiated by herself. In addition to helping with the organization of donations to **Spirit** *Hall*, did you know that she, single-handedly, collected \$1425 to advertise our fall rummage sale? (She collected a similar amount for our previous two sales.) Consider this:

- Carol sent out 105 "Save the Date" post cards to people who had written a check during the spring sale or expressed an interest in the fall sale
- She checked with the Sentinel-Record and with local radio stations for advertising rates.
- Contacted "Value Direct" to see whether they would place a free ad. They did. This is mailed out to thousands of people from Hot Springs Village to Arkadelphia.
