Please remember that your council audit is also due in January. Please ensure that you submit The Survey of Fraternal Activity #1728 - and the Free throw Championship Form. Make sure your council is on the path to earning the Star Council Award and Star District.

We will also be having the Founder's Day Awards Dinner incentive. Councils that have the largest net intake by council size by Diocese will be invited to a special awards dinner to be held in June. This incentive ends March 29 – Founders Day. Please also meet with your Pastor to continue building the domestic church while strengthening our parishes. This initiative needs to be followed by all councils.

New Year's Resolutions

At this time of year we often look back at what went well during the preceding year and what we want to improve upon. We then sit down and make a "resolution", which is a promise. A promise to ourselves, (and possibly to others), that we will do better at something during the coming year. By the time you read this 2016 will be a memory and we will be starting a new year, full of promise, hope and anticipation. What are you going to promise to do better at? What did you do last year and what do you think you can do better?

In 2016, the Knights of Columbus insurance department has hit the 16th consecutive year of record growth. We were awarded, (for third consecutive year), the Ethisphere award for being the most ethical insurance company in America. We have received from Standard & Poors, and from AM Best, the highest rating available, which we have earned every single year we have ever been rated by those two independent ratings companies. HIGHLIGHTED PROGRAM OF THE MONTH

FAMILY OF THE MONTH

The Family of the Month Program is extremely valuable for the recognition of outstanding families who exemplify "Faith in Action". This year the family of the month/year will be opened not only to knights and families, but also deserving catholic families in our parishes and communities. Choose a family that has made significant contributions to the Church, community, and/or Council and at the same time enjoys one another, communicates, shares experiences and generally exemplifies the family values taught by our Church and our Order. Activities may include church ministries and committees as well as community involvement and projects

Since the selection of "Family of the Year" occurs in May, at the state convention, this program will encompass the months of April through March to ensure all nominations for a twelve month period of time will be included in the overall process. For this fraternal year the timeframe for submissions is April 2016 to March 2016. Select a "Family of the Month" each month from among your council membership, starting in April 2016 and each month thereafter through March 2017. Submit your councils Family of the Month selection to the State Family of the Month Chairman by the 15th of the month following the month for which the nomination is being made. Use the Family of the Month reporting form on the following page. The form from the Family of the Month booklet (#1993) should also be submitted to the Supreme Council. This form may be substituted for the State FOQ and a copy sent to the State Council Activities Director. As always, a copy of any forms submitted to either the State Council or Supreme must be sent to your District Deputy for his files.

Present the family a "Family of the Month" certificate (#1843), available from the Supreme Council Supply Department. Other appropriate awards selected by the Council such as the Knights of Columbus Book of Prayers for the Family may be used. The K of C Book of Prayers for the Family (item #2748) is available from Supreme Council Supply. The monthly winners for the State will receive a gift (to be announced by letter to the Grand Knight). In addition, they will be eligible for consideration as "Family of the Year" from the monthly honorees as the outstanding Catholic family. Further honors may come to your council as the "Family of the Year" selection may represent New Jersey as the State entry in Supreme's "Family of the Year Program

If you have not reached your membership quota now is the time to meet with your Pastor to schedule church drives. Contact your insurance agent and work with him to achieve the Founders Award which is your insurance quota. Keep your Council active with a good amount of activities and programs in order to fulfill the Columbian Award (Form SP7). Have your per capita taxes been paid? If not have your financial secretary take care of this and keep your Council in good standing.

I hope to see all Grand Knights and District Deputies January 7th at our Grand Knights midterm meeting. The importance of this meeting cannot be over-emphasized. The Membership Team will be there to answer questions and give positive directions.

Supreme has again brought back the \$4.50 per billable member incentive program for those Councils that reach **STAR COUNCIL**. Keep in mind the State incentives which are listed below:

> For each member that a Council recruits between July 1, 2016 and June 30 2017 less suspensions, that Council will be paid \$10.00 per new/reactivated member from the state council (net total) The amount will be issued as a credit towards their state per capita bill mailed in September,



- 2. For each new member or reactivated member, the sponsor will be entered into a state drawing at the end of year Grand Knights meeting. Copy of the form 100 to be sent to the State Membership Director. (Prizes to be determined)
- 3. For Councils that achieve the highest membership intake by diocese and by membership size will be invited to the Founders Day Dinner being held in June. (More information and the criteria to come)

This month brings a great opportunity to let our lawmakers know how important it is that we return to a Culture of Life. In Washington, it will be a show of support for our new, pro-life President. It will be a march of hope that our country has taken a turn for the better.

In New Jersey, it will be a show of political force, that New Jerseyans of all ages support life and legislation like the Pain Capable Child Protection Act. Activities like this are critical to the success of the 20/20 Project. Get your parishes involved by letting them know you are going.

If you are not sponsoring a bus to Washington, there is information on the State Council website at this LINK that may help you find one leaving from your area. Be sure to check it out. If you can't do that, then plan to attend the Rally for Life in Trenton organized by New Jersey Right to Life. Details can be found on their website through this LINK.

Speaking of the 20/20 Project, have you talked to your pastor yet about scheduling Masses yet? If not, then you need to do that right away. Once you do, fill out the form at this <u>LINK</u> and send it in. As of November 30, 2016, 705 of the 2,400 Masses have been scheduled. We still have a long way to go!

We also have our second Turn Off the TV Day coming up on Ash Wednesday, March 1. Be sure to get started planning now, and get your parish involved! Order some Pledge Cards and, with the pastor's permission, put them in the pews. Encourage parishioners to fill them out and drop them in a basket on the way out of Mass. Then display them in the vestibule! All the resources you need to do this are on the State Council website at this LINK.

Finally, I would like to offer a suggestion of a simple act of Catholic Citizenship for those of you on Facebook. If you have the app on your phone, look at the upper right hand corner of the screen where it says "Check In." This allows you to post where you are and what you are doing. The next time you attend Mass, check in at the church and let your friends know that you are there.

The media is telling people that most Catholics do not believe Church teachings and, in fact, do not even attend Mass on a regular basis! By checking in, you would be making an individual statement to the contrary. Stand up and be counted! Imagine the impression we would make if we all did it! We might even encourage other Catholics to do it as well. Let our numbers be known!
