Through it all we must never lose sight of those most affected, the victims of these evil and sinful acts. Tragically for them, their lives are permanently altered. Merely an apology can do little to heal the deep harm caused.

We must acknowledge the evil, confront it, but also not allow it to control us and take away our faith. Indeed, it is not an easy balancing act. In the end, we will endure and Christ will prevail.

In the meantime, continue to pray for all victims and for the Church. On a personal note, thank you so much for your continued support and encouragement which has always been there. Thank you so much, and keep the Faith!


