March as the the Davidson County's Historian in 2011. Title of her speech is: A Seat at the Table: How Jews & Catholics Became Leaders in the 'Buckle of the Bible Belt'

<u>Community</u>- On April 6<sup>th</sup> we are going to preparing dinner for the residents of the Dismas House. Here is a description of the Dismas House provided from their website:

The idea for <u>university students</u> and former prisoners to share a home was conceived by a group of students and the late Father Jack Hickey, O.P., a chaplain at Vanderbilt University, as an extension of the Vanderbilt Prison Project. He saw the plight of so many about to be released from jail - no home, no family, no job, and no hope - all of which contribute to recidi vism. Father Hickey and the students opened the first Dismas House in 1974 in Nashville, Tennessee.

Dismas is the traditional name of the repentant thief at Calvary (Luke XXII, 39-43.) The ex-offender is also seen as Dismas - punished, repentant, but deserving of a second chance and a new start.

Residents typically live in a house for 3-6 months, leaving with a stable income, a greater sense of self-worth and hope for the future. Residents are expected to gain employment within 2 weeks of moving in, help with the chores, attend nightly meet ings, participate in evening meals and pay program fees.

<u>Vocations-</u> With our major fundraisers completed for the year, our Vocations Committee will now receive a lot more attention. Two simples activities that I would like for us to complete are writing the seminarians while they are completing the spring semester and spending time with them as they as return back to the diocese for the summer. We will be discussing our relationship with the seminarians at the next council meeting.

#### RESOLUTION TO DISTRIBUTE THE KC FUND

Whereas, Worthy KofC Supreme Advocate John Marella and Worthy KofC Supreme Treasurer Emeritus Jack O'Reilly have determined that, for the good of the order, the Fund formed from the proceeds of the sale of the K C Clubhouse in 1997 and held by Wiley Bros./Aintree Capital, be liquidated and given to worthy organizations within the Diocese of Nashville.

<u>Whereas</u>, the spending formula below was used by Council over the years to distribute donations to past organizations and membership has voiced that it's a good framework for fairly and equitably dispersing the Fund.

Cathedral of the Incarnation	.30%
Worthy charities	.30%
Catholic education	. 20%
Diocese of Nashville seminarians and priests	.10%
Dominican sisters	.10%

Whereas, the balance of the Fund as of the last statement on 12/31/10 was \$978,539.79, and after paying our outstanding legal bill approved by Council earlier this year of \$8,530, the balance is \$970,009.79.

Whereas, the amounts listed below will be deducted from the beginning balance prior to distribution:

Council #544 seed money\$50,000.00	
Donation to the Middle Tennessee KofC MR fund <u>\$20,009.79</u>	(plus any additional accrued interest from the
	KC Fund or minus any unforeseen expenses at the
	time of disbursement)
KC Fund balance available for distribution\$900,000.00	

<u>Therefore</u>, <u>be it resolved</u>, Council #544 will distribute the \$900,000,00 KC Fund balance in the following manner and order Wiley Bros./Aintree Capital to send checks to the following organizations:

Cathedral building fund\$50,000.00	(remainder of #544 pledge from '08)
Cathedral Charities fund for parish needy\$130,000.00	(restricted to those in need only)

<u>Additionally</u>, when the entire distribution is finally completed, Council #544's trustees shall conduct a full accounting and report the results at the next regularly scheduled business meeting. After Council approval, a copy of the report will be sent to the Supreme Advocate and Treasurer Emeritus.
