Dear Brother Knights,

We are now moving into the “dog days of summer”, when people tend to slow down due to the heat and humidity of the summer months. Many councils tend to do exactly the same thing, slow down. Not being active in July and August, not having meetings and not looking for new members! Many say we just can't do a lot so we'll really get going come September!

Unfortunately you and your Council cannot afford to take this type of approach any more. This attitude, along with the thinking that after the State Convention in May the year is over (but it's not), limits you to a nine month fraternal year. You can't afford to be complacent! You and all the officers and members must start now to put your council in a strong positive position. This starts with bringing in new Catholic men into our Order. They are out there, waiting to be asked to join. It's just up to you to start working actively now, not in September to get this Columbian year off on the right foot!

We appealed to the Grand Knights and District Deputies back in June to start right out of the block, in July, to work towards achieving Star Council. We asked every DD to bring in two (2) new members from their districts. This would really jump start the year in a positive manner not seen in over five years in New Jersey! This means moving positively in July and August, getting programs scheduled and started, new members identified, screened and taking their First Degrees early in the year.

Our 2017 – 2018 goals, set by Supreme for the State Council, are not unrealistic but require everyone to do their part locally within their councils. If local councils accomplish their goals for achieving Star Council the State Council will benefit as well.

For this fraternal year we're asked to do the following:

- New Member Gross Intake – 2400 new members (200 per month from 315 councils!)
- Have a Net Intake of 1500 members (gross minus suspensions and withdrawals)
- Have 55 Councils out of 315 (17%) achieve Star Council
- Start 6 new Councils throughout the State
- Reactivate 6 councils currently suspended (for various reasons)
- Have 60 Parish roundtables in the State (currently we have 45)

These goals aren't really all that daunting to accomplish! They belong to everyone. Everyone must take ownership of them in addition to the goals developed locally by the Grand Knights, and truly believe achieving them is how we can become stronger in our Parishes, Communities and Council. In order to do this everyone must do their part towards becoming an active council, starting NOW! We have 11 months to achieve these goals. Can we get it done!

WE at the State council are here to assist in any way possible! All you have to do is ask!

Dear Brother Knights:

When I spoke to both the District Deputies and the Grand Knights in June, I talked about our Membership goals for the First Quarter of this Columbian Year. Supreme has challenged the State of New Jersey to top the best month's intake for the past five years by just one member. July of 2012 saw 129 members join the order in New Jersey, so our goal for July, 2017 is 130 members. As of today – July 22, 2017 – we have brought in 76 new members towards that goal (58.5%). I know that there are Admission Degrees scheduled for the last week of the month, so I will report back next month related to our status. A membership incentive from Supreme Council is 500 VIP points for every new or readmitted member.

How can we make these membership goals?

If half of the active councils brought in one new member – ***we make this goal!***

If each District Deputy brings in 2 members per district – ***we make this goal!***

Grand Knights and District Deputies – schedule Admission (1st) Degrees and recruit towards a specific date. Please ensure that your degree dates are shared with your Diocesan Assistants so that the degree dates can be posted on the State Website.

In the coming months, the Membership Chairmen in each diocese will be hosting a training session for Grand Knight, Council Membership Chairman, and any other Council Officer who want to learn more about the membership process and how we can productively grow the Order. Highlighted Program of the Month

THE SILVER ROSE

How did the Running of the Rose start? The Running of the Rose started with the Squires wanting to do an event for Our Lady of Guadalupe. They conceived of the idea to carry a rose, a symbol of Our Lady, from Ontario, Canada, through the United States, to Monterrey, Mexico. The first run was completed on December 12, 1960. This has been an annual event since then.

How is the Silver Rose significant? The rose is a symbol of Our Lady of Guadalupe. Juan Diego was showered with roses during an apparition. At the same site in Monterrey, Mexico, amazing roses still grow. The original run of the Running of the Rose used a real rose. From 1961 to the present, a silver rose was crafted specifically for this event. The Silver Rose is made from silver mined from Mexico.



How is the Running of the Rose run presently?

Since the significance of this program has expanded, there are 6 identical Silver Roses travelling 6 routes through Canada, through the Western, Eastern, and Central parts of the United States, to Texas. From Texas, the Roses cross the border to finish at the basilica in Monterrey. Thousands of prayer services are held along the way, making this powerful symbol available for the faithful.

How is the Running of the Rose significant for the Knights of Columbus?

The Running of the Rose represents the unity and fraternity in our Order. This unity supersedes national borders and binds Circles, Councils, and Assemblies together. Each state only

has a few weeks with the Silver Rose before transferring to the next. Cooperation and unity are essential for any successful annual run. Utmost, the Running of the Rose and the Silver Rose represents the patron saint of the Americas, Our Lady of Guadalupe. What can we not do with Mary at our side?

Who is the Contact person for the Running of the Rose for the NJ Knights of Columbus?

Former District Deputy Michael Choma is the State Chairman for the program. FDD Choma has successfully run the program in the past and plans to do so again this year.

When is the Rose available in New Jersey?

The Silver Rose will be traveling through NJ between September 3 and October 8, 2017.

Are there prayer booklets available with the Silver Rose? Prayer booklets are available for the Silver Rose program, just as there are for the Marian Icons traveling the state

How can you arrange to have the Rose in your area?

To host the Silver Rose and hold a prayer service at your Parish, contact the State Chairman, Mike Choma via email at mikechoma826@gmail.com. Arrange for an evening prayer service at your Parish, invite the entire Parish Community to attend, ask the Assembly affiliated with your Council to arrange for the Color Corps to be in attendance. Anyone handling the Rose MUST wear white cotton gloves at all times.

Let's make the Silver Rose Program successful, sponsor a prayer service in your area.

SPECIAL PROGRAMS CORNER

Brother Knights,

Please support the many worthwhile programs within Special Programs. Your financial support is critically needed and advance planning of fundraisers will help immensely! These programs will also help you on your council's journey to achieving STAR COUNCIL!

In 1983, President Reagan designated

November as "National **Alzheimer's Disease Awareness** Month". At that time, fewer than 2 million Americans had Alzheimer's; however, today, the number of Americans with the disease has soared to nearly 5.4 million. And, according to Alzheimers.net, nearly 44 million people have Alzheimer's or a related dementia. In 60% of those cases, a family member is caring for that patient. More than 40% of family caregivers report that the emotional stress of their role is high or very high which has led to \$9.7 billion in additional health care costs of their own. **Caregiver Respite Programs** provide trained caregivers that attend to an individual in need of care in order to give their primary caregiver time to relax and attend to their own needs.

The NJ State Council is asking all councils to have a fundraiser or to "shake the can" one weekend in November or other appropriate time to raise funds for **Alzheimer's Respite Care**. All monies received are issued to Alzheimer's New Jersey where 100% of the monies donated stays in NJ. For every \$1,000 earned through this State Program, the Alzheimer's New Jersey organization gives out one grant to a family in need of respite. The State Chairmen of this Program, [Neal McGarrity, PGK](#) (Northern Councils) and [Jack Persia, FM](#) (Southern Councils), will take donations in any amount to attain the goal of 50 grants. Please see the [Grand Knight's Handbook](#) for the counties they serve and where to send the checks. Also, "Regional Walks to Fight Alzheimer's" are coming up in September and October. See [Alzheimer's New Jersey](#) for more details and advise your State Chairman of your participation results!

We now have aprons for Alzheimer's Fund Drives and they cost just \$16 each. Please add \$5 to the total for shipping. - **Bells for Babies.**

This one is an easy, no-brainer, as you are asking your parish to ring its bells on January 22.

- **Window to the Womb.**

Place a copy of this DVD into your parish's Youth Ministries/CCD Program.

- **20/20 Project.**

Schedule a Mass in your parish by the end of 2017 for the "Protection of Babies in the Womb and Their Families."

INSURANCE MATTERS

Brothers,

A recent article in the New York Times, (Saturday July 15, 2017), Business Day section, complained about the cost of Long term care. The article correctly related the rising costs, the debilitating effect on family and retirement nest eggs. It noted that a lot of people who wait to purchase the insurance until their 60 or even into their late 70's don't get approved, (25% of those between 60-69 are declined and 44% of those between 70-79 are declined). It predicted that the Medicaid, (a joint program of the Federal and individual states), which pays a lion's share of long term care costs, will not be able to shoulder the ever increasing costs of care for the baby boomer generation and beyond.

The solution proposed by the columnist turned my stomach. The New York Times writer, Ron Leber, advocated for assisted suicide as an answer to the problem of how to care for elderly family members who need care. He got a retired Episcopal priest, whose own father died of dementia, to advocate for the "aid in dying" movement.

So what the New York Times is saying is that because it costs a lot of money to care for a family member in a nursing home, (or it is a burden on the family to take care of that family member at home), and since it could make retirees use up all of their savings, or have to buy insurance to cover the costs, (and that insurance is costly), and that people who wait too long to buy, instead of buying earlier in life, (when costs are less and when they are healthy), that is better to help our loved ones commit suicide. The NY Times is trying to make an economic case that too much to care for Grandma, so let's snuff out her life, or, Dad's going to not be able to give us money when he dies, so let's help him kill himself.

The earlier you buy protection against LTC, the less you pay over the years. The longer you wait, the greater chance there is that you will have an issue that could make you uninsurable. Those two facts, are made into the NY Times case for saying don't worry about doing the right thing and taking care of your family, let's just "assist them in dying", so the family doesn't have to pay the premiums for insurance or for the cost of care. As Catholics, and as people committed to family, we all need to be outraged by this attack on our families. Your insurance agents in New Jersey are here to help you plan and put in place a program that will make this issue a non-starter for your family. Let us show you what we can do, so that we don't have to give into this culture of death being spewed at us by supposedly respectable media outlets.

E-Mail Safety, Protocol and Courtesy

The state website is vigilant 24/7 to protect its integrity, but also your privacy. We use an open-source program "Spam Assassin" to filter out over 10,000 pieces of spam each day – directed at our mail server. I use additional proprietary programs to further reduce spam on my computers. Not every piece of blocked mail is spam – some is (was) legitimate!

Some mail that wound up being blocked just in the past 24-48 hours were blocked, or unopened for the following reasons:

- No subject in the subject line – will not be opened
- ALL CAPS in either the "from:" or subject line – deleted
- Subjects such as "This is for you" – no thanks!; or "I thought you would like this" – you would be wrong!; or links only in the body – deleted

How to be reasonably safe my mail is legitimate:

- I will capitalize the first word in the subject line
- I will repeat the capitalized word in the body
- I will reference, in detail, any attachments
- I will close with "Vivat Jesus!!!"
- When in doubt ask, 24/7 – "We Never Close!"
- I do NOT sit chained to my desk and I am not always logged into my e-mail accounts. If you send me something that is urgent, call me and ask me to check my mail.

Now, a word about courtesy:

We are all volunteers. I happen to enjoy what I do for ALL of you, and I am always open to any and all suggestions an even constructive criticism. I am not on Skype; if I were you would see that I always answer the phone with a smile! Don't *assume* your difficulty is with the State website...it may be, but keep an open mind.

This month I fielded several "assumptions" that were posed in a very uncharitable manner. It turns out, in every case, the issue was with the Supreme website.

Bottom Line Brothers: Stay Calm! I can walk you through virtually any crisis! Be respectful, please.
