Veterans



There are veterans that are not as fortunate as some of us. Their daily lives are filled with loneliness or a battle to survive. We find these veterans in the VA hospital or

nursing home, or worse yet, on the streets. Some families of veterans are also facing hardships.

We can help ease some of the veteran's burdens by making small donations of personal items and food items. These donations are accepted at every Council business meeting. Following are some suggestions for donations.

Personal items: deodorant, tooth brush, tooth paste, disposable razor, shampoo, soap, comb/brush, new socks, disposable diapers, baby wipes, baby powder, paper plates, cups, napkins, toilet paper and paper towels.

Food items: canned fruit, soups, broth, tuna, vegetables, meat/beef, spaghetti sauce, spaghetti/pasta, crackers/cookies, cereals (hot or cold), macaroni and cheese, peanut butter, jams/jelly. Donations can be left on the table near our storage closet. Thank you in advance from our Veterans.

Venerable Father McGivney

Founder



People who knew Father McGivney in this period were impressed by his energy and intensity. Father Gordian Daley later recalled, "I saw him but once, and yet I remember this pale, beautiful face as if I saw it only yesterday. It was a 'priest's face' and that explains everything. It was a face of wonderful repose. There was nothing harsh in that countenance although there was everything that was strong."

William Geary, one of the Order's charter members, said that at the first council meeting in 1882, Father McGivney was "Acclaimed as founder by 24 men with hearts full of joy and thanksgiving; recognizing that without his optimism, his will to succeed, his counsel and advice they would have failed."

Father McGivney had originally suggested Sons of Columbus as a name for the Order. This would bind Catholicism and Americanism together through the faith and bold vision of the New World's discoverer. However, the word "knights" replaced "sons" because key members of the organizing group who were Irish-born Civil War veterans felt it would help to apply a noble ritual in support of the emerging cause of Catholic civil liberty.



The first public references to the Order came on February 8, 1882. Both the *New Haven Morning Journal* and the *New Haven Courier* reported that the Knights of Columbus had held an initial meeting the night before.

On March 29, the Connecticut legislature granted a charter to the Knights of Columbus, formally establishing it as a legal corporation. The Order's principles in 1882 were "unity" and "charity." The concepts of "fraternity" and "patriotism" were added later. Each of these ideals played a major role in ceremonials from the beginning. The Columbus-linked themes, says historian Christopher J. Kauffman, "reverberated with pride in the American promise of liberty, equality and opportunity."

Insurance Corner

Disability Income Insurance

<u>What is it?</u>

Disability income insurance helps replace lost income when you are unable to work due to a disability resulting from an illness or accident.

Who needs it?

Disability income insurance helps protect your most important financial asset – your paycheck – so it should be an important part of every family's planning. Long-term disability is much more common than other unfortunate circumstances that are commonly covered by insurance. Consider the fact that you face a 1 in 100 risk of losing your home to a fire, but a 1 in 4 risk of suffering a longterm disability.

Despite the odds and the prevalence of long-term disability – nearly 11 million Americans are

receiving federal disability benefits – more than 100 million Americans are without private disability income insurance. In addition, any disability income insurance you may have through your employer may very well be insufficient or contingent on certain circumstances (like worker's compensation).

How does it work?

Knights of Columbus disability income insurance policies provide a monthly benefit amount over the course of a maximum benefit period (see below) designed to help replace the income that you would have otherwise received if you were able to work. You are free to use your disability income benefits in whatever way you see fit – just like you would with your own paycheck.

Knights of Columbus Disability Income policies also come with special features, such as the total, partial, or presumptive disability income benefits, which help protect against special circumstances. As an added bonus, our disability income insurance policies come with a waiver of premium provision, which waives your policy's premiums while you're suffering from a disability.

What options do I have?

Benefit Period

The maximum benefit period is the longest period for which monthly disability benefits are payable for any one period of a disability. The benefit resets once the disability concludes. You may choose from:

2-Year – Protect your paycheck with two years of disability income payments.

5-Year – Protect your paycheck with five years of disability income payments.

To Age 67 – Protect all your working years with disability income payments until you reach retirement age.

Monthly Benefit

Working with your Knights of Columbus field agent, you establish the monthly benefit amount that the policy provides, based on your income and subject to certain limits.

Elimination Period

Disability income insurance policies come with an elimination period, which serves as your deductible or out-of-pocket amount. You can select a 30, 90, or 180-day elimination period, after which time your benefits will begin to be paid.

Additional Features and Benefits

A number of special features and benefits – often called riders – are available on Knights of Columbus disability income insurance products. For instance, the catastrophic disability rider provides an additional monthly benefit in the event of a catastrophic disability, and the cost of living adjustment rider helps your monthly benefit keep pace with inflation during a long-term disability.
