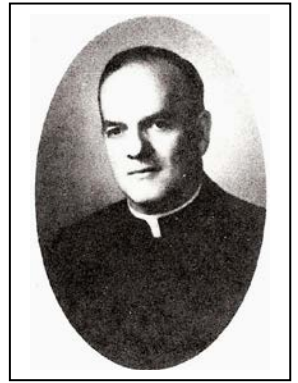

We begin June with the Ascension of Jesus into Heaven and the fulfillment of His promise to send an Advocate Who would visibly descend on the Blessed Mother and the Apostles at Pentecost, an Advocate Who will "be with you always," Who will "teach you everything and remind you of all that I told you," Who will "guide you to all truth."

It is the Holy Spirit Who continues to guide the Church. Our faith can be, indeed has been, shaken by events within the Church. But a little shaking is not a bad thing – it serves to wake us up to what we may have begun to take for granted, in the Church and in our own lives. To accept Jesus demands a daily commitment to trust in Him, to do what He asks us to do, to follow where He leads. Our faith is ours to maintain or abandon – while it can be affected by the actions of others, it cannot be lost by those actions – that is a decision which we can attribute to no one but ourselves.

And believing in Jesus means believing in the Church He built upon the rock of Peter, against which the gates of the netherworld would not prevail. Believing not in the flawed humans who people that Church, but in the power of the promise of the Advocate Who would continue to guide it.

Jesus promised to not leave us orphans – but to abandon the Church is to make ourselves orphans, to leave the protection of the family with which we have been gifted to guide us home to Heaven, to imagine the power of unreliable humanity as

greater than the power of the Spirit who continues to lead us, in spite of the failures of men.

Having said all that, we certainly welcome our new Archbishop, Wilton Gregory, and pledge our support and loyalty as he undertakes, at the Spirit's prompting, the leadership of the Archdiocese of Washington.

May his stewardship of this Church provide not only healing but also a greater commitment to follow Jesus, to embrace the Holy Spirit, to give glory to God in all that we do. Archbishop Gregory's motto is "We Are the Lord's" – let us make that our daily reminder. Let us also express our gratitude and best wishes for Cardinal Donald Wuerl as he embarks on retirement, thanking him for all that he has done to manifest God's Kingdom through our local Church. May God bless us all.

MARY, MOTHER OF THE CHURCH

The Blessed Virgin Mary, our mother and model, intercedes for and consoles the Church, the body of Christ

INVALUABLE TO the Christian life is a warm and loving devotion to Mary, the Mother of God. I was blessed to grow up in a home where the rosary was prayed daily, even on the busiest and most difficult days. There was always a statue of the Blessed Mother in our home and other reminders of Mary's love for us, her children. At school, May processions culminated in the crowning of a statue as we all sang to Our Lady.

In time, I got into the habit of praying a daily rosary, and as I meditated on the life of Jesus through the eyes of Mary, my vocation came into sharper focus. In my final years at Mount St. Mary's Seminary in Emmitsburg, Md., I often went to the beautiful grotto up the mountain, a national shrine dedicated to Our Lady of Lourdes. In the quiet of that grotto, my love for Mary deepened as I prepared to serve the Church as a priest.

But it was not until I visited Lourdes, France, for the first time in the 1980s, that I was overwhelmed with the healing power of the Blessed Mother's intercession. In that holy place, where Mary revealed herself to St. Bernadette as the Immaculate Conception, I experienced a wonderful healing, cleansing and renewal of body, mind and spirit. Over the years, I have returned to Lourdes many times, often with pilgrims, many of whom suffer from serious illnesses. I visit with them before they go into the baths and, when feasible, pray with them after they emerge. The purifying love and powerful intercession of Mary is palpable in those encounters.

My love for the Blessed Mother likewise intensified when I visited the Shrine of Our Lady of Guadalupe in Mexico City for the first time in 1990 and looked upon her miraculous image. The experience filled me with joy and opened my eyes to Mary's role in the evangelization of the world.

Inspired by these experiences, Marian devotion has become an essential part of my life. Like every good Knight of Columbus, I carry a rosary in my pocket. My father's own K of C rosary also remains in the little chapel in my residence. When the house is quiet at night, I often slip into the chapel and pray with my dad's rosary. As I do so, I think about all the people I met during the day and the many people who asked me to pray for them. As the day comes to a close, nothing is more consoling than to spend a little time in conversation with Mary.

I also look upon a beautiful statue of the Blessed Mother that I received from Cardinal James Hickey, my mentor

and friend, when I became a bishop many years ago. When I look upon that image, I never fail to pray for the cardinal, whose example and memory continue to influence my life so deeply.

During the month of May, we honor Mary in a special way, and on June 10, the Monday after Pentecost, we will celebrate her as the Mother of the Church. Her virginity symbolizes the truth and purity of the Church's teaching and the sacrifice that the Church daily offers. Her motherhood symbolizes the maternal care that the Church gives to us, her children, reborn by water and the Holy Spirit. This love reaches us through many channels, not the least of which are the Church's ministries of healing and charity. And when members of the Knights of Columbus live the principle of charity, we help extend the loving care of the Church to the poor and the vulnerable.

These days, though, it is the Church — sinful in her members — that needs healing. Sins against young people and the failure of Church leaders to respond continue to haunt and hobble the Body of Christ. Many practical steps still need to be taken to ensure that bishops and other leaders are held accountable for their actions. But those steps alone, important as they are, won't fully heal the Church's wounds. For that, we must turn our gaze toward Mary, asking her prayers that the Church might be purified, cleansed, healed and renewed.

REFLECTIONS

Promoting Equality Through Coercion (by Lawrence P. Grayson)

The misnamed Equality Act of 2019 -- perhaps the most egregious and far-reaching assault on religious freedom, individual conscience, and free speech ever put forth in this nation -- was passed by the U.S. House of Representatives on May 17.

The bill, if enacted, would make sexual orientation and gender identity equivalent to existing protections for race, color, national origin, sex, disability and religion under the 1964 Civil Rights Act, while negating the free exercise protections of the First Amendment as reaffirmed in the Religious Freedom Restoration Act (RFRA). It would affect virtually every aspect of American society, as it would apply to "any establishment that provides a good, service, or program," including those engaged in public education, lending, housing, employment, federal assistance, health care, transportation, entertainment, recreation, exercise, public facilities, and more.

The title, Equality Act, is an alluring bromide, meant to disarm a not-very-aware public. It illustrates the hypocrisy of a

government that proclaims the absolute equality of all its citizens but gives special privileges to a small segment. To paraphrase George Orwell in his novel Animal Farm, under the Act, "All people are equal, but some people are more equal than others."

Perhaps, the most publicized provision of the bill is its mandated access to communal facilities "in accordance with an individual's gender identity." Women and girls would be required to share restrooms, locker rooms, dressing rooms, and even showers, in schools, university dorms, retail stores and other venues, with biological males.

A sampling of current government overreach foreshadows an ominous future, if the Act becomes law.

The federal government, for example, would be able to dictate the hiring and firing of staff and the admissions policies in Catholic schools. In 2018, a Catholic elementary school in Florida fired a female teacher for marrying another woman. A kindergarten-aged child in Kansas was recently denied admission to a Catholic school because his parents are in a same-sex union. In both of these cases, the schools would have been forced to take the opposite actions, in spite of Church teaching.

The legislation would encourage LGBTQ-inclusive educational curricula for children in public schools. When accrediting agencies follow suit, will Catholic schools be able to resist including material about same-sex lifestyles? A few days before the House passed the Equality Act, the popular PBS television cartoon series Arthur, which receives significant federal funding, showed Arthur and his classmates joyously attending their male teacher's marriage to another male. And, there currently are numerous examples of "drag queens" holding story hours in libraries, schools and book stores to affect the minds and imaginations of young children with glamorous, positive role models of gender fluidity.

Catholic adoption ministries could be shut down nationally. Pennsylvania, Illinois and Massachusetts have already effectively closed Catholic adoption agencies in those states by requiring them to place children with same-sex couples, which violates Catholic convictions about marriage and family.

Last year, a girl was removed from her parents' custody when they refused to have her medically transition to a male, but instead wanted her to receive counseling for her gender confusion and remain a girl. Under the Equality Act, government agencies could take children from their parents, if they refuse to provide transitional treatment.

Retail service companies, such as florists, bakers, caterers, photographers, and event consultants, that willingly serve all customers, but will not in good conscience help celebrate same-sex weddings, will be driven out of business. Jack Phillips, owner of Masterpiece Cakes, legally fought the Colorado Civil Rights Commission for several years before the U.S. Supreme Court ruled that the Commission had acted prejudicially in upholding the complaint of a gay couple that he refused their request for a specially-designed wedding cake.

Even though the Supreme Court legalized same-sex marriage in 2015, the Equality Act goes beyond mere approval to require total acceptance of these unions. It defines belief in traditional marriage as a "sex stereotype" and makes a sex-stereotype illegal under federal law. If churches do not at least recognize, if not celebrate, same-sex marriages, it is possible that they could be sued or lose their tax-exempt status.

The claim that the Act will create equality in athletics is a sham. When Title IX, which prohibits sex discrimination in education programs, was enacted, women's sports at the high school and collegiate levels expanded enormously. Then, in 2016, the Obama administration interpreted the term "sex" under Title IX to include "gender identity," which allowed any male who claimed to identify as female the right to participate in women's sports. The result was inevitable. Biological males, who have natural physical advantages in size, strength and speed, dominated events when competing against females. Although President Trump revoked the Obama policy, the Equality Act would write gender identity into law. The many legal protections women now enjoy would be effectively eliminated, with the result that women's athletics would be essentially destroyed.

In the health sector, the ramifications of the Act would be enormous. Puberty-blocking hormonal treatments for children could be deemed necessary and standard health care. Doctors and nurses would be required to provide gender transition treatments and sex-change surgeries, even if these procedures violated their medical judgments and religious beliefs. Further, the language in the Equality Act is general enough so that courts could interpret it to mandate taxpayer funding for abortions and to nullify conscience protections for medical providers who object to performing these procedures.

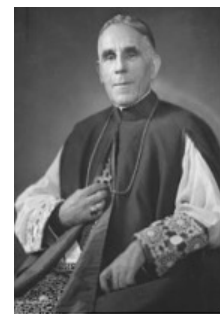
Inevitable conflicts will arise between those who wish to adhere to their religious beliefs and advocates for LGBTQ "rights." Persons and groups holding traditional Christian beliefs about marriage, the distinction between sexes, and gender being determined at birth would be marked as bigots and exposed to legal action. Without the protection provided by RFRA, the Equality Act would tip the judicial scale against religion. In essence, the Act would criminalize Christianity and persecute Christians for their beliefs on sexual morality and gender issues.

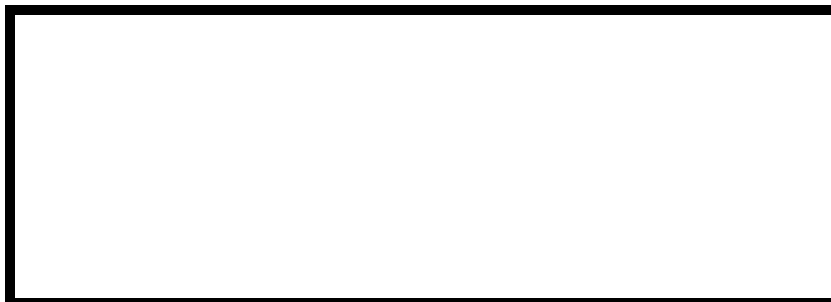
