

#### **CHAPLAIN'S THOUGHTS**

We all suffer in this life, some much more than others. If someone tells you about the suffering that they are going through, it probably brings to mind a suffering of your own. Your response to the person could very well be, "I know what that's like." Now, think of the Agony, Suffering, Crucifixion, Death and Burial of our Lord. Jesus can honestly say to each of us about our suffering, "I know what that's like." However, Jesus can also say, "Come, all you who pass by



the way, look and see whether there is any suffering like my suffering." Can we say that we really know what His suffering was like?

Saint Paul tells the Philippians that "though he was in the form of God, Jesus did not regard equality with God something to be grasped. Rather, he emptied himself, taking the form of a slave, coming in human likeness; and found human in appearance, he humbled himself, becoming obedient to death, even death on a cross.

Jesus endured His suffering out of obedience to His Father, because He loves His Father, and because He loves us so much that He was willing to die for us. His suffering ended on the Cross, the "tree of death," which became for us, the "tree of life." His death on the Cross made our eternal life in Him possible. Through His passion, death, and resurrection, Jesus reversed the disobedience of original sin by obeying his Father's will in spite of the devil's temptations, the betrayal of Judas, the abandonment of His apostles, the false accusations, the condemnation, the humiliation, the scourging, the crowing with thorns, and the torture of crucifixion.

This week, we need to stay united to Jesus Christ, our loving Savior. We need His strength to come into our lives, so that we can have the courage to live as He wants us to live. The ways we can stay united to Christ this week are by prayer, fasting and good works. We should spend more time in prayer this week, and more heartfelt sincerity in our prayer. This week, we must resolve to let Christ lead us, to concentrate on doing His will, not ours. This week, we can initiate Christ's Passion by doing what He did, by sharing our neighbors' sufferings, by taking upon ourselves the crosses of others.

We must see that we are not called to be spectators to Jesus' suffering and Passion; we are called to be active participants in His suffering and Passion. We participate in Christ's victory over suffering, sin and death, by carrying our sins to Calvary, just as Jesus carried His Cross. Then, He can save and heal us by nailing our sins to the Cross. He calls us to bring our sins to Him, and in exchange we get to carry Him everywhere we go, and into every heart we touch. Jesus wants to bring His salvation and His healing love to the world through us. A donkey carried Jesus into Jerusalem on that first Palm Sunday. Now, it's our turn to carry Him to others, for the rest of our lives.

## New Incentive For Fraternal Year End

Star Councils are the strong foundation upon which the Knights of Columbus' growth in charitable works, membership and insurance rest. In continuing recognition of the outstanding councils that earn this distinc-

tion, the Supreme Council has initiated a new incentive.

If a council earns the Star Council Award (at any level) in the 2014-2015 fraternal year, it will receive a credit of \$4.50 (\$3.50 per capita and \$1 Catholic Advertising) for each billable member on its roster as of July 1, 2015. Please note that this special Star Council incentive is only offered for insurance territories (United States, Canada, Puerto Rico and Guam).

For example: A council with 100 billable members on its roster as of July 1, 2015, will receive a credit of \$450.00 on the September 2015 statement. Be advised that non-billable members include Honorary Life members and those who have disability waivers.

Only through growth can councils be successful as they strive to earn Star Council Award status. Recruiting and retaining members is the result of successful, active council programs.

Grand Knight, as a fraternal leader you should continually review the council and its membership numbers. Ask yourself: Is your council on pace to make its membership and insurance quotas? Is your council conducting programs that include a large percentage of its membership? Where do you stand on insurance and membership? Is your council in tune with your chaplain? Does your council involve your field agent? How are your programs and activities doing?

What do these results tell you? The numbers are the report card. The better the numbers, the better the programs have been in connecting the members of the council and uniting them in a common cause

The only way to improve these numbers is to expand the programs of the council, to include and connect to more members, and to be involved, visible and connected to parish life. Good programs and activities involve your council members, build enthusiasm and bolster your membership efforts. Programs provide opportunities to welcome new members into your council, which is the first step in qualifying for the *Star Council Award*.



A new Knights of Columbus-produced documentary on St. John Paul II and his relationship with North and South America will screen this month on national television networks.

John Paul II: Uniting a Continent explores how the papacy of St. John Paul II left an indelible mark on the American continent. Driven by his singular conviction of a "United American Continent" under the patronage of Our Lady of Guadalupe, John Paul II's papal travels from Argentina to Alaska generated massive crowds, shaped an entire generation and ultimately changed the course of history.

Narrated by actor Andy Garcia, the film features rare archival footage and insightful analysis from leading figures, including Cardinal Sean P. O'Malley of Boston, Supreme Knight Carl A. Anderson, John Paul II biographer George Weigel and former Vatican spokesman Joaquin Navarro-Valls. Viewers will be both intrigued and moved by the documentary's unprecedented framework for understanding one of the giant figures of our times.





# Fraternal Benefits Advisor Protect Your Family With

#### Two Problems, One Solution

In the summer of 1873, as a young seminarian in Canada, he was forced to leave theological studies and return home to aid his family after the sudden death of his father, Patrick. "He was reeling," it says in his biography *Parish Priest*. "He packed his belongings, knowing that he would never return to Sainte-Marie, and went home."

"Money for tuition was no longer available," the authors continue. Even if the McGivney family could survive without Michael's financial support, it was not clear that he could survive without help from them — or someone." Michael was able to continue his studies only after receiving a scholarship from the then-Diocese of Hartford.

Less than a decade later, as an associate pastor at St. Mary's Church in New Haven, Conn., Father McGivney was faced with an all-too-similar situation.

One of his parishioners, Edward Downes Jr., was forced to quit the seminary after his father died unexpectedly. He returned home to New Haven to support his mother and 12 siblings.

In those days, the court had the right to assign children to public institutions if it had reason to believe that their families could not properly care for and support them. Unless they were represented by a financially secure guardian in court, the teenage Downes boys would be removed from their family.

On February 6, 1882 — the very same day as the first meeting for what would become the Knights of Columbus — Father McGivney appeared in court to stand as guardian for Edward's brother Alfred. The court accepted, yet Father McGivney was frustrated by the recurring nightmare of financial hardship.

"Even though he was only a young man," *Parish Priest* says of Father McGivney, "he was filled with a lifetime of anger and frustration at the sense of doom that settled over nearly every family that lost its wage earner. ... On the afternoon of February 6th, he was more determined than ever that what had happened to the Downes family need not happen to anyone else."



#### The Missions Begins - And Continues

In that spirit, Father McGivney set off with "entrepreneurial zeal" to found the Knights of Columbus. In his own words, Father McGivney wanted the organization to "to unite the men of our Faith throughout the Diocese of Hartford, that we may thereby gain strength to aid each other in time of sickness, to provide for decent burial, and to render pecuniary assistance to the families of the deceased members."

He knew what life was like without that assistance. The initial system of "life insurance" designed by Father McGivney was a simple one, a pass-the-hat system through

which each member could help support his brother Knights.

As the organization grew council by council, state by state, and country by country, so too did the insurance program. The pass-the-hat system was transformed into one of the largest and most highly rated life insurance programs in North America.

The Knights of Columbus has passed many milestones and received many accolades along the way: \$97 billion of life insurance in force, 39 consecutive A++ (Superior) ratings for financial strength from A.M. Best, 14 consecutive years of sales growth, and designation as a 2014 "World's Most Ethical Company," but all that is secondary.

What matters most is that we continue to fulfill Father McGivney's mission of offering and providing financial protection for Catholic families.

2015 is not 1882. Times are different. Laws are different. Economies are different. But even for those families who may have slightly more than next-to-nothing, insurance protection can be the difference between getting by and getting evicted. In its role as the premier Catholic life insurer, the Knights of Columbus continues to provide a valuable and noble service.

#### MASTER'S LOG REPORT

It is that time of the year when all Assemblies are getting ready to elect new Officers for the 2015-2016 fraternal year. In that regard, it is important to remember that all Assembly elections must be conducted during the month of May.

The following is an excerpt from Laws and Rules Governing the Fourth Degree: Article VIII: Section 24 (j): Elections.

The regular election of officers in Assemblies shall take place annually at the first regular business meeting of the assembly held in May of each year.... The Faithful Navigator shall within ten days after the election, file report of the same, together with the names and addresses of all officers elected, with the Master of the District, and shall send a duplicate to the Supreme Secretary.

The report referred to in the last sentence is the Supreme Report Form 186 - Report of Officers Chosen. Supreme expects 100% completion no later than June 30th.

*Heads Up!* The council will have the honor of hosting a Maryland State Council Third Degree on April 17, 2015.





# Marian Title for April Our Lady of Knock

On the evening of August 21, 1879 Mary McLoughlin, the housekeeper to the parish priest of Knock, County Mayo, Ireland, was astonished to see the outside south wall of the church bathed in a mysterious light; there were three figures standing in front of the wall, which she mistook for replacements of the stone figures destroyed in a storm. She rushed through the rain to her friend Margaret Byrne's house.

After a half hour Mary decided to leave and Margaret's sister Mary agreed to walk home with her. As they passed the church they saw and amazing vision very clearly: Standing out

from the gable and to the west of it appeared the Blessed Virgin, St. Joseph and St. John. The figure of the Blessed Virgin was lifesize, while the others seemed to be neither as large nor as tall. They stood a little away from the gable wall about two feet from the ground. The Virgin was erect with her eyes toward Heaven, and she was wearing a large white cloak hanging in full folds; on her head was a large crown.

Mary Byrne ran to tell her family while Mary McLoughlin gazed at the apparition. Soon a crowd gathered and all saw the apparition. The parish priest, Archdeacon Cavanaugh, did not come out, however, and his absence was a disappointment to the devout villagers. Among the witness were Patrick Hill and John Curry. As Patrick later described the scene: 'The figures were fully rounded, as if they had a body and life. They did not speak but, as we drew near, they retreated a little towards the wall.' Patrick reported that he got close enough to make out the words in the book held by the figure of St. John.

An old woman named Bridget trench drew closer to embrace the feet of the Virgin, but the figure seemed always beyond reach. Others out in the fields and some distance away saw a strange light around the church. The vision lasted for about three hours and then faded.

The next day a group of villagers went to see the priest, who accepted their report as genuine; he wrote to the diocesan Bishop of Tuam; then the Church set up a commission to interview a number of the people claiming to witness the apparition. The diocesan hierarchy was not convinced, and some members of the commission ridiculed the visionaries, alleging they were victims of a hoax perpetrated by the local Protestant constable! But the orinary people were not so skeptical, and the first pilgrimages to Knock began in 1880. Two years later Archbishop John Joseph Lynch of Toronto made a visit to the parish and claimed he had been healed by the Virgin of Knock.

The Church approved the apparition in 1971 as being quite probable, although it has never been formally stated. The Shrine at Knock is opened year round. In 1994 three life-size statues were erected of Our Lady, St. Joseph and St. John.

#### Transforming the St. Patrick's Day Parades

St. Patrick's Day, which is a holy day of obligation for Catholics in Ireland, has been corrupted in America by homosexual activists who flaunt their opposition to Catholic doctrine. Celebratory parades have been coopted for dissident political purposes.

Since the seventh century, St. Patrick has been revered as the patron saint of Ireland. His feast day was officially placed on the universal liturgical calendar of the Catholic Church in the early 1600s, thus, liturgically commemorating the saint and his role in converting Ireland to Christianity.

In America, his feast day was celebrated even before this country became a separate nation. The Charitable Irish Society of Boston organized the first observance of St. Patrick's Day in the thirteen colonies in 1737, while Irish soldiers serving in the British army staged the first recorded parade in his honor in New York City in 1762.

With the dramatic increase of Irish immigrants to the United States beginning in the mid-19th century, the observance expanded throughout the country and started to gain a cultural purpose celebrating a common Irish immigrant experience in America. The various parades, however, retained a strong religious aspect as the vast majority of Irish-Americans were Catholic.

With the growing secularization of America, the weakening of adherence to Church teaching, and a growing belligerence on the part of lesbian, gay, bisexual, and transgender (LGBT) groups, there were increasing demands and pressures on parade organizers to admit these groups to march and proclaim their sexual orientation in direct opposition to what Catholicism stands for.

Homosexuals have marched in the parades for many years, but have done so as members of organizations that promote Irish heritage. This year, after decades of opposition, gay and lesbian groups marched under their own rainbow banners in the St. Patrick's Day parades in Boston, Washington, DC, and New York, while Catholic moral teaching was ignored in Norfolk, Virginia.

In Washington, some 40 members of a contingent from the DC Center for the LGBT Community marched down Constitution Avenue, accompanied by a car adorned with rainbow flags and shamrocks.

In Massachusetts, the South Boston Allied War Veterans Council, a private group that organizes the 114-year-old parade, had consistently banned gay groups from participating, holding that homosexuality conflicts with Catholic doctrine. Their position had been confirmed when the Supreme Court unanimously ruled in 1995 that the group had a First Amendment right to exclude whomever it wanted. The organizers, however, came under intense pressure to change their position, which ran counter to the liberal attitudes that prevail in Massachusetts; in 2004 the state became the first in the nation to legalize same-sex marriage. Two LGBT rights groups, Boston Pride and OutVets, joined in the South Boston St. Patrick's Day Parade this year.

The organizers of the New York parade, the city's 254<sup>th</sup> annual march up 5<sup>th</sup> Avenue, also buckled under external pressure. NBCUniversal, which has broadcast the parade for many years, threatened to drop its coverage unless a gay group was included. The organizers allowed OUT@NBCUniversal, the company's employee group of homosexuals, to march under its own banner. Thus, the committee retained the broadcast network and had the brewers Guinness and Heineken, which boycotted the event last year, return as sponsors. Wanting to "keep 2015 focused on the

gesture of goodwill we made towards the gay community," the parade committee further denied the request of Children First Foundation, a pro-life organization, to march.

Cardinal Timothy Dolan, Archbishop of New York and this year's grand marshal, said he thought "the decision is a wise one." This contrasts with the position of his predecessor, Cardinal John O'Connor, who in 1993, while avowing his love and prayers for homosexuals, stated that he "could never even be perceived as compromising Catholic teaching" by entertaining their admission as an identifiable group in the parade. At the Cardinal's Mass before the 1993 parade, the faithful sang the hymn "Hail, Glorious St. Patrick," intoning, "In a war against sin, in the fight for the faith, Dear Saint, may thy children resist to the death." No such hymn was sung this year.

In Norfolk, Virginia, the parade which began in 1968, has been organized annually by a local Knights of Columbus council and usually includes a large number of Catholic organizations. While no gay group marched, Gov. Terry McAuliffe, a self-proclaimed Catholic, who is an advocate for abortion and homosexual marriage, was invited to serve as grand marshal.

The reaction of Catholic groups dismayed by the developments was consistent. In Boston, the Immaculate Heart of Mary School, which annually sends its classic float of St. Patrick and its 40-member-band, pulled out. The school's principal Brother Thomas Dalton stated, "We don't believe that any Catholic organization should be part of a parade that is promoting a homosexual lifestyle and same-sex marriage." In addition, the Massachusetts State Council of the Knights of Columbus, which had announced its intention to participate, withdrew.

In New York, the decision prompted the Catholic League and at least one Catholic school to decline to march. And in Norfolk, Holy Trinity Parish cut its ties to the organizing council, while the Ancient Order of Hibernians and about six Catholic schools withdrew from the parade. The state's two bishops, Francis DiLorenzo of the Richmond diocese and Paul Loverde of Arlington, condemned the selection of the governor as grand marshal, stating, "It is an erroneous and serious mistake in judgment for any Catholic organization to grant awards, honors and platforms to any public person who clearly acts in defiance to Catholic teaching."

St. Patrick spent his adult life as a missionary in Ireland working to convert the Celtic tribes from their polytheistic beliefs and pagan practices, including sodomy, to Christianity. It is a travesty that parades bearing his name now advertise the gay lifestyle.

In New York, Holy Innocents Church, located just blocks from the parade route, offered an alternative event. It conducted a "St. Patrick's Day Lenten Pilgrimage," which encompassed four Masses, the opportunity for Confession, and a prayer vigil for unborn children. The traditional religious purpose of the parades may have been impeded, but prayer and sacrifice can yet win the day.


