Chaplain Thoughts. . .



“He has been raised from the dead.”

Mary Magdalene was crying as she rushed to the Tomb where they buried Jesus, in the early hours of First Day of the Week. She was shocked and bewildered when she saw that huge stone removed from the tomb. She ran to tell Peter and the other disciple whom Jesus loved (John), what she had found. Peter first, then John, went into the empty tomb, and John saw and believed. John knew that his faith in Jesus was true, that his faith in God’s promise to send Israel a Savior, was justified.

Jesus’ suffering, death and resurrection bought eternal life with God for us. Jesus rescued Mary Magdalene from her troubles and gave her another chance at life as His disciple. Jesus forgave Peter for his denial of Him during His passion and gave Peter another chance as His Apostle and the Rock on whom He would build His Church on earth. Through His obedience to His Father’s will, in His suffering, death and resurrection, Jesus gave all of mankind another chance at life with God, by baptism into His Body. Jesus’ resurrection from the dead has changed everything! It has changed our fundamental relationship with God. A relationship with God that Adam and Eve lost for all of mankind by disobedience.

In his first letter to the Corinthians, St. Paul says that if Christ has not been raised from the dead, our faith is in vain. If Christ has not been raised from the dead, we are still separated from God. If Christ had not risen from the dead, He has no more authority over our lives than any other historical person. But He did rise from the dead!

Now, Easter Sunday has dawned, and with it, the absolute victory of the Resurrection. The tomb is empty. The stone is overturned. The shadow of the cross is replaced by the morning light of a new life in truth. Christ’s apparent failure has risen in victory.

We have another chance at life with God.

SUPREME KNIGHT'S MESSAGE

Carl A. Anderson - Supreme Knight

St. Joseph's Humble, Decisive Witness Speaks Volumes To Our Culture Today



As Catholic fathers, one of our main responsibilities is to pass on the faith to our children. We do this best by living the faith in an engaging way and by attending Mass with our family. But we also need to teach our kids the basics of the faith at a young age and make sure their Catholic knowledge grows as they do.

In teaching about Jesus and Mary, a summary of Gospel stories and a review of the mysteries of the rosary provide an excellent primer. What can we say about St. Joseph, the husband of Mary and adoptive father of Jesus, who has no words recorded in the Bible? In our online age in which every stray thought can be texted or tweeted, we can present Joseph as a model for our times — a man of action who goes against the tides and trends of the world.

As we approach St. Joseph's feast day March 19, consid-

er these five “countercultural” qualities of Joseph that can be instructive to our children, as well as to us.

Attentive. Our kids are bombarded by distracting media, yet they long for peace of heart and mind. As Pope Francis has observed, Joseph was “constantly attentive to God” and responded with courage to heavenly messengers who told him to put aside the opinion of others. St. John Paul II also said that because of his attentiveness, Joseph had the “power of making great decisions.” Our children, too, can do great things with St. Joseph at their side.

Humble. Social media, as forums for idealized personas and perfect images, are not noted for fostering humility. With a little guidance, our children can see through the online posturing and appreciate the value of honesty, the foundation of humility. Setting aside his own plans in order to follow God's will, Joseph “lowers himself and takes this great responsibility upon his shoulders,” explains Pope Francis. St. Joseph teaches us that humility does not mean passivity. Rather, his hidden life was defined by integrity and strength.

Protective. Our kids can feel vulnerable amid what Pope Francis calls a “throwaway culture,” which does not respect the dignity of the human person — especially the unborn, the poor, the elderly, the sick and others on the periphery. In the face of harmful influences such as cyberbullying and online pornography, we should appeal to our children's desire for protection. St. Joseph was the guardian, or *custos*, of Jesus, and he is now the patron of the universal Church. As a father, show your children that you stand strong with Joseph.

Hardworking. Although life today is vastly different than in the time of St. Joseph, the demands of hard work are still essentially the same. “Work was the daily expression of love in the life of the family of Nazareth,” wrote St. John Paul II. While our virtual age seeks pleasure first and is quick to demean or outsource menial labor, Joseph the carpenter rolls up his sleeves and reveals the dignity of human work. He is an example of someone who knows that hard work can be its own reward.

Loving. Our world is filled with distorted images of love that can cause our children great harm and heartache. Joseph is an antidote. Love for him was not red hearts and arrows but self-giving for the good of others. He also expressed a “tenderness,” notes Pope Francis, a “strength of spirit and a capacity for concern, for compassion, for genuine openness to others, for love.” Through St. Joseph, your kids can learn the true nature of love that is rooted in his care for Mary and Jesus.

Presenting St. Joseph with these countercultural virtues, we fathers should seek to imitate him in our own lives. That will be a win for our children, our families and ourselves.

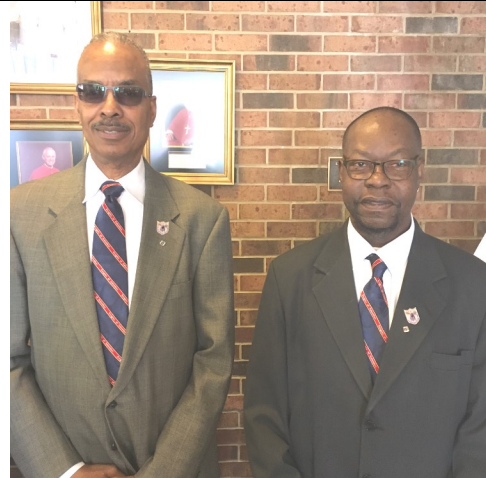

FAMILY FULLY ALIVE



In founding the Knights of Columbus, Father Michael J. McGivney sought to respond to the crisis in family life affecting Catholics in 19th-century America. As a young man he witnessed firsthand the challenges his widowed mother faced with seven children at home. Later, as a priest he confronted on a daily basis the problems affecting the families of his parish community due to poverty, violence, alcoholism, immigration, anti-Catholic prejudice and discrimination.

Father McGivney's vision for family life was not simply that each family might find financial and material aid. He understood that holiness is the calling of all baptized Christians. And, seeing as his two brothers followed him into the priesthood, we can understand how truly important the "sanctuary of the home" was to the McGivney family.

His family was a living example of what the Second Vatican Council later taught — that each man, woman and child is called to holiness through proclaiming the Gospel and communicating the divine gift of love through the activities of their daily lives.

When Christian families respond in this way to the design of the Creator, they become a "domestic Church" that, as Pope Paul VI explained, mirrors "the various aspects of the entire Church."

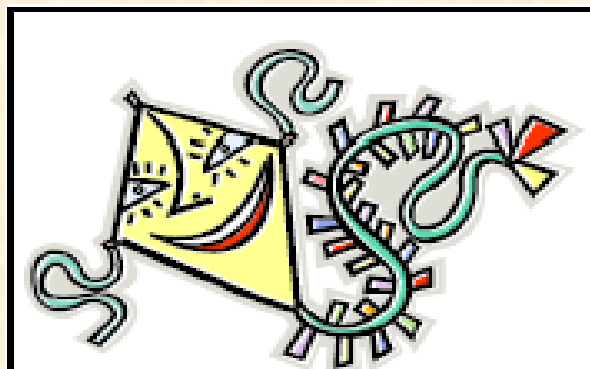
Kites Are Coming

The Battle Over Morally-Offensive, Compelled Speech

On March 20, the U.S. Supreme Court heard oral arguments in the case of *National Institute of Family and Life Advocates (NIFLA) v. Becerra*. The issue to be decided is whether the government can compel a faith-based ministry to proclaim a message that is in opposition to its mission.

Compelled behavior and speech have been tactics used by governments, throughout the ages, in many nations and in many cultures, to stigmatize, penalize and suppress minority religious views. In Elizabethan England, Catholics were fined if they did not attend Sunday services in an Anglican Church. Until the 20th century, Muslim nations imposed a jizya or yearly tax on non-Muslims living in the country. In Nazi-occupied territory during World War II, Jews were required to wear a Star of David on their clothing.

In October 2015, California passed the *Reproductive Freedom, Accountability, Comprehensive Care, and Transparency (FACT) Act*, which requires all pregnancy care facilities to post notification in their waiting areas and in their advertising that the state offers free or low-cost abortions to women who qualify, along with a phone number that provides quick access to abortion clinics. These centers must do so even though they find the government-provided message morally offensive and it directly contradicts the purpose for which the centers exist.

The California law also requires pro-life, non-medical centers to inform clients that they are not licensed medical providers and have *no licensed medical provider who supervises the provision of services* -- effectively requiring them to advertise what they don't do or claim to do.

Under questioning from the Supreme Court justices, the California deputy solicitor general admitted that if a pro-life pregnancy center took out a billboard advertisement with the words "Choose Life," it would have to include in the same size font the 29-word government statement. If the billboard were in Los Angeles, the statement would have to be in 13 languages.

Pro-life pregnancy care centers are virtually the only groups affected by the mandate. Organizations, such as Planned Parenthood, which serve as the abortion providers for California's Medi-Cal and Family PACT (Planning, Access, Care, and Treatment) programs, are exempt from the requirement. The latter are not required to notify clients about the non-abortion services offered by pro-life organizations, such as prenatal care, material support, and adoption services, or to show ultrasounds to their patients. Thus, the mandate is not designed to make known maternity options, but rather to force pro-life centers to convey the government's viewpoint and advertise for abortion providers.

NIFLA, on behalf of the 140 pregnancy resource centers in California that are its members, sought a preliminary injunction to prohibit enforcement of the FACT Act, claiming that the law violated their First Amendment rights to free speech and free exercise of religion. The 9th Circuit Court of Appeals upheld the law, and on November 13, the Supreme Court agreed to review NIFLA's free speech argument.

Laws similar to California's FACT Act have been enacted across the nation. They have been challenged with varying results. In March 2014, Centro Tepeyac, won a suit overturning a Montgomery County, MD, law requiring pro-life pregnancy centers which counsel expectant women to advise clients to speak with licensed medical professionals; the law did not apply to abortion providers, such as Planned Parenthood, even if they offer counseling by non-medical persons.

In June 2014, Austin LifeCare, part of the Care Net network in Texas, won a suit overturning an Austin city law requiring pro-life pregnancy care centers to post signs stating they do not offer abortions or birth control drugs.

New York City passed an ordinance in 2011 requiring pro-life pregnancy centers to provide printed and oral notices that emphasize abortion and encourage women to go elsewhere. After the courts struck down most of the provisions, a settlement was reached in 2016 that frees the centers from posting messages that are contrary to their beliefs.

In July 2017, an Illinois court issued a statewide preliminary injunction against a 2016 statutory change to the state Health Care Right of Conscience Act that would force pro-life medical professionals to refer patients for abortions and to counsel patients on what the legislation calls the "benefits" of abortion.

On January 5, 2018, the Fourth Circuit Court of Appeals ruled in favor of the Greater Baltimore Center for Pregnancy Concerns, a pro-life Catholic charity, which had sued to overturn a Baltimore city ordinance passed in 2009. The ordinance, which pertained only to "limited-service" pro-life pregnancy centers, required them to post a disclaimer in their waiting rooms that they do not provide abortion or birth control services. After seven years of litigation, the appellate court ruled that the ordinance violated the First Amendment's guarantee of freedom of speech because it forced "a politically and religiously motivated group to convey a message fundamentally at odds with its core belief and mission."

But even as laws are being overturned by the courts, others are being enacted. In July 2017, Hawaii passed a pregnancy center signage law similar to the one in California; pro-life groups have said it will be contested in the courts.

The various signage laws are classic examples of content and viewpoint discrimination in compelled speech. The messages to be conveyed are antithetical to the religious and ideological reasons the pro-life centers exist. The laws should only be sustained if the relevant government body can substantiate that it is meeting a compelling government interest that cannot be achieved in a less restrictive way.

That is why *NIFLA v. Becerra* is important. If the Supreme Court rules in favor of California, other abortion-promoting statutes will likely follow. If NIFLA wins, but with a narrow ruling, California will not be able to enforce the law, but there will be little guidance for other pregnancy-related, compelled-speech cases pending in the lower courts. A broad ruling could resolve the question of such laws once and for all.

"Yes, sir."

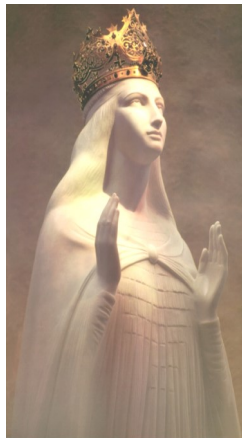
"Well, then, express the will of the people," the president ordered.

Marian Title for April Our Lady of Knock



On the evening of August 21, 1879 Mary McLoughlin, the housekeeper to the parish priest of Knock, County Mayo, Ireland, was astonished to see the outside south wall of the church bathed in a mysterious light; there were three figures standing in front of the wall, which she mistook for replacements of the stone figures destroyed in a storm. She rushed through the rain to her friend Margaret Byrne's house.

After a half hour Mary decided to leave and Margaret's sister Mary agreed to walk home with her. As they passed the church they saw and amazing vision very clearly: Standing out from the gable and to the west of it appeared the Blessed Virgin, St. Joseph and St. John. The figure of the Blessed Virgin was life-size, while the others seemed to be neither as large nor as tall. They stood a little away from the gable wall about two feet from the ground. The Virgin was erect with her eyes toward Heaven, and she was wearing a large white cloak hanging in full folds; on her head was a large crown.

Mary Byrne ran to tell her family while Mary McLoughlin gazed at the apparition. Soon a crowd gathered and all saw the apparition. The parish priest, Archdeacon Cavanaugh, did not come out, however, and his absence was a disappointment to the devout villagers. Among the witness were Patrick Hill and John Curry. As Patrick later described the scene: 'The figures were fully rounded, as if they had a body and life. They did not speak but, as we drew near, they retreated a little towards the wall.' Patrick reported that he got close enough to make out the words in the book held by the figure of St. John.

An old woman named Bridget trench drew closer to embrace the feet of the Virgin, but the figure seemed always beyond reach. Others out in the fields and some distance away saw a strange light around the church. The vision lasted for about three hours and then faded.

The next day a group of villagers went to see the priest, who accepted their report as genuine; he wrote to the diocesan Bishop of Tuam; then the Church set up a commission to interview a number of the people claiming to witness the apparition. The diocesan hierarchy was not convinced, and some members of the commission ridiculed the visionaries, alleging they were victims of a hoax perpetrated by the local Protestant constable! But the ordinary people were not so skeptical, and the first pilgrimages to Knock began in 1880. Two years later Archbishop John Joseph Lynch of Toronto made a visit to the parish and claimed he had been healed by the Virgin of Knock.

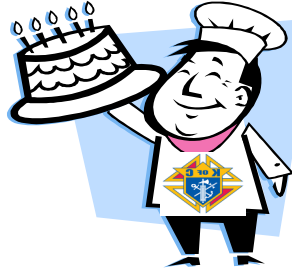
The Church approved the apparition in 1971 as being quite probable, although it has never been formally stated. The Shrine at Knock is opened year round. In 1994 three life-size statues were erected of Our Lady, St. Joseph and St. John.
