Today is the First Sunday of Advent. The word "Advent" means "coming." We light the 1st Advent candle today, preparing for the coming of Christ, the eternal light who will pierce the darkness of the world. Just as a light gets brighter, the closer it comes to us, the Light of the World is symbolically coming closer to us and getting brighter by each additional candle that we light during the four Sundays of Advent.



Jesus' first coming brought us salvation and with salvation, He gives us abundant graces. We must accept His graces to guide us through this life, because the time of His Second Coming will be unexpected; therefore, we must use His graces to always be prepared. Advent then is a time of expectancy along with our waiting in hope. Advent is forward looking. It is different from Lent, which is a time

of reflection and examination.

The Light of the World that we prepare for is the coming of Jesus. Yet, we should also be preparing for Jesus' Second Coming. Then, as we prepare to remember Jesus' First Coming, we will not fear His Second Coming, but will look forward to it.

A MESSAGE FROM THE SUPREME KNIGHT'S The Gospel of Life

This month as we celebrate the event of Christmas, I suggest we also contemplate what we might call the process of Christmas — the series of events that began in March with the angel's Annunciation to Mary and is brought to fulfillment on December 25th with the birth of Jesus.

In his account of the Annunciation, St. Luke writes "Mary set out at that time and went as quickly as she could to a town in the hill country

of Judah" [1:39]. We also know that when Mary greeted Elizabeth "the child leapt in her womb." The prophetic ministry of John the Baptist to proclaim the coming of the Messiah actually began while John was still in Elizabeth's womb – itself an eloquent pro-life testimony.

But St. Luke's account bears even more dramatic witness to the humanity of the unborn child. St Luke is so concerned to make a precise record of both pregnancies at the time of the Visitation that he records the Archangel Gabriel telling Mary that Elizabeth is "in her sixth month." Then St. Luke tells us that Mary's visit to Elizabeth lasted about three months. Elizabeth then gives birth to John the Baptist. In this way we understand that Mary must have left to see Elizabeth almost immediately after the Annunciation – a journey she made "as quickly as she could."

Elizabeth's words to Mary – "Why should I be honored with a visit from the mother of my Lord?" – show us that while Jesus may be only five days old, he is the Lord. The Incarnate One who is present within Mary when she visits Elizabeth is not potentially the Messiah; he is at that very moment the Messiah.

Jesus, when he was first recognized as the Lord by Elizabeth, was at the same point in his biological development as are the thousands of embryos that have been conceive for scientific research. Those embryos that society d by means of in vitro fertilization and later destroyed because they are no longer wanted by their biological parents and as those thousands of embryos whose death is now sought to provide stem cells today willingly destroys are no less fully human than was Jesus on the day of the Visitation.



This Christmas we rejoice in a God who brings to us in Mary's child the Gospel of Life. Our Order has done much during the years to "Keep Christ in Christmas." But, the story of his life before, as well as at his birth, is one our society desperately needs to know now.

During our Christmas celebration let us also take time in our homes and in our councils to join Mary on her pilgrimage to Elizabeth. Let us prepare to observe our 43rd *Annual March for Life* on January 27, 2017. And as we take this historic step to advance firm hope of the one who heard from the lips of an angel that "nothing is impossible to God." the pro-life cause, let us do so with the same

St. Joseph Catholic Church Celebrates Its 95th Anniversary





Reclaiming Christmas

Two thousand years ago, Rome was the center of the civilized world – economically, commercially, socially, militarily. Its material greatness, however, was accompanied by moral depravity. Prostitution, pornography, homosexuality, same-sex unions, suicide, and other lustful perversions were accepted.

Does not the permissiveness of that ancient culture appear familiar? As we in America – and indeed the West -- strive for material greatness, are we not recreating a pagan moral climate?

The Roman world changed, however. On a day now known as Christmas, the "Word was made flesh, and dwelt among us." God came to earth in the person of Jesus Christ. Conceived by the Holy Spirit and born of a virgin, the Second Person of God assumed a fully human nature, with all of the joys and agonies, trials and tribulations, thoughts and emotions, sufferings and death that are innate to man.

Through His teachings and the Church He left behind, a new era began for the human race. His doctrines elevated women to equality with men, asserted the role of charity and social justice, showed the debasement and immorality of slavery, established the sanctity and indissolubility of marriage, and raised the status of the family and children. The recognition of Christ's birth with its profound implications, became a special event for His followers.

Ever since the first settlers landed in America, Christmas has been celebrated in this land. But now, with declining religious beliefs among the populace, for many Christmas has been replaced with a secular, commercial holiday, preceded by a month-long marketing blitz focused on an inordinate amount of buying and gift-giving. Today, this Christian observance is not only being deemphasized, but God Himself is being expunged from public recognition.

Nativity scenes are banned from government property; Christmas programs and traditional carols are forbidden in public schools; the greeting "Merry Christmas" is replaced with "Happy Holidays"; shopping malls are decorated with winter scenes, sleighs, trees, bells, birds, Santa Clauses, and anything other than a reminder of what occurred 2000 years ago; and there are recent efforts to place satanic displays next to crèches. The same Christ Child who could find no place in the public inn in Bethlehem is now being proscribed from receiving public acknowledgement in America.

The silencing of Christmas is more than just being concerned about the sensitivities of non-Christians. It is a step toward suppressing those moral beliefs that are rooted in Christian doctrine: the protection of the unborn, the sanctity of life at all stages, the inviolability of tradition marriage, the ability to live one's religious beliefs in the public square. There can be no further restrictions without a total suppression of Catholic identity, a loss of religious freedom, a denigration of societal mores based on virtue and morality, and a weakened ability to develop the faith among the young.

In spite of the moral darkness of our time, things can change. But it will take a concerted effort by all Christians, Catholics included, to live their faith in public. They must create a counter-cultural movement, and it can start by taking back Christmas and once again publically celebrating the birth of Our Savior. Pope Pius X, at the beginning of the 20th century, said: "The greatest obstacle to the apostolate of the Church is the timidity or rather the cowardice of the faithful." As harsh and as true as that observation has been, Christians today must be forthright in expressing their faith. They no longer can be hesitant to confront the secular forces that are removing God from the culture. They must express their religious beliefs and publically celebrate their traditions.

A new liturgical year begins on December 3, with Advent, the prelude to Christmas. This period of preparation, penitence and expectant waiting for the coming of the Lord, can be a period of moral strengthening. It is an opportunity to reflect on why God chose to become man and its implications for our lives. We are in this temporal life to work out our salvation so that we may merit an eternity in the kingdom of God. Jesus, through His coming taught us the way and gave us the means – grace, the Eucharist, his Church – to attain that salvation.

In the days ahead, as a sign of gratitude and fidelity to our Lord, make a public statement about Christmas. There are innumerable ways to do so, limited only by your imagination. Display a crèche in your yard as well as your home, send religious greeting cards, use stamps displaying the Madonna and Child, promote traditional songs that praise God, join a neighborhood caroling group, set up an Advent wreath, include religiously-themed ornaments on your Christmas tree, visit the Nativity scene in your church, take a card from a church's "giving tree" and return a gift for a needy child, include religiously-themed ornaments on your Christmas tree, and tell your children or grandchildren the story of Christ's birth.

As you prepare for Christmas, do not neglect the most important step -- strengthen yourself spiritually. Say the Rosary, spend time in Eucharistic Adoration, go to Confession, meditate on the liturgical readings, so that when you go to Mass on Christmas Day, you can be truly joyous about the arrival of our Lord.

Do not stop these activities on December 25. Continue them at least until the Epiphany -- Feast of the Three Kings, *Little Christmas* -- which will be celebrated on January 7. Then, throughout the year, pray the Rosary and meditate on its mysteries, which recount the life of Our Lord. Every time we recite the Hail Mary, we say, "Hail, full of grace, the Lord is with thee," the words the Archangel Gabriel used to invite Mary to become the mother of God. Reflect on when these words were first said and of the birth that followed.

If we live everyday as a preparation for Christ's coming, the results will be profound. If we do, the world *will* be a different place.

Marian Title for December Our Lady of Guadalupe



On December 9, 1531 Juan Diego, a simple indigenous peasant, had a vision of a young woman while he was on a hill in the Tepeyac desert, near Mexico City. The lady told him to build a church exactly on the spot where they were standing. He told the local bishop, who asked for some proof. He went back and had the vision again. He told the lady that the bishop wanted proof, and she said "Bring the roses behind you." Turning to look, he found a rose bush growing behind him. He cut the roses, placed them in his poncho and returned to the bishop, saying he had brought proof. When he opened his poncho, instead of roses, there was an image of the young lady in the vision.

Today, the icon is displayed in the nearby Basilica of Guadalupe, now one of the most visited Catholic shrines in the world. The Virgin of Guadalupe is Mexico's most popular religious and cultural image, with the titles "Queen of Mexico, Empress of the Americas, and Patrones of the Americas."
