So far in this short season of Ordinary Time, we have heard of our Lord's call to His Apostles and to us as His people to "Come, follow Me." Now that we have heard Him calling, what must we do? We must listen to Him!

Throughout salvation history since Moses, God has called His people through the message of the prophets He has sent. Now, God completes and fulfills His call,



His message, His message, through His greatest prophet, His Son, Jesus.

The people listened, because Jesus speaks to them as Moses did, with AUTHORITY! However, there is a difference between the authority that Moses spoke with, and the authority that Jesus speaks with. Jesus does not speak and act with the authority given to Him by God, as Moses did. Jesus speaks and acts on His own authority, because He is God. Jesus uses His authority to expel demons from a man whom they possessed and controlled.

# "He taught them as one having authority."

The demons knew who Jesus was and tried to say so. The demons were trying to gain a measure of control over Jesus by saying that they knew who He really was. However, Jesus silenced them, with AUTHORITY! The people were amazed, and left the Synagogue, spreading the news of what they had seen to everyone they met.

In some ways, each one of us can relate to that possessed man's situation. We are not possessed, but we all have sufferings and temptations that seem to have mysterious power over us, just as the devil had power over this man. Jesus came to bring new life and new hope to that man. He comes to bring new life and new hope to every human heart today, and He rejoices whenever we let Him act with authority in our lives, as He did for that possessed man.

#### SUPREME KNIGHT'S MESSAGE

Carl A. Anderson - Supreme Knight

<u>January</u>: On January 25<sup>th</sup>, Knights joined hundreds of thousands of marchers in the defense of the unborn at the annual March for Life in Washington, D.C.

January: Players and coaches from the Denver Broncos joined the Knights of Columbus for a Coats for Kids distribution on January 28<sup>th</sup>. The event was held with the support of the Jack and Linda Del Rio Foundation and Catholic Athletes for Christ

February: The Knights of Columbus set an Insurance record for the 13<sup>th</sup> consecutive year with nearly \$8.2 billion in new life Insurance sold.

**March:** The Knights of Columbus was recognized as a 2014 World's Most Ethical Company by the Ethisphere Institute, an independent center of research promoting best practices in corporate ethics and governance. The Knights was one of only two companies in the life Insurance category honored this year.



March: Founder's Day, March 29<sup>th</sup>, was observed throughout the Order. Supreme officers, members of the clergy and Knights of Columbus staff members offered the prayer for the canonization of Venerable Father Michael McGivney at his sarcophagus in St. Mary's Church in New Haven, Connecticut.

**April:** The shrine established by the Knights of Columbus to preserve the legacy of John Paul II was designated a national shrine on March 19<sup>th</sup> by the U.S. Conference of Catholic Bishops. The shrine's name was officially changed to the St. John Paul II National Shrine on April 27<sup>th</sup>, the date of the pope's canonization.

April: The Knights celebrated the canonization of Pope John Paul II and Pope John XXIII in Rome on April 27<sup>th</sup>. The Order provided financial support for the Vatican Television's broadcast and hosted numerous pilgrims at K of C facilities. Major U.S. celebrations in honor of the canonization were also held in Washington, D.C.; New Haven, Connecticut; and Los Angeles.

**May:** Supreme Knight Carl A. Anderson and his wife, Dorian, joined over 250 delegates, chaplains, wives and guests at the 4<sup>th</sup> Poland State Convention, held May 9-11<sup>th</sup>, at Gnlew Castle in northern Poland.

<u>May</u>: The Order joined the U.S. Military Archdiocese in sponsoring a spiritual journey to the Marian shrine in Lourdes, France, as part of the annual warriors to Lourdes Pilgrimage for Wounded or Disabled Military Personnel. The pilgrimage took place May 13-19<sup>th</sup>.

<u>June</u>: For the 39<sup>th</sup> consecutive year, the Knights of Columbus Insurance program earned the highest financial strength rating of A++ (Superior) in 2014 from A.M. Best rating agency.

June: Supreme Knight Carl Anderson announced that the Knights of Columbus set records for charitable donations and service hours in 2013, contributing more than 170 million and more than 70.5 million hours. The Supreme Knight made his announcement on June 12th at the opening business session of the Organizational Meeting of State Deputies in New Haven, Connecticut.



<u>July</u>: The Knights of Columbus ended the fraternal year with membership in the Fourth Degree reaching 340,960, roughly 18 percent of the Order's overall membership. The Knights also saw an increase of 60 new assemblies, bringing the total to 3,169.

**July:** Supreme Knight Carl Anderson announced July 14<sup>th</sup> that the Knights of Columbus will cover the costs of athletes from the United States and Canada as they participate in the 2015 Special Olympics World Games in Los Angeles.

<u>August</u>: The Knights held its 132<sup>nd</sup> Supreme Convention in Orlando from Aug. 5-7<sup>th</sup>. Cardinals, archbishops, bishops and other members of the clergy joined approximately 2,000 members of the Order and their families at the event.

August: The Knights of Columbus established St. Andrew Kim Taegon Council 16000, the first council in South Korea. Supreme Knight

Carl Anderson made the announcement on Aug. 5th, noting "There are nearly 5.5 million Catholics in South Korea today. It is among the fastest-growing Catholic communities in the world. I am sure that South Korea, like the Philippines will play a significant role in the future of the Knights of Columbus."



September: The Knights of

Columbus Christian Refugee Relief Initiative raised more than \$1 million in public donations for those suffering persecution in Iraq and the surrounding region. Combined with the \$1 million raised by the Order, the total stood at more than \$2 million in mid-September, after only three weeks of the Order's establishment of the fund to support humanitarian assistance to refugees fleeing persecution in Iraq and the nearby areas.

**October:** The Knights launched the "Building the Domestic Church: The Family Fully Alive" initiative which is designed to help members and their families develop their spiritual lives through prayer, parish activities and charitable efforts.

October: Hundreds of guests visited the St. John Paul II National Shrine in Washington, D.C., on Oct 22<sup>nd</sup>, the first feast day of St. John Paul II. The Shrine unveiled its new world-class exhibit: "A Gift of Love: The Life of St. John Paul II."

**November:** The Knights of Columbus donated an ultrasound machine to a Baltimore pregnancy center, making it the 500<sup>th</sup> such gift through the Order's Ultrasound Initiative.

<u>December</u>: On Dec. 12<sup>th</sup>, the Feast of Our Lady of Guadalupe, His Holiness Pope Francis received Supreme Knight Carl Anderson in a private audience at the Vatican. On behalf of the Order, the Supreme Knight presented the Pope with the annual proceeds from the Vicarius Christi Fund and an additional \$400.000 for the Vatican's Christian relief fund.



Supreme uses an algorithm to determines who get the \$ and how much based on the in formation they receive from the forms. For every council that does not submit a form, that participated in a SO event in 2014, we are losing money for SO. In 2014 few forms were submitted and SO only received \$1,250. However in 2013 we did much better and \$4,000+ went to SO.
- 7. Survey of Fraternal Activity #1728, due January 31, 2015. The Order needs to demonstrate to the governments of the countries it is present in the incredibly high return on investment they get by granting the Knights of Columbus' tax exempt status. This survey is one of the chief vehicles for explaining that fact. Please submit your survey today.

Love is the word most of us associate with the month of February, as Valentine's Day is celebrated during this month. Feelings of hope, expectations of happiness and joy are expressed by people young and old. Let us remember that love in all its splendor is from God. God is love and His love gives us life. Life in his spirit, life in union with His Son and eternal life as children of God.

Throughout this month, let us show our love for God by preparing ourselves for the season of Lent which begins on Ash Wednesday, February 18<sup>th</sup>. The Catholic church offers us many opportunities this month to participate in Lenten Services. Stations of the Cross devotions, Adoration, Benediction, Reconciliation Services and Masses are available this month and throughout the Lenten Season. Schedules and times are listed in the bulletin and on the St. Joseph website.

On Wednesday, February 18, 2015, we will enter one of the most important seasons of the church year: the 40 days" of Lent. The word "Lent" comes from the Anglo-Saxon word lencten, or spring, the time of year when the days begin to lengthen. Lent itself is always the same period of time, but its starting date is tied to the movable feast of Easter and can be as early as February 4th or as late as March 10.

Lent is one of the most important seasons of the church year because it is a time of penitence, an introspective period during which we take stock of our lives and our relationships to discover and change what we must to prepare for Easter and experience the spiritual renewal that comes when we engage in this type of "making right" activity. So, during Lent we each follow the example of Jesus by sacrificing our own will to the purpose of God.



# Marian Title for February Our Lady of Beauraing



The Blessed Virgin showed herself 35 times. These Apparitions of Our Blessed Lady occurred in Namur, Belgium in 1932 and 1933. In that period of time, the small town boasted about 2,400 people. It was at the convent of the sisters of Christian Doctrine of Nancy in a small replica of a Lourdes Grotto that these apparitions occurred.

The Blessed Virgin Mary told the children to "Always be good." And it was especially important to

her that they attend the Mass of the Immaculate Conception for which 15,000 people came. She told them to "Pray, pray very much."

She asked several things of the children including that a chapel be built, she wished for people to come on pilgrimage, she stated "I am the Immaculate Virgin," and she showed them her golden and Immaculate Heart.

During the final days of the apparitions, each child received a secret, none of which have been revealed. But to Fernance Voisin, a fifteen year old visionary, she asked, "Do you love My Son?" To which Fernande replied "Yes." Spectators reported hearing a loud thunderous sound and seeing a ball of fire coming from the sky as this was happening. "Do you love me?" She asked. "Yes," Fernanda replied. "Then sacrifice yourself for me."

Everybody hears Her say: "Adieu!" In the apparitions which occurred after the 29<sup>th</sup> of December the children continually see 'A heart surrounded by rays of light'. This is why people here call Mary: "Mother with the Golden heart".

The feast day of Our Blessed Lady of Beauraing is celebrated on August  $22^{nd}$ .

# REFLECTIONS Lawrence P. Grayson

#### Needed: Moral Boldness, Not Tepidity

The recent atrocities against the staff of *Charlie Hebdo* created a worldwide outpouring of support for freedom of expression. Some one million people, including over 40 heads of state, marched in Paris to exhibit a commitment to a liberal, tolerant social order and against terrorist extremism attempting to impose censorship through fear.

The satire used in *Charlie Hebdo* is extreme and often obscene, with blasphemous depictions of Christianity, Judaism, and to a lesser extent Islam. The reaction of the Islamic jihadists has been violent, destructive and murderous. As with many issues that evoke strong emotions, two opposing positions toward freedom of expression have crystalized. One holds sacred an unrestrained, libertine view of self-expression, even if it is rude, derogatory, insulting, hateful, sacrilegious or provocative. The second is the notion that statements, whether in speech, writing, drawing or other means of presentation, that mock one's religion or demean another's core beliefs must be censored through brutality or even death.

Neither extreme is healthy for society. The tyranny of coercive violence can never be condoned. Similarly, offensive, vile expressiveness which continually tests the limits of civil discourse strains the mores that bind a society. The alternative to these extremes is a civil milieu in which everyone is free to express their views, even if tasteless and disagreeable to the majority, but without purposely demeaning or overtly attacking the beliefs and values of others.

There is a place for criticism and satire in a well-ordered society, to point out the absurdities, failings and erroneous reasoning of people and institutions as a way to encourage thoughtful reflection. True freedom of expression is not unrestricted license to say or do as one pleases, but the right to act as one ought. As Pope Francis recently said, there must be limits on freedom of expression, especially when it insults or ridicules a person's faith. Although freedom of speech is a fundamental human right, it cannot be used to violently disrupt the social order -- cause panic, incite riots, promote anarchy, or overthrow a just government. When free rein is given to one's desires and passions, disharmony, disorder and injustice result. Freedom must be ordered and limited by social standards, governmental law, and moral imperatives.

Freedom of expression is also threatened by nonviolent repressive actions. In America today, there is a soft tyranny in the form of political correctness. Colleges and universities, where inquiry, debate and the pursuit of truth should be prized, are increasingly sanctioning speech. The Foundation for Individual Rights in Education released a report in December stating that 55 percent of the 437 universities studied have substantial limits on what can be said or presented. On too many campuses, anyone questioning feminist, homosexual, environmentalist, Islamist, or socialistic orthodoxy faces harassment and unequivocal silencing.

Institutions of higher education are not the only targets of coercion. Legatus, an organization of Catholic business leaders, was recently targeted by lesbian, gay, bisexual, and transgender advocates. A speaker at its January 2015 summit

meeting was Paul Darrow, a former international supermodel who left the gay life, converted to Catholicism, and now represents Courage, a Catholic support association for people with same-sex attraction who seek to live a chase life.

A group of LGBT activists, outraged at this challenge to their lifestyle, demanded that several prominent Catholic speakers withdraw from the conference – and three did. Actor Gary Sinise, acclaimed for his work with veterans, withdrew stating he did not want his mission of serving the troops to be disrupted by any controversy. Bret Baier, Fox News Channel's chief political correspondent, who was to speak about his faith and his son's congenital heart disease, and Pete Coors, chairman of Molson-Coors Brewing Company, also retreated after the LGBT-promoting Human Rights Campaign urged them to back out.

Brendan Eich, co-founder of Mozilla Corporation, faced similar retribution from the homosexual community. He was forced to resign as the company's CEO in April 2014, only ten days after being promoted to the position. His sin was supporting California's Proposition 8, which recognized marriage as only between one man and one woman.

Atlanta Fire Chief Kelvin Cochran, who also is an African-American Baptist church deacon, was recently fired after he wrote a Bible study for men that briefly discussed the Christian definition of sexual purity. The *New York Times*, while noting that there is no evidence that Cochran discriminated against gays or lesbians, held that he should be fired because he had the temerity to publicly acknowledge his beliefs. Rev. Franklin Graham, son of Evangelist Billy Graham, commented: "The LGBT community wants us to be afraid of expressing our Christian beliefs. They want us to cower in the face of their threats to the livelihoods of believers. But we shouldn't back down!"

When challenged by proponents of political correctness, too many people and organizations have been paralyzed by fear. The threat of violence is not required to have them exercise self-censorship. The soft tyranny of public denunciation, bad publicity, reduced profits, lost jobs, bad grades, and other sanctions for expressing moral beliefs is enough to keep most people and organizations in line.

None of us wants to confront the purveyors of libertine views or endure the resulting slurs that will be hurled at us. But when we are called to defend our faith, our core beliefs or speak the truth, we must boldly do so. We may be reviled and face the wrath of those who are obsessed with race, class, gender, sexuality, identity, and multiculturalism, but by remaining silent the freedoms which we prize are being eroded.

Hopefully, we will never have to face the hard tyranny of persecution and violence. But we can learn from the Mexican martyrs of the 1920s and 1930s who, while facing firing squads for defending the faith, shouted: *Viva Cristo Rey!* In the soft tyranny we do encounter, take heart from the motto of our State Deputy, *Be Not Afraid, Our Faith is Our Courage*.
