## Chaplain Thoughts...

#### "Blessed are the poor in spirit"

In today's Gospel [M5 5.1:12a], when Jesus "saw the crowds, he went up the mountain, and after he had sat down, his disciples came to him. He began to teach them..." It is not by chance that Jesus went up the mountain to teach His disciples and the crowds. Moses went up the mountain of Sinai to receive the "Ten Commandments" from God. The "Ten Commandments," given to the Israelites, contained God's Covenant with His chosen people, a Covenant of freedom from slavery and death in Egypt.

We probably picture Moses coming down Mount Sinai holding two tablets, each with "Five" of the Commandments. Those tablets represented God's Covenant with His people, so each tablet contained the complete "Ten Commandments." One tablet was God's part of the Covenant and the other tablet was the Israelites' part of the Covenant. Guess which side broke their part of the Covenant?

Jesus, on this mountainside, tells His chosen people, in fact, all people, including you and me, how to live in His New Covenant, a Covenant of freedom from slavery to sin and eternal death, a Covenant of love and life. This time the



Covenant between God and man will not be broken, because it is between Jesus and His Church, sealed with His own blood, shed on the Cross.

The Beatitudes that Jesus gives us turns this world's standards upside down. Jesus tells us that God gives us happiness; we cannot win it, achieve it, merit it, or buy it. Jesus teaches the crowds, and us, that happiness will come to people with open hands, humble hearts and receptive spirits.

Jesus not only tells us in the Beatitudes how we are to live our lives, but what blessings and hope this living brings us. To live humbly in righteousness, is the hope that we should have, that when our earthly journey is complete, we will be truly blessed to hear the words of our Lord, "Come, you who are blessed by my Father. Inherit the kingdom prepared for you from the foundation of the world."

A little humility goes a long way, because it gives us eternal hope. "Blessed are the poor in spirit – theirs is the kingdom of heaven."

Also, Plenary Indulgences can be earned by attending this Pilgrimage. This information is also on the Maryland state Council Website.

#### Supreme Knight's Message

# Growth is Our Primary Responsibility by Supreme Knight Carl A. Anderson

"Our responsibility as the leaders of the Knights of Columbus is to assure the continued growth and sustainability of our Order. This is our first and primary responsibility," Supreme Knight Carl Anderson told the gathered state deputies at the Mid-Year Meeting held in Orlando. The focus of this meeting was membership recruitment and retention.

"While we have other goals and activities that are necessary, no other task is sufficient to advance the

Good of the Order if we do not advance membership growth. Everything we do depends upon membership," he added.

Today there is a challenge that has to be met, he continued. Supreme Knight Anderson pointed out that the Knights of Columbus must recruit younger men and fathers of young families. Our councils need to emphasize programs more relevant to families with young children and we need to use recruitment tools that rely upon enhanced Internet and web-based connectivity.

It is necessary, he said, to recruit younger members in ways that respect the more limited time they have to dedicate to volunteer activities and to schedule council activities in ways that respond to the more limited time young fathers have to participate in activities outside the home.

"Let's remember this: Father McGivney was not yet 30 when he founded the Knights of Columbus with what was described at the time as the 'young go-ahead men' of New Haven," the supreme knight continued. "And I am totally confident that had there been a World Youth Day in 1882, Father McGivney would have been there with his brother Knights. Father McGivney founded the Knights of Columbus for the young working men of his day, to protect their families."

The Supreme Knight also encouraged councils to provide the First Degree in the new DVD format to assure that candidates may join without having to wait for long periods before taking the admission degree.

To help train our council's officers and make volunteer efforts more efficient, the Knights of Columbus has developed the Fraternal Training Portal, the Supreme Knight said. These training program include information on promoting fraternal leadership skills, and instill organizational awareness of the vision of our founder and the legacy mission. Training will be available for current officers with access to Officers Online and roll out to all council officers over the coming months. Shortly thereafter the Fraternal Training Portal will open to Deputy Grand Knights, Chancellors, Membership and Program Directors, followed by all officers.



"Our Building the Domestic Church While Strengthening Our Parish initiative combines two great traditions of the Knights of Columbus: building up Catholic family life and strengthening parish life," Supreme Knight Anderson said. Parishes are the natural home of Knights of Columbus councils and where they thrive best while strengthening the parish community as a whole, he added. These parish-based councils can be the drivers within the parish that promotes Catholic family life

and new charitable initiatives, and that calls Catholic men to greater spiritual formation and evangelical action.

"And these programs will do one more thing: They will help make our parishes more family friendly, especially for young families," the Supreme Knight said. Along with this, he continued, the Building the Domestic Church: The Family Fully Alive program includes monthly themes, meditations, Scripture readings and activities for the whole family. It is a program for all families, but it is designed especially for young families. It can help families that need new ways to bring the light of the Gospel into their homes.

Additionally, the Knights of Columbus is continuing to partner with Praesidum Inc. to provide the most up-to-date resources available to ensure safe environments for children. Through this partnership, Knights involved in youth programs have access to online training, background screening and reporting services. To further enhance this initiative, the Supreme Knight said that an Office of Youth Protection department has been developed at the Supreme Council office to monitor these efforts.

"Young people, especially College Knights, play a large role in the annual March for Life in Washington, D.C. each year," Supreme Knight Anderson said. "This coming year, I ask every Knight that can make it to Washington, D.C. for this event, which is a true witness to the devotion we and so many others hold to support a culture of life, to please do so."

During the meeting the Knights of Columbus leaders also had the opportunity to watch the recap video of the 2017 Supreme Convention in Toronto. "This video is an excellent overview of all we do as Knights of Columbus and all that our organization stands for," Supreme Knight Anderson said. "I strongly urge all councils to show this video, which is accessible on kofc.org, to their membership and to link to it on their websites."




#### Mardi Gras Time At St. Joseph

#### A Window to Advance the Culture of Life

The unpredicted results of the 2016 election have created the most significant opportunity for restoring the protection of life at all stages, since abortion was legalized in 1973. The Vice President and newly-nominated Cabinet members heading key departments are steadfastly pro-life, and both Houses of Congress have pro-life voting records. Most encouraging, less than 72 hour after he was inaugurated, President Trump issued an Executive Order to reinstate the Mexico City Policy which bans the use of federal funds from promoting or performing abortions in other countries. The President also has stated he will sign the Pain-Capable Unborn Child Protection Act, which prohibits abortion after 20 weeks of gestation, make the Hyde Amendment, which prevents taxpayer-Medicaid dollars from funding abortions but requires annual approval, permanent law, defund Planned Parenthood, and appoint constitutional-originalists who believe in pro-life to the Supreme Court.

This political alignment is unlikely to occur again in our lifetimes. If significant changes are not made – and done quickly – to eliminate oppressive executive orders and regulations and enshrine in law the protection human life from conception until natural death, the pro-life movement will have no one to blame but itself.

The predominance of religious believers in the present Congress will be hard to retain. Currently, 91 percent of the members identify themselves as Christian, compared to 71 percent of the general population. The overrepresentation is even greater among Catholics – 31.4 percent of the members claim that faith, while 21 percent of the adults in the country do

Conversely, 23 percent of U.S. adults are "nones" – that is, they consider themselves to be atheists, agnostics or have no religious persuasion – while only 0.2 percent of the members of Congress have no denominational affiliation. It is too early to tell when and how the increasing number of religiously-unaffiliated voters will express their political influence, but any group that represents nearly one-quarter of the electorate cannot be ignored. If the unaffiliated become a significant political bloc, they most likely will oppose Catholic teaching on marriage, abortion, religious freedom, assisted suicide, and transgender prerogatives.

It is time for bold action. Political and social change requires strong leadership, a committed constituency and principled courage. This is certainly true in dealing with moral issues, such as abortion. The political leadership is in place. An unanswered question, however, is: Will Christian religious leaders, including the Catholic hierarchy, support them?

In the short term, when political gains can be made, a lot will depend on how Christian politicians vote. Will they adhere to the teachings of their claimed faiths or follow opposing desires of vocal and often minority segments of the people they represent? Will many Catholic politicians continue to claim they are personally opposed to abortion or same-sex marriage or other violations of Church teachings, but will not deny others from having those options? If they do, will they receive censure from the bishops?

There also is a constituency, as a majority of Americans identify as pro-life and favor restrictions on abortions. A Knights of Columbus/Marist poll released on January 23 found that 74 percent of the U.S. population, including 55 percent of those who supported Hillary Clinton for president, would restrict abortion to at most the first three months of pregnancy. A similar poll in January 2016 found that 61 percent of Americans, including 6 in 10 pro-choice supporters, favor laws that would ban abortion after 20 weeks of pregnancy, except to save the life of the mother.

Further, in contrast to the segment of the population advocating abortion, the pro-life movement has a large and growing component of passionate young people. This bodes well for the future. *Students for Life*, for instance, which hired its first staff member in 2006, now has pro-life groups on 1,031 campuses in all 50 states. At the March for Life in recent years, the Verizon Center and Armory in Washington, DC, which combined have seating for over 30,000 people, have been filled to capacity for the Youth Rally and Mass for Life. The number of teenagers and young adults who participate in the March so awed then-NARAL President Nancy Keenan that in 2012 she bemoaned, "There are so many of them, and they are so young."


With regard to moral courage, it certainly is not lacking among the youth. Lila Rose was 15 when she started Live Action, and did her first undercover investigation of abortion providers three years later. David Daleiden was in his early 20s when he founded the Center for Medical Progress to engage in citizen journalism. Shortly thereafter, he exposed Planned Parenthood's illegal selling of parts of aborted children. In spite of strong social, political and legal opposition, Rose and Daleiden have persisted in their efforts to demonstrate that abortion is not a compassionate response to women's health, but a sordid and callous business. In less dramatic ways, but also requiring moral firmness, many young people have started pro-life groups on college campuses in spite of hostility from pro-choice students and resistance from faculty members and administrators. Many of them are unrelenting in their desire to support life.

Enacting laws to restrict abortion, as important as this is, is only a partial solution. Laws can be rescinded or amended. What is needed is a conversion of the hearts and minds of the American people, a spiritual renewal, the development of a public morality. When a majority of the American people truly believes in God, recognizes that He created men and women in His image and likeness, and acknowledges the innate dignity of every person, laws will be less necessary and it will be possible to create a societal culture of life that will prevail for generations to come.

This will not be easy or quick, but it is not unattainable. It can be won with God's help enlisted through prayer, penance, and the Sacraments. Let us support the pro-life efforts of the nation's new political leadership, and pray for their success.







# Our Lady of Bearing



The Blessed Virgin showed herself 35 times. These Apparitions of Our Blessed Lady occurred in Namur, Belgium in 1932 and 1933. In that period of time, the small town boasted about 2,400 people. It was at the convent of the sisters of Christian Doctrine of Nancy in a small replica of a Lourdes Grotto that these apparitions occurred.

The Blessed Virgin Mary told the children to "Always be good." And it was especially important to her that they attend the Mass of the

Immaculate Conception for which 15,000 people came. She told them to "Pray, pray very much."

She asked several things of the children including that a chapel be built, she wished for people to come on pilgrimage, she stated "I am the Immaculate Virgin," and she showed them her golden and Immaculate Heart.

During the final days of the apparitions, each child received a secret, none of which have been revealed. But to Finance Violin, a fifteen year old visionary, she asked, "Do you love My Son?" To which Fernanda replied "Yes." Spectators reported hearing a loud thunderous sound and seeing a ball of fire coming from the sky as this was happening. "Do you love me?" She asked. "Yes," Fernanda replied. "Then sacrifice yourself for me."

Everybody hears Her say: "Adieu!" In the apparitions which occurred after the 29<sup>th</sup> of December the children continually see 'A heart surrounded by rays of light'. This is why people here call Mary: "Mother with the Golden heart".

The feast day of Our Blessed Lady of Bearing is celebrated on August 22<sup>nd</sup>.
