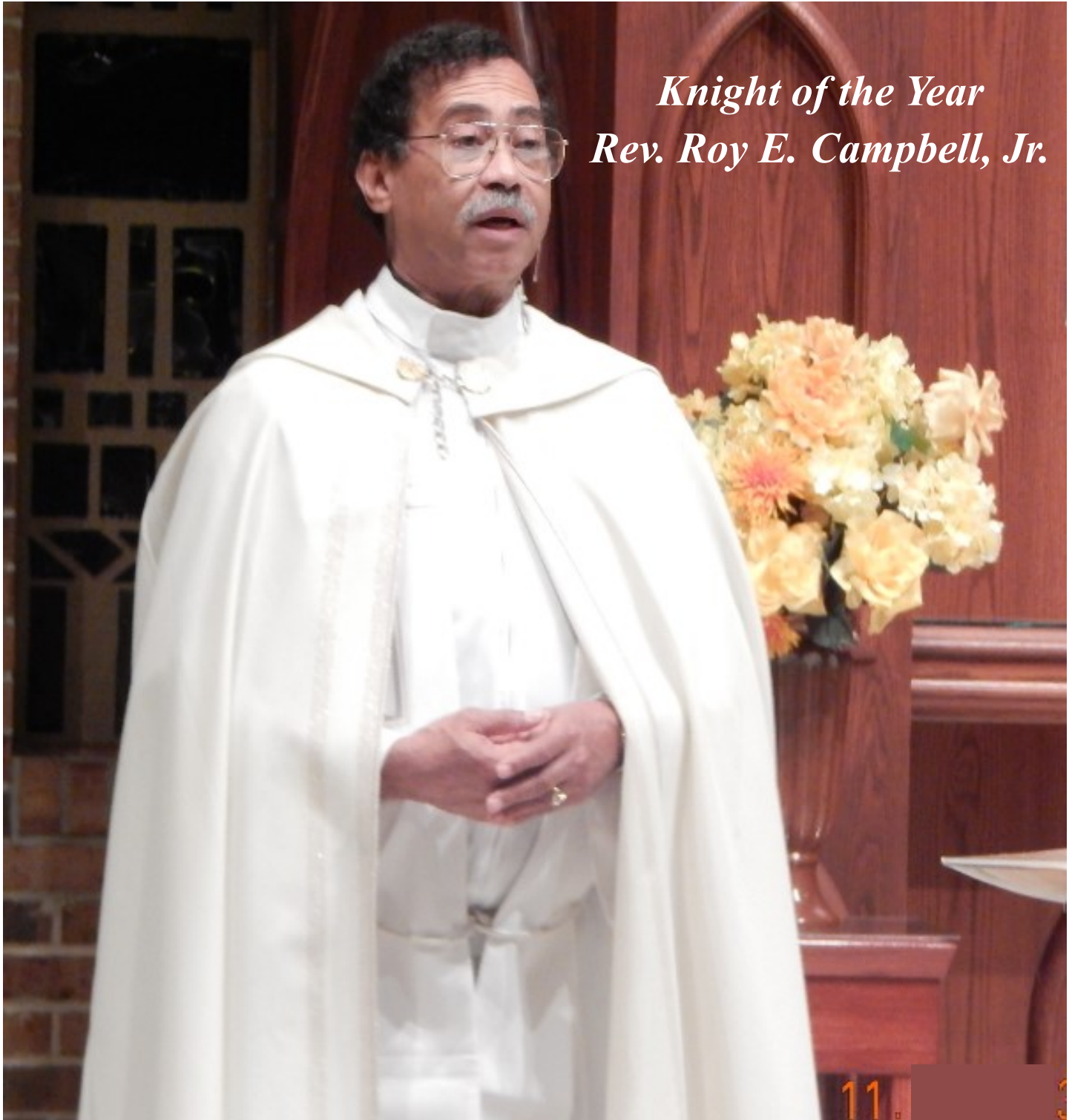

Mary and Joseph obeyed the law of Caesar by going to Bethlehem to register for the Roman census. Now, they were obeying the law of God by dedicating their Baby to Him, by circumcision, eight days after His birth and naming Him Jesus. Mary was only doing what her Jewish religion required, so why do we honor Mary on the Octave Day of Christmas in this Solemnity, as the Mother of God?

Mary’s role is integral to our salvation. By Mary saying “yes” to the Angel Gabriel, Jesus, the Son of God, became the Incarnate Word of God, as a man. When we honor Mary, we give glory to her Son, Jesus. He honored His mother at the end of her earthly life, by assuming her body and soul into heaven and crowning her Queen of heaven and earth. This Solemnity of Mary honors her, because of what she became when she said “yes” to the Angel Gabriel. She not only became the mother of Jesus, the Son of God, in His humanity, Mary also became the Mother of God!

Supreme Knight's Message

New Deputy Supreme Knight Appointed by Supreme Knight Carl A. Anderson

Patrick E. Kelly, a Past State Deputy of the District of Columbia, was appointed Deputy Supreme Knight by the Knights of Columbus Board of Directors on December 13. A Knight for 33 years, Kelly became the Order's Vice President for Public Policy in 2006 and since 2011 has also served as Executive Director of the Saint John Paul II National Shrine in Washington, D.C. He was elected to the Order's Board of Directors in 2013. Earlier this year, he retired with the rank of Captain from the U.S. Navy Judge Advocate General's (JAG) Corps Reserve, where he specialized in international and operational law and served as the Commanding Officer of the international law unit at the United States Naval War College. Previously, Kelly had a long career of public service that included advisory roles to Congress and the Department of Justice. Kelly also served as Senior Advisor to the Ambassador-at-Large for International Religious Freedom at the State Department. His responsibilities included serving as the Department's principal interlocutor with the Holy See and other nations on religious freedom issues.



wig served previously for two years as Supreme Treasurer and has been a member of the Board of Directors since 2007.

Kelly has served as the first Executive Director of the Saint John Paul II National Shrine, which is adjacent to The Catholic University of America. He has overseen the renewal of that facility, previously known as the Pope John Paul II Cultural Center, which was purchased by the Supreme Council in 2011. During his tenure, the Shrine has developed a world-class permanent exhibit, called "A Gift of Love: The Life of Saint John Paul II," and created two new worship spaces that feature the mosaic artwork of Jesuit Father Marko Rupnik — the Redemptor Hominis Church and the Luminous Mysteries Chapel, which enshrines a first-class blood relic of St. John Paul II. As Deputy Supreme Knight, Kelly will continue to oversee the Shrine's operations.

He holds a law degree from Marquette University Law School and a master's in theology from the Pontifical John Paul II Institute for Studies on Marriage and Family at The Catholic University of America. He and his wife, Vanessa, have three young daughters.

He succeeds Logan T. Ludwig, who is retiring at age 70 after serving as Deputy Supreme Knight since 2013. Lud-

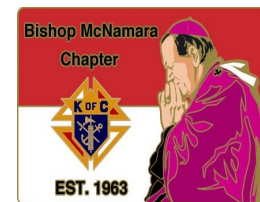
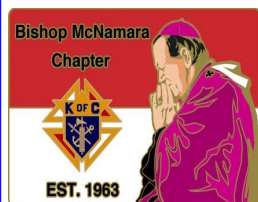

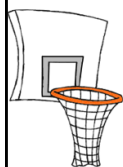

Winning is Not the Same as Victory

On September 18, 1862, after the previous day's fierce fighting, Gen. Robert E. Lee withdrew his battered army from Antietam and retreated to Virginia. The superior Union forces under the command of Gen. George B. McClellan had an opportunity to re-engage and destroy the Confederate army and possibly end the war. McClellan, however, did not pursue and Lee was able to reconstitute his forces and fight for another two and a half years.

On November 8, 2016, pro-life voters helped defeat an anti-life, anti-religious freedom candidate for president. The triumphant President-elect has named a Cabinet that may be the most favorable toward life, traditional marriage and religious liberty in the history of this nation, and has promised to nominate Supreme Court justices who are pro-life and believe in constitutional originalism rather than judicial activism. The designated-nominee for: Secretary for Health and Human Services has a one-hundred percent congressional voting record on pro-life issues; Secretary of Education has received strong endorsements from national pro-life groups; Attorney General is a protector of religious liberty; and Secretary of Defense is a champion of the persecuted Christians in the Middle East.

But leaders need supporters, just as generals need troops and politicians need constituents. If a culture of life is to once again guide the policies of this nation, continued pro-life action is needed. Passivity, timidity and false compromise after this electoral success will assure that much of the current policy remains unchanged.

President Barack Obama has pursued a strong irreligious agenda from virtually the first to the last day of his eight-year administration. Three days after his inauguration in January 2009, he rescinded the Mexico City Policy, originally enacted in 1984. The regulation prohibited private organizations that received U.S. foreign aid from performing or promoting abortions abroad.

His secularist policies continued unabated – increasing federal funding for abortion; imposing mandates that force religious organizations and family-owned businesses to pay for abortion-inducing drugs, contraception, and sterilization in their healthcare plans; promoting LGBT privileges; creating gender self-identity rights; declaring that Catholic colleges, hospitals and social service agencies that hire and serve non-Catholics do not qualify for a religious exemption from certain government regulations; cancelling grants to Catholic programs that provide relief to the victims of human trafficking because the Church opposes abortion; and not defending against legal challenges to the Defense of Marriage Act which defined marriage as the union of one man and one woman.

This godless pursuit continued through December 15, 2016, when the Department of Health and Human Services adopted a rule to prevent states from prohibiting federal funds appropriated for family planning under Title X of the Public Health Service Act from going to Planned Parenthood and other abortion providers. The rule takes effect January 18, two days before President Obama's term ends.

Planned Parenthood, which performed 30.6 percent of all abortions in the United States in 2015, has enjoyed a favored relationship with this Administration. In the past eight years, its federal funding increased from \$363 million in 2008 to \$554

million in 2015.

President-elect Trump and the Republican Congressional leadership have stated that a bill to defund Planned Parenthood and dismantle Obamacare will be one of the first items on the agenda after the inauguration. The funds currently going to less than 665 Planned Parenthood facilities will be awarded to some 13,540 Federally Qualified Health Centers, which do not provide abortions, and thus will increase public access to health care services such as pap smears and breast exams.

The effort to defund Planned Parenthood is not only a financial imperative, but a moral one as well. In December 2016, the U.S. Senate Judiciary Committee referred several Planned Parenthood affiliates to the FBI and the U.S. Department of Justice for possible prosecution for illegally selling body parts from aborted infants.

With the change in the presidency, a radical opposition will employ every political maneuver and public relations ploy to preserve -- and even expand -- the anti-Christian, anti-life, anti-family executive orders, laws, regulations, and policies of the outgoing Administration.

LGBT activists are working to legally protect "sexual orientation and gender identity." These measures, referred to as SOGI, would empower the government to use the force of law to punish individuals and organizations that act on their religious convictions. Under these decrees, persons could incur fines, jail time and personal ruin, and organizations be threatened with the loss of grants, contracts, licensing and tax-exemption. Already, the Education Department has interpreted Title IX to require schools and colleges under non-discrimination statutes to allow students access to bathrooms and locker rooms based on their claimed gender rather than their birth sex.

The first 100 days of a new presidency are most important for getting things done. Executive branch actions are not laws and thus a new president can abolish previous ones by a stroke of a pen. It is expected that after he is inaugurated, President Trump and his HHS Secretary Tom Price, working in collaboration with majorities in both Houses of Congress, will not only repeal the Obama actions but enact new legal protections for the most vulnerable members of society.

In addition, the new President, his Cabinet, and Congress should act quickly to:

Eliminate regulations in the military and federal agencies that criminalize Christian beliefs on sexuality, marriage and religious expression

Overturn the Obamacare mandate that requires faith-based organizations to provide employee healthcare insurance that supports sterilization, contraception and abortifacients

Repeal regulations that force schools and businesses dealing with the public from allowing people to use bathrooms and changing rooms based on one's preferred gender

Nominate and confirm a pro-life justice to the Supreme Court

Electing a pro-life president was a success. But it is a dangerous assumption to consider this as the desired victory. We who are pro-life, pro-family and desire religious freedom must continue to pray and must support our political representatives in upholding their campaign promises. We must turn the success of the recent hard-fought election campaign into a complete victory and re-establish a culture of life in this nation.

Marian Title for January
**Our Lady of
 Hope of Pontmain**



Our Lady’s visit occurred at the height of the Franco-Prussian War. Pontmain lay between the oncoming Prussian invaders and the city of Laval. With the sound of gunfire in the distance, two young brothers, Eugene and Joseph Barbadette, were pounding animal feed with their father when they saw a beautiful woman above the village church. Years later, an adult Joseph (who became a priest) recounted:

She was young and tall of stature, clad in a garment of deep blue, like balls of indigo such as laundresses use for rinsing linen. Her dress was covered with brilliant gold stars. The sleeves were ample and long. She wore slippers

of the same blue as the dress, ornamented with gold bows. On the head was a black veil half covering the forehead, concealing the hair and ears, and falling over the shoulders. Above this was a crown resembling a diadem, higher in front than elsewhere, and widening out at the sides. A red line encircled the crown at the middle. Her hands were small and extended toward us as in the ‘miraculous medal.’ Her face had the most exquisite delicacy and a smile of ineffable sweetness. The eyes, of unutterable tenderness, were fixed on us. Like a true mother, she seemed happier in looking at us than we in contemplating her.

A crowd gathered to pray as word quickly spread among the anxious villagers. Children saw the beautiful Lady, and gleefully pointed up to her. Adults, however, only saw 3 stars forming a triangle! As they prayed the Rosary, the children saw the garment’s stars multiply until it was almost entirely gold. Next, the children saw a banner unfurl beneath the Lady. Slowly, a message appeared: “But pray, my children. God will hear you in time. My Son allows Himself to be touched.” Upon hearing the message read aloud, the crowd spontaneously began the hymn “Mother of Hope.” As they sang, Our Lady laughed and joined in the singing.

The children squealed with delight as her hands kept time with the music, conducting their song. When the crowd began “My Sweet Jesus,” her expression changed to profound sadness and a red crucifix appeared in her hands, with the words “Jesus Christ” above it. Her eyes mournfully contemplated the cross during the hymn. As the people sang the “Ave Maris Stella,” the cross vanished, and her smile returned, though with a touch of melancholy. Two small white crosses then appeared on her shoulders before Our Lady disappeared behind a cloud.

The apparition lasted for 3-hours. In that time, the people of Pontmain heard a lessening in the distant sounds of war. During the evening, the Prussians ceased their advance and, 12-days later, the war ended. Just as Our Lady promised, God heard their prayers for peace. Devotion rapidly spread under the title Our Lady of Hope of Pontmain and, in 1900 the Bishop consecrated a magnificent Cathedral commemorating the apparition. The tiny chapel over which she appeared remains nearby in its original state.
