By tradition, the Catholic Church dedicates each month of the year to a certain devotion. In May, it is the Blessed Virgin Mary. This devotion arose among Jesuits in Rome in the late 18th century and quickly spread throughout the Western Church. By the time of Pope Pius IX's declaration of the dogma of the Immaculate Conception in 1854, it had become universal. May crownings and other special May events in honor of Mary, such as public recitation of the rosary, stem from this time.

Some or all of the following prayers to the Blessed Virgin can be incorporated into our daily prayers during this month.

HAIL HOLY QUEEN

Hail, holy Queen, Mother of Mercy! Our life, our sweetness, and our hope! To thee do we cry, poor banished children of Eve; to thee do we send up our sighs, mourning and weeping in this valley of tears. Turn, then, most gracious Advocate, thine eyes of mercy toward us; and after this our exile show unto us the

blessed fruit of thy womb, Jesus. O clement, O loving, O sweet Virgin Mary.

TO MARY, REFUGE OF SINNERS

Hail, most gracious Mother of mercy, hail, Mary, for whom we fondly yearn, through whom we obtain forgiveness! Who would not love thee? Thou art our light in uncertainty, our comfort in sorrow, our solace in the time of trial, our refuge from every peril and temptation. Thou art our sure hope of salvation, second only to thy only-begotten Son; blessed are they who love thee, our Lady! Incline, I beseech thee, thy ears of pity to the entreaties of this thy servant, a miserable sinner; dissipate the darkness of my sins by the bright beams of thy holiness, in order that I may be acceptable in thy sight.

TO THE BLESSED VIRGIN MARY FOR MAY

O most august and blessed Virgin Mary! Holy Mother of God! Glorious Queen of heaven and earth! Powerful protectress of those who love thee, and unfailing advocate of all who invoke thee! 


Mother's Day

Mother's Day is a holiday honoring motherhood that is observed in different forms throughout the world. The American incarnation of Mother's Day was created by Anna Jarvis in 1908 and became an official U.S. holiday in 1914. Jarvis would later denounce the holiday's commercialization and spent the latter part of her life trying to remove it from the calendar. While dates and celebrations vary, Mother's Day most commonly falls on the second Sunday in May and traditionally involves presenting mothers with flowers, cards and other gifts.

MOTHER'S DAY: HISTORICAL PRECURSORS

Celebrations of mothers and motherhood can be traced back to the ancient Greeks and Romans, who held festivals in honor of the mother goddesses Rhea and Cybele, but the clearest modern precedent for Mother's Day is the early Christian festival known as "Mothering Sunday." Once a major tradition in the United Kingdom and parts of Europe, this celebration fell on the fourth Sunday in Lent and was originally seen as a time when the faithful would return to their "mother church"—the main church in the vicinity of their home—for a special service. Over time the Mothering Sunday tradition shifted into a more secular holiday, and children would present their mothers with flowers and other tokens of appreciation. This custom eventually faded in popularity before merging with the American Mother's Day in the 1930s and 1940s.

MOTHER'S DAY: EARLY INCARNATIONS

The roots of the modern American Mother's Day date back to the 19th century. In the years before the Civil War (1861-65), Ann Reeves Jarvis of West Virginia helped start "Mothers' Day Work Clubs" to teach local women how to properly care for their children. These clubs later became a unifying force in a region of the country still divided over the Civil War. In 1868 Jarvis organized "Mothers' Friendship Day," at which mothers gathered with former Union and Confederate soldiers to promote reconciliation.

Another precursor to Mother's Day came from the abolitionist and suffragette Julia Ward Howe. In 1870 Howe wrote the "Mother's Day Proclamation," a call to action that asked mothers to unite in promoting world peace. In 1873 Howe campaigned for a "Mother's Peace Day" to be celebrated every June 2. Other early Mother's Day pioneers include Juliet Calhoun Blakely, a temperance activist who inspired a local Mother's Day in Albion, Michigan, in the 1870s. The duo of Mary Towles Sasseen and Frank Hering, meanwhile, both worked to organize a Mothers' Day in the late 19th and early 20th centuries. Some have even called Hering "the father of Mothers' Day."

MOTHER'S DAY: CELEBRATIONS AND TRADITIONS

While versions of Mother's Day are celebrated throughout the world, traditions vary depending on the country. In Thailand, for example, Mother's Day is always celebrated in August on the birthday of the current queen, Sirikit. Another alternate observance of Mother's Day can be found in Ethiopia, where families gather each fall to sing songs and eat a large feast as part of Antrosht, a multi-day celebration honoring motherhood. In the United States, Mother's Day continues to be celebrated by presenting mothers and other women with gifts and flowers, and it has become one of the biggest holidays for consumer spending. Families might also celebrate by giving mothers a day off from activities like cooking or other household chores. At times Mother's Day has also been a date for launching political or feminist causes. In 1968 Coretta Scott King, wife of Martin Luther King Jr., used Mother's Day to host a march in support of underprivileged women and children. In the 1970s women's groups also used the holiday as a time to highlight the need for equal rights and access to childcare.

Knights Help Provide Prosthetic Upgrades to Boston Marathon Bombing Amputees

Funding assists amputees with prosthetic care and upgrades not covered by their insurance

One year after the Boston marathon bombing, the Knights of Columbus Stand With Boston Program is providing assistance for people who lost limbs in that tragic event.

The latest in a series of Knights' initiatives to help provide mobility for individuals in the United States and worldwide, the Knights' Boston program is designed to cover the cost of additional or higher-quality prostheses in order to help amputees regain as much mobility as possible.

The Knights of Columbus is donating more than \$33,000 to help three people who lost limbs in the bombing. For two of the amputees, the funding has helped pay for costs not covered by their health insurance, supporting upgrades to state-of-the-art military grade X-3 micro-processor knees. In the third case, the K of C is helping to pay for a prosthetic running leg that supplements the prosthetic leg that is used by the person for most day-to-day activities.

"Medical coverage often has its limits," said Supreme Knight Carl Anderson, "but we are very happy that we are able to help bridge those limits with this charitable program designed to help those who lost a limb in the bombing recover even greater mobility."

Anderson added: "Following the example of the Good Samaritan, the Knights of Columbus has always sought to help those in need. What happened in Boston was a terrible reminder of the reality of evil in the world, but by responding with care for those who were hurt, we can show that the power of love is stronger than hatred or evil, and that evil does not have the last word."

In implementing the program and reviewing applications, the Knights of Columbus continues to consult with experts in the field of prosthetics and rehabilitation.

The Catholic fraternal organization has a long history of assisting those with mobility issues and has provided more than 40,000 wheelchairs to individuals throughout the United States as well as worldwide, from Latin America to Vietnam.

In the wake of the devastating 2010 earthquake in Haiti, the Knights of Columbus committed \$1.5 million in aid and launched the "Healing Haiti's Children" initiative together with several partners that has so far helped hundreds of Haitian children with prosthetic and rehabilitation care.

Cumulative figures show that during the past decade the Knights of Columbus has donated \$1.475 billion to charity and provided more than 673 million hours of volunteer service in support of charitable initiatives.



A Founding Vision, A Visionary Founder



“Resolved by this assembly: That Michael J. McGivney, Matthew C. O’Connor, Cornelius J. Driscoll, James J. Mullen, John J. Kerrigan, Daniel Colwell, and William M. Geary, and all other persons now associated with them under the name of the Knights of Columbus, together with all other such person as may hereafter become associated with them, and their successors, are constituted a body corporate and politic by the name of the Knights of Columbus.

“The purpose for which said corporation is formed are the following: (a) of rendering pecuniary aid to its members, their families and beneficiaries of members and their families; (b) of rendering mutual aid and assistance to its sick, disabled and needy members and their families; (c) of promoting social and intellectual intercourse among its members and their families, and (d) of promoting and conducting educational, charitable, religious, social welfare, war relief and welfare, and public relief work.”

~ Excerpted from the Charter of the Knights of Columbus, Granted by the General Assembly of the State of Connecticut, Approved March 29, 1882.

As the Connecticut winter drew to a close in March of 1882, few could have imagined that the new Catholic organization just approved by the General Assembly would amount to much.

Secret societies and fraternal organizations were abundant. And besides, Catholics weren’t well-liked or highly thought-of. There was even some Catholic resistance to the idea of the Knights of Columbus. Local priests took issue with the concept. A similar Catholic group even refused to allow Father McGivney to establish a branch of their organization in Connecticut.

It was seemingly inconceivable that an organization, begun in such unwelcoming circumstances, would go on to become one of the world’s largest Catholic fraternal organizations.

It was baffling to think that a group of destitute Irish immigrants, fighting against unemployment, discrimination and diseases in New Haven, Conn., would cause a spark that would light up the world with more than 1.8 million members in more than a dozen countries.

It was so improbable that a group of men dedicated to serving the needs of their Catholic community would go on to donate nearly \$1.5 billion dollars to charitable causes and spend 673 million hours volunteering in just the last decade.

And it seemed so unlikely that a Catholic priest, who spent nearly every waking minute attending to the spiritual and material needs of his parishioners, would be the founder of one of North America’s largest life insurance companies.

Inconceivable? Baffling? Improbable? Unlikely? Perhaps — but not to Father McGivney. And not to the 75 men who dared to answer his call to found the Knights of Columbus. It is his vision — and theirs — that we celebrate each March as “Founder’s Day.”

And what, exactly, did they found? Father McGivney, we know, did not just found a charitable society, but a society of mutual aid through which members would insure their own well-being, and that of their families, with the help of their brother Knights.

Father McGivney, we’re told in *Parish Priest*, began the founding of the Order and its insurance program with “an entrepreneurial zeal.” Determined to provide financial protection for his parishioners and their families, he “had to delve into the subject of insurance and read all of the fine print, of which there was plenty.”

A Founding Vision, A Visionary Founder (cont.)

Before deciding that a new group was in order, Father McGivney researched the finer points of other fraternal benefit organizations' insurance programs, ultimately concluding that their coverage was insufficient.

And when it came time to crunch the numbers and establish the newly-founded Knights' insurance program, it was Father McGivney himself who set down the terms and reported them to the members and other parishes in the diocese.

"In the way that Father McGivney had organized the insurance," *Parish Priest* says, "nearly anyone could afford coverage."

Father McGivney was devoted to his mission, working tirelessly until his premature death at age 38.

How proud must Father McGivney and his brother Knights be to know that the program he founded continues to provide affordable, quality insurance to Knights and their families?

How proud must they be to know that the Knights of Columbus continues to provide insurance by brother Knights, for brother Knights, protecting Catholic families for generations?

How proud must they be to know that the Knights of Columbus, with over \$92 billion in force and nearly 2 million active contracts, is protecting more Knights than ever before?

Not nearly as proud as we are to call Venerable Father Michael J. McGivney our beloved founder.

This March, let's make Father McGivney's priority our own. Let's continue his mission of protecting Catholic families from destitution and financial ruin by making sure that our families are protected with insurance for brother Knights, by brother Knights. After all, it's part of what being a Knight is all about.
