Projected net revenue would be approximately \$ 1,350.00 if we undertake 200 small arrangements.

The only way this proposal would work is if we hit the ground running when we return on Jan. 6, 2016. We need to seize the idea as our own (before any other organization does) and start to promote pre-sale via the church bulletin immediately. Our goal would be to pre-sell as many units as possible; we should be able to sell quite a few over the Valentine weekend. Details will be presented at the January Council Meeting

and it will be put to a vote from the floor. Basically we would procure all materials by Friday before, put our team to assemble during the day Saturday in Knights room for distribution during weekend masses. As regards our charitable acts, as part of the Coats for Kids, we delivered 2 boxes each with 12 coats, one for girls and one for boys to St. PJs on December 11. They were very grateful as they were in need.

You were fantastic in attracting new members this past Fraternal year. Let's keep up the good work I extend a warm welcome to all our new members. Only Having Insurance "Through Work" Doesn't Work
