In the Spirit

Last month we talked about patriotism in this column. In the United States, our summers are defined by patriotic holidays. Memorial Day is the unofficial start of Summer, The 4th of July is near the mid point and Labor Day takes us into fall.

All of these holidays have different meanings. This month, let's look at the 4th of July. This holiday is the date the Declaration of Independence was signed in 1776. The holiday is also known as Independence Day. There are many parts of the Declaration that refer to what Jesus taught us. Just as Jesus did not shy away from foreigners or the sick, or sinners, our forefathers wrote "all men are created equal." This was the start of a new philosophy in governance. And, to be correct, because of politics of the time, not all people were free in this fledgling country. It took a Civil War many years later to make more free.
