Why do the Knights offer Insurance? We know the story of why the Venerable Father McGivney offered insurance and how it contributes millions of dollars to charity annually, and why he started the Knights, but why do the Knights offer insurance? Sometimes you have to experience something front and center to truly embrace and understand the true circumstance of a cause. Twice over the last six months, those reasons hit me head on.

The first case was about two months ago when a widow of a Brother Knight passed away from the local Hanahan council. Her Brother called our local office during an Agency meeting literally in tears as he wasn't sure what to do as his sister literally lived pay check to pay check and didn't have \$500 to her name. Part of this was because her husband and our Brother Knight had passed about two years before and her financial situation because very difficult. Our Office Manager informed him that back in 1992 his sister took out a \$20000 whole life policy for only \$200 per year. To say he was blown away was an understatement and he personally sent me a text that evening giving me a first-hand account to the reaction of her children when he informed them of the news over dinner. This provided them the opportunity to give their Mother a proper Catholic Funeral with some money left over as well.

Case two happened about six months ago. A Brother Knight from a local Summerville Council, had just retired as a state trooper. He was in great shape physically and mentally as he would be what we in the Insurance world call Ultra-Premier. The Lord had other plans for him though as one month after he retired, the Lord called him home. His wife and kids came to our office to fill out the death claim paperwork and unknown to them, he took out a \$250,000 term policy. I'm sure the family would rather have their husband and Father back, but needless to say the tears openly flowed at that point as they knew he would still be taking care of them even in death.

This Brothers is why we do what we do and why we offer Insurance in the Knights of Columbus. It assures that we can continue to do the amazing works of Charity that we have done for years, but more importantly, it assures us that we can continue the Venerable Father McGivney's dream and care for our widows and orphans.

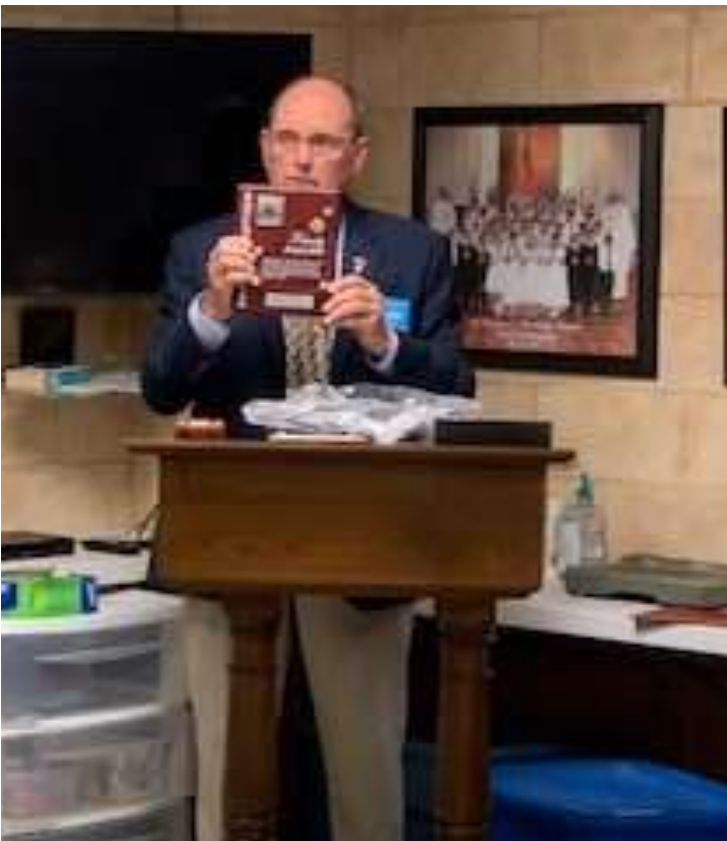
