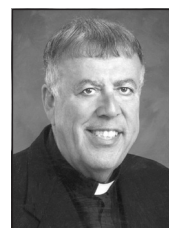

Dear Brothers Knights and families,

On November 8th, every American Knight is asked to cast his vote in the national, state, and local election. Encourage your family and friends to vote as well. This is an awesome responsibility. Practice your citizenship.

The K of C Supreme released this statement regarding the upcoming election. "Members are not authorized to engage in partisan political activity in the name of the Knights of Columbus. Partisan political activity is defined as activity directed toward the success or failure of a political party, candidate for partisan political office, partisan political group, ballot initiative and the like. Remember the Third Degree: Partisan politics are not allowed in the Order or in any of its council chambers."

Our Bishop Charles Thompson offered a powerful reflection regarding the upcoming election in the Diocesan Newspaper, The Message, on October 14th, 2016. The Bishop shares in his article that there are seven principles of Catholic Social teaching which should be considered when one votes. I encourage you to read it. If you do not receive the weekly diocesan paper, you can download it at themessageonline.org. Seek reliable information about the people whom you are voting for. We, as Catholics, are called to form our conscience based on Catholic teachings. Pray to the Holy Spirit for wisdom and vote. Pope Francis has said in reference to the U.S election that we should study the proposals well, pray and choose with your conscience.

The K of C Supreme Council has urged all its members to pray the following prayer 9 days (October 30th - eve of November 7th) before the election. This prayer was composed for the 1959 dedication of the Basilica of the National Shrine of the Immaculate Conception in Washington D.C. "Most Holy Trinity, Our Father in Heaven, who chose Mary as the fairest of your daughters; Holy Spirit, who chose Mary as your Spouse; God the Son, who chose Mary as your Mother, in union with Mary we adore your majesty and acknowledge your supreme, eternal dominion and authority. Most Holy Trinity, we put the United States of America into the hands of Mary Immaculate in order that she may present the country to you. Through her we wish to thank you for the great resources of this land and for the freedom which has been its heritage.

Most Holy Trinity, we put the United States of America into the hands of Mary, have mercy on the Catholic Church in America. Grant us peace. Have mercy on our president and on all the officers of our government. Grant us a fruitful economy, born of justice and charity. Have mercy on capital and industry and labor. Library Board Presentation

Dean Vonderheide, Jasper Library Board President, and Christine Golden, Library Director, spoke at the October 24th meeting. They shared plans for the proposed library at the old Hoosier Desk site and discussed facts leading up to the November 8 referendum where the public will be asked to support a \$6.5 million bond for a new library. The median homeowner in Jasper would see an increase of \$2.69 per month. By working together with the City of Jasper and a private developer, the Cultural Center project has secured \$3.4 million in IEDC tax credits to revitalize an old industrial site. The plans include tearing down the old factory and building a brand new library on the site.

Much of the conversation throughout the evening focused on flood plain and soil concerns. Flood insurance will not be necessary for the site as the plans include raising the

ground level of the building to 30 inches above the flood plain. GEM engineering has developed a pylon system that minimizes any concerns about the soil makeup and feel confident moving forward. Golden and Vonderheide stressed this is a 15-year bond and hopes to even further minimize the tax impact through fundraising. A total of \$4.2 million has been raised so far through Jasper LEADs, with close to \$800,000 being pledged to the library.

Golden and Vonderheide thanked the K of C for giving them the opportunity to speak about the need for a new library in Jasper that will provide flexible space, more programming opportunities, meeting rooms, and the ability to move the Jasper Public Library into the 21st century.
