The Sacred Heart

The month of June is dedicated to the devotion to the Sacred Heart of Jesus.

When I was a child the image of the Sacred Heart of Jesus impressed me a lot: the heart on the outside of Jesus' chest with thorns and blood around scared me. I did not like the image of the sacred heart.

My parish in Portugal was the first church in the world dedicated to the Sacred Heart. The Estrela Basilica was built by order of Queen Mary I of Portugal, because she made a vow: if she had a son she would build the first basilica to the Sacred Heart .She kept her promise after bearing a son, José, Prince of Brazil and dedicated the church in 1790.

I understood the importance of the Sacred Heart of Jesus while in the seminary. The devotion to the Sacred Heart is the devotion to the human heart of God, the human love of God. The heart is a symbol of God's love for us. Saint John's Gospel says that Jesus' heart was pierced by a lance. The heart of God burns with compassion for us. To be devoted to the Sacred Heart means to let God's love change our lives. It



means to accept His love for us.

During the month of June let us look at Jesus' heart; let us rediscover Jesus' love for us!

Warden's Word

As the "watchdog" of the council I feel it's my duty to inform all of my observations.

- Over the last 11 months I have observed approximately 185 of our 1000 members in attendance at council events.
- Of those 185 attendees I have observed that approximately 80 of them attended numerous events.
- Of those 80 I have observed approximately 60 of them work these events.
- Of those 60 I have observed approximately 45 of them work multiple events.
- Of those 45 I have observed almost 100% of them not only donated their time and effort but paid to attend.
- The average attendance for a Business Meeting was 35, which is 3.5% of our council membership. (I believe at least 10 of us are required attend.)

These are somewhat disturbing observations. While I am in full agreement with the State and National push for new membership, I for one would like to see the push for better participation from our current membership.

Family of the Month


"Strength Through Faith, Family & Fraternity"



Capital Improvement Fund Update

Lamar Odom's Life Insurance Story Lamar was raised in Queens, New York in a sin-

gle-parent household. Even though his mother, Cathy, earned a modest income working as a corrections officer, she sent him to Catholic school because of concerns about the public schools in the South Jamaica neighborhood where they

lived. When Lamar was 12, his mother died of colon cancer. Because she had life insurance, Lamar was able to continue his Catholic school education.

When Lamar graduated high school at 18, life insurance again made a difference in his life. Lamar was considered to be one of the best young basketball players in the country, but knew it would be best for his career if he did not pursue a professional career right away. Because he and his grandmother, who raised him through high school, were financially stable, Lamar did not need to immediately earn a paycheck and attended college for several years prior to turning pro.

"I'm sure my mom didn't think she would die at age 35, but that didn't stop her from doing the responsible thing and buying life insurance," said Lamar. :her wise decision gave me the foundation to move on in my life, and played a big role in making me the person I am today. When I began my pro career, one of the first things I did was buy life insurance to make sure that my loved ones would always be taken care of. I'm proud to be working with the LIFE Foundation to share my story and to hopefully get more Americans to do the kind of smart planning my mom did."

Do you know someone who is a graduate of Gonzaga High School? Are you a former student of Gonzaga located at 900 North Capitol Street? Who are those persons wearing Gonzaga Alumni shirts seen recently in The Knight's Room. Who was this person to have a now famous Catholic school named after him?

Aloysius Gonzaga was born into an aristocratic family in the castle of Castiglione, Italy, in

1568. His father was Ferrante Gonzaga, a Marquis, and a professional soldier. Aloysius received instructions at the age of eight in Florence. At the age of twelve he received spiritual guidance from St. Charles Borromeo. Later, he and his brother went to Madrid where his father served the Spanish King. While in Spain he decided to become a Jesuit priest. During his novitiate period he received many instructions and exceeded in mathematics, theology and philosophy. He had always been ill as a child and suffered from kidney disease. In the fourth year of his studies a famine and pestilence broke out across Italy. Disregarding the hazard to his own health, he devoted himself to the care of the sick and dying. He reported a vision of the Archangel Gabriel who told him the day of his own eminent death. On that very day, June 21, 1591, he died from the illnesses he'd contacted. He was canonized by Pope Benedict XIII. (1726).

Undoubtedly you've noticed that the old Walter Reed Army Hos-

pital just South of us along Georgia Avenue has closed and the new facility has opened next to Navy Hospital on Wisconsin Av. The many injured and amputee soldiers we'd see around Silver Spring are no longer with us. Many people have wondered what will happen with the now vacant property. The plan is to convey 67 acres to the District for redevelopment into residential, retail, community parks and a hotel/conference center. The remaining 43 acres will go to the Department of State which plans to build a Foreign Missions Center with space for fifteen chanceries or embassies. They anticipate this will be a 20 year long project. The Walter Reed Medical Buildings on Brookville Road in Silver Spring are unaffected.

Reflections Lawrence P. Grayson The Nation's Eroding Consensus

America is under stress. It is experiencing a splintering of the core values that hold it together as a nation. The populace is evolving into divergent groups possessing strongly opposing beliefs, with little or no middle ground. It is evident on issues such as the rights of an unborn child vs. those of the mother, the definition of marriage, the extent of religious freedom, the balance between personal liberty and national security, and individual vs. government responsibility, among others.

A nation requires not only a defined territory with an orderly, stable government, but a communal culture, that is, a foundation of common societal values, traditions, language and history, which can form its people into a community. Culture, which may evolve over time, typically is the most powerful of the forces defining a nation.

From its inception, America has been a pluralistic society welcoming people of diverse backgrounds, nationalities and cultures. The resulting multiplicity of talents that have poured into the country have strengthened the nation, while providing opportunities for individuals to succeed based on their abilities, desires, and efforts. Within a generation or two, the customs and mores brought by the then-immigrants harmonized with the extant ones, creating a dynamic American culture, which adopted elements from the lands of the more newly arrived. Over time, the blending became a unitary culture, with continual refreshment from the influx of new immigrants. This has been America's history as it has striven for unity-amid-diversity.

As America expanded from a collection of 13 colonies bordering the Atlantic Ocean to 50 states spanning the continent and beyond, it was populated largely through the emigration of peoples from European countries. This produced varying regional characteristics with people having different intensities regarding specific issues, but possessing a core of prevailing values based on Judeo-Christian teachings.

While never perfect, the success of America's societal "mixing bowl" has rested on a societal commitment to tolerance and respect for individual rights. It also has required a broad consensus among the multiple communities, minority and majority alike, on the nation's core beliefs and cultural values. Without the consensus the nation could not have continued to exist - at least as a democracy.

More recently, the traditional approach to pluralism has been transformed, as the emphasis has been to celebrate diversity over unity. While this may appear to be more tolerant, more open-minded, and more progressive, with a greater commitment to promote equality and togetherness, it has a significant flaw. Multiculturalism is based on relativism. In its drive for impartiality and equity, it presents every culture and society as equally desirable and beneficial, except that of the prevailing majority which is consistently denigrated and pressured to be contrite for failings that were addressed generations ago. Peoples of other cultures are encouraged to express their traditions in glorified ways, but those of America's resident culture are maligned with accusations of intolerance, bigotry, or nativism when they try to exhibit pride in the aims, ideals, achievements, heroes, struggles, sufferings, and triumphs of the nation's past

Multiculturalism ignores the necessity for a common set of values. It promotes detached group identities and disparate societal principles. To obtain recognition and acquire special rights, groups speak with indignation and outrage, claiming histories of abuse. A separate identity for the faction is promoted through consciousness raising and an emphasis on things that remove it from the rest of society. Spokesmen for the group assert that its members are victims of discrimination, a concept that is constantly enlarged and used to limit the freedom of opinion and autonomy of conscience of others. This is a powerful accusation, especially in a nation founded on freedom, and often suppresses opposing views.

When core principles are in conflict, as when minority groups hold views or pursue activities that are anathema to the larger society, the nation becomes fragmented. Bitter conflicts arise when one group makes statements or behaves in ways that offend the majority, especially when those actions appear to be an attack on religious beliefs. Group identity then becomes a source of dissent, rather than adding to the richness of a shared culture.

The strength and permanence of a society, especially a democracy in which government is invested in the people, requires a commitment to shared constants that provide criteria for communal action. America was founded on Christian principles. Its common standards are based on values and virtues that are derived from the Gospel and best taught by religion. But this nation, as Europe before it, is trying to relegate religion to the private sphere and ban any mention of God from public discourse or expression.

Without recognition of the transcendental, without an acknowledgement of God, without a respect and reverence for that which is holy, the nation as we know it cannot continue to exist. When there is no faith or belief in God, individuals attempt to achieve self-fulfillment through an exclusive focus on wealth, consumerism, and personal pleasure, resulting in declining moral standards, a neglect of the common good, and little commitment to family or community. Such a profane and hedonistic society is literally unsustainable.

America has succeeded on the basis of pluralism, in which a balance has been struck between adherence to a common set of values – based on Christian teachings – and the freedom for peoples of varying backgrounds and beliefs to maintain their own identities. Multiculturalism, which often promotes relativistic secularism, undermines such core values as freedom of conscience, the dignity of the individual, human rights at all stages of life, concern for the common good, and patriotism. American, without those values, has no future.
