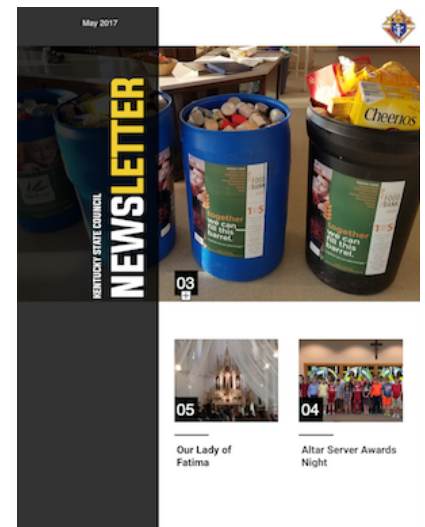

The world-famous International Pilgrim Virgin Statue (IPVS) of Fatima is one of two “twin” statues sculpted in 1947 by famous sculptor José Thedim. The image reflects the precise instructions of Sister Lucia.

Her desire was that the pilgrim image represent Our Lady’s position when she revealed herself as the Immaculate Heart to the Shepherds in 1917. Our Lady of Fatima through the Pilgrim Virgin Statue, set forth from Fatima in May, 1947 to claim her dominion and become the Pilgrim of the World, carrying first to devastated Europe after WWII the message of peace.

### UPCOMING STATE CONVENTION – The State Convention is *your* Convention

- It is *your* opportunity to be recognized for the Good Works performed by *your* council over the past year.
- It is *your* opportunity to see, hear and learn about the Good Works performed by other councils.
- It is *your* opportunity to meet new Brother Knights. To develop new friendships and to build upon existing friendships.
- It is an opportunity for *you* to spend a moment in silent adoration in front of the Our Lord during the Adoration Hour and to attend mass with *your* State Chaplin Fr. Patrick Dolan.
- It is an opportunity to break bread with *your* Brother Knights. To be one in Christ and to give thanks to Fr. McGivney for his vision of founding an organization dedicated to Mary and serving those in need.

### UPCOMING STATE CONVENTION – Things you should know

- Any 3<sup>rd</sup> Degree member of the Knights of Columbus that is in good standing with the Order and that has a valid travel/membership card may attend the State Convention Business meeting.
- Only those councils in good standing with Supreme and the State Council may have a voice (vote) at the convention. (Article 1 section 9 of the KY State By-laws)
- Only those councils having properly submitted their delegate's paper work may have a voice (vote) during the convention. In the case of a "Contest of Delegate" one member of each side may appear before the Credentials Committee. (Article 1 section 8 of the KY State By-laws)
- All meetings of the State Council shall be conducted in the Third Section. ***DO NOT send a 1<sup>st</sup> or 2<sup>nd</sup> degree member to the State Convention as a delegate.***
- A candidate being nominated for office must be nominated by a recognized delegate or a member of the State Council with "Voice" privilege.
- A third degree member in good standing can be nominated from the floor, but it will be announced that he does so without a review or recommendation from the Election Committee. (Article III section 2(f) of the KY State By-Laws)

### Council Resolutions:

We have a total of 14 Resolutions submitted for review and action at the upcoming State Convention. The Resolution Committee will be composed of the following councils:

**1055, 1361, 1418, 1955, 2046, 2282, 3909, 5634, 6897, 10725, 12623, 13196, 14728, 15063, 15484, 15841, 16206, 16232 and 16424**

It is the responsibility of the Resolutions Committee to be familiar with the resolutions, bring up any concerns for discussion and be prepared to vote on them at the State Convention. All 14 resolutions were sent out last month to each Council's Grand Knight and to the Past State Deputies. For those councils that will be serving on the Resolutions Committee you will be receiving an additional email with the resolutions so that you can share them with your council's delegates. Although I will have a few copies of the resolutions with me at the State Convention, it is my expectation that the members of the Resolution Committee will be fully informed and ready to express any concerns and then vote on each resolution.

### Candidacy Declarations:

There are a total of 5 Candidacy Declarations at this time, one for each current State Officer. An individual wishing to run for a State Office and not having submitted a Declaration for Candidacy may do so at the State Convention during the period of time that the request for additional candidates for a specific office is called out. A candidate for office cannot nominate himself. In order for a candidate's nomination be accepted, the nomination must be presented to the assembly by a certified delegate to the State Council or a member of the State Council having "Voice" privilege.

### Safe Environment Training:

The GOOD NEWS is that we've made some progress in our efforts to get every council compliant with Supreme's mandate that all councils be trained in the Safe Environment Training program. The BAD NEWS is that there are currently 28 councils that have not completed the required training. In some cases it may be that an individual did not get his "background" check completed, in most cases either the GK or Youth Director or both have not completed their training. All training should have been completed by the end of December, 2016.

Those councils that have not completed their training have either been called or have received at least one email notice requesting feedback as to when they will complete their training. Worthy Faithful Navigators and Ladies,

**May Events;** May 1<sup>st</sup>, Observed as May Day, a holiday and spring festival since ancient times, also

observed in socialist countries as a workers' holiday or Labor Day. On May 2, Pope Leo XIII (1810-1903) was born in Carpino, Italy (as Gioacchino Pecci). He was elected Pope in 1878 at age 67 and lived to govern the church another 25 years, laying the foundation for modernization of Church attitudes toward a rapidly industrializing and changing world. May 5<sup>th</sup> is celebrated in Mexico as Cinco de Mayo, a national holiday in remembrance of the Battle of Puebla in 1862, in which Mexican troops under General Ignacio Zaragoza, outnumbered three to one, defeated the invading French forces of Napoleon III.

May 8, 1945, a second German surrender ceremony was held in Berlin. Soviet Russia's leader Josef Stalin had refused to recognize the German surrender document signed a day earlier at Reims. This time, German Field Marshal Wilhelm Keitel signed the surrender document which declared, as did the first, that hostilities would end as of 12:01 a.m. on May 9th.

May 1869, the newly constructed tracks of the Union Pacific and Central Pacific railways

were first linked at Promontory Point, Utah. A golden spike was driven by Leland Stanford, president of the Central Pacific, to celebrate the linkage.. It is said that he missed the spike on his first swing which brought roars of laughter from men who had driven thousands upon thousands of spikes themselves.

May 26, 1917 John Fitzgerald Kennedy was born, the 35th U.S. President was born in Brookline, Massachusetts. He was the youngest man ever elected to the presidency and the first Roman Catholic. He was assassinated in Dallas, November 22, 1963, the fourth President to be killed by an assassin.

**Next Exemplification:** July 22, 2017, Father Alexander Korte, Bowling Green, KY. The planning is almost done and the information will be on the Kentucky Website soon. The information will be handed out at the State Convention, this Exemplification will be held in the Owensboro Diocese. This will be the First Exemplification for 2018 Fraternal Year. The new Year starts July 1, and I hope to have an Exemplification in each of the Diocese of Kentucky. The February Exemplification will be held in Radcliff on February 24. If your Assembly would like to sponsor an Exemplification, please let me know.

May is election month. Please conduct your elections and report the new Assembly Officers on the Knights of Columbus Website.
