# **Grand Knight's Report**

I had the pleasure of visiting Past Grand Knight Frank Svacina recently. Frank was Council 10930's First Grand Knight when the council chartered in 1992. Frank, a pharmacist, brought a wealth of Knights of Columbus experience with him from Wisconsin. He along with Fred Bolliger, Frank Helwig, Rane Fief, Tom Dera, Harold Green, Tom Konen, Joe Kozel, Larry Loftus, Bob McWilliams, Charlie Parr, John Phillips, Willie Seger, Gene Sieja, Lee Sperry, Walter Stank, Rev Sal Stefula, John Thome, Tom Walsh, and others launched the Council 10930 with 50 members. The list of charter members hangs in St Thomas Parish Hall.

Thanks to a solid foundation, nearly 20 years ago, our Council now has 204 members. (Charlie Parr deserves considerable credit for this accomplishment, at least for the 6+ years I have been a member of this council.) There will be one more First Degree ceremony May 10. Please have prospective brothers complete a form 100 and give it to Charlie, or me, ahead of the 5/10 meeting.

After some necessary attrition, we hope to finish this fraternal year with more than 205 members. Numbers/statistics do not mean much without corroborating evidence, but I will let you be the judge of how much of an impact Knights and their families have had over the last 20 years. Currently, Knights and wives serve on the Pastoral Council (6), the Finance Council (4), Why Catholic team, (3) Fund Raising Committee (12),and Stewardship committee (5) (Number in parenthesis indicates minimum number of Knight/wives on the committees; there may be more). We help staff various ministries including Eucharistic, Lectors, Hospitality, RCIA, RCIC, as well as Social Outreach service through the Food Pantry, Samaritan House Suppers, and the Presbyterian Nights Shelter. No doubts these roles would be occupied even if there was not a vibrant Knights of Columbus Council 10930, but I am sure they would not be filled as well!

These are only the most recent examples of a nearly 20-year commitment that Knights and their families have made to St Thomas the Apostle and Holy Trinity. We make an enormous difference in the church and community. Heartfelt thanks to you, our present and past members and wives, for what you have done, what you are doing, and you will continue to do.

## Are You Degree Officer Material? (Borrowed from the Texas Knights Website)

Ceremonials are vital when it comes to making council quotas and goals. Setting regular dates for the exemplification of the degree and for team practice is important for the best presentation.

It is just as important for a degree team to recruit new members as it is for a council to recruit new members for the order.

As leaders in the Knights, we need to step up to understudy a role that may have particularly impressed us as you observed a veteran team perform their charge. Some are longer than others, and some are only a few paragraphs. What is takes to become a First Degree Team Member is a commitment to live life according to the ceremonials. From the beginning, the degree has taught the candidate a lesson that was specifically focused on a man's duty to God and his family. Our ceremonials are important because they cross all national and economic boundaries.

These principles are Catholic duties that guide a member for a lifetime. Thus the presenter must also be of a caliber to live the lesson that is taught. Ceremonialists often comment that work as a degree officer is extremely fulfilling. Memorization is a tall order for some. Team depth is especially important to help the Order move forward at a more rapid pace. Teams and team members must be well versed in not just one role, but several, so that a complete team is ready and able to admit candidates to the council.

A well-memorized and inspiring delivery will motivate a new member to become active in his council. It helps him to see the dedication of the members that have worked to memorize a talk and have it seem to come from the individual rather than from a piece of paper. This is the true test. Anyone can read words aloud, but the man who lives the virtues

expressed as a true member and a gallant Knight.

Degree members come from the membership and are often some of the more busy brothers we have. They learn how to arrange their calendars around scheduled degrees.

The degree officers should have the ability to deliver in a professional and eloquent manner. The words are very important, but how it is delivered will always leave an impression on the recipient. Council officers need to keep their eyes open for members who show aptitude for becoming a certified degree officer. Not all will be able to make the cut, as the standards are high.

Practice and rehearsal is important. The professional presentation and depth in each role is key to the long-term growth and success of your council.
