Thank you to all who sponsored candidates or participated in the Exemplification of the Fourth Degree this past Saturday. Sixty-eight new Sir Knights! Very Well done. This was the first Exemplification under the new Dress Rules. There were mix of members and candidates in tuxedos and suits. Tuxedos are no longer required but certainly can be worn. The social baldric is now no longer used. The PG-113, Emblem of the Fourth Degree, pin is now the only pin to be worn for any Fourth Degree event whether on the New Uniform, a tuxedo, or a suit. Those PG-745-US, commonly called the national flag pin, are now relegated to your weekday or weekend suit or sport coat. We can now focus on candidates for the Fourth Degree Exemplification in Ocean City on 24 March 2018 at the Princess Royale Hotel and Convention Center. Let's double the number of candidates for that Exemplification.

Just in, Supreme is extending the deadline for the **25 percent discount** on ordering the **new uniform** to Oct. 31, 2017. Remember, you can only get the New Uniform at the **KnightsGear.org** and the uniforms

will arrive some weeks or months in the future. There are 2,000 on back order at this time. The New Uniform is only required for Color Corps events but we would like to see many more **Color Corpsmen** added to our ranks so please get this out as soon as possible.



This year, our Assembly is continuing the collection of items for veterans who reside at the Loch Raven VA Community Living and Rehabilitation Center in Baltimore, through activities at the parishes of each of our three affiliated Councils. For the third consecutive year, we obtained and displayed items such as toiletries, health care items, and books at the Resurrection Council's Italian Dinner on Friday, September 15. Attendees at the dinner were offered the opportunity to purchase, and then donate, the items on display.

This year, approximately \$230 of items were purchased and donated, which our Assembly will deliver to the VA Center later in the fall.

Veterans Online Exchange Shopping Privileges Update

Last year, the Base Exchange system announced they would allow veterans to begin shopping on the AAFES, NEX, and other online stores, starting on

Veterans Day 2017. The Exchanges have begun verifying eligibility and have started rolling this out on a limited test basis. So

have started rolling this out on a limited test basis. So far, they have granted online shopping access to several thousand veterans as beta testers.

AAFES will continue to allow some veterans access to the online store now, so they can test adding new people to the system and get a head start on the process.
