Perpetua and Felicity** (March 7), **St. John of God** (March 8), **St. Frances of Rome** (March 9), **St. Patrick** (March 17), **St. Cyril of Jerusalem** (March 18), **St. Joseph** (March 19) and **St. Toribio de Mogrovejo** (March 23).

The feast of **St. Katharine Drexel** (March 3), is superseded by the Sunday liturgy.

When the charter was issued in November twenty ninth, 1992, the council met in the basement of St. Edward Church. All Knights of Columbus meetings and social functions were held there as well. For several years, a weekly BINGO was held there sponsored by our council.

Sometime during 2010 and into 2011, a new building was started for a Parish Hall. The new hall was being built with pledges form our church members and with an outside donation. The parish hall was paid off in less than 4 years. The council then moved from the basement to the new Parish Hall along with all money-making projects.

Some activities that we will mention will start with Thanksgiving Dinner for the people of Fulton, Kentucky, sponsored by our local council. We did this for anyone that wanted to come. We fed three hundred people and delivered a portion of these meals to the sick and shut-ins in the area. Several churches worked together to put this

meal on one that helped tirelessly was the First United Methodist Church.

On occasion, Fr. Robert would find a family in need of help with their utilities and our council would at times pay a portion of their bill and at times there might be a need to pay the entire bill so that the gas, water, and electric would be turned back on for the family. We believe that helping people that have a need greater than ours is what our Lord Jesus wants us to do. No one that had a true need was ever turned away by our church or Knights of Columbus to my knowledge.

March State Advocate Facts, Forms and Fat Tuesday Greetings

Brothers,

A reminder that any and all Council and Candidate Resolutions that are to be submitted for consideration at the 116th State Convention in May should have been voted on and approved at the council level and submitted to the State Advocate by **March 15th, 2019**.

Here is an update with Safe Environment Training and reminder that **All Youth Compliance must be completed before May 1**st..... PLEASE DO NOT WAIT

As of 3/1/2019 there are;

16 GKs that are not compliant with their training.

39 Program Directors not assigned.

66 Community Directors not assigned.

67 Family Directors not assigned.

We have 16 councils who are fully compliant. Great Job!

We have 2 more councils who have a few spots pending to become fully compliant...

Please consider helping your council out by volunteering for these important roles and more importantly, when you receive an email notification to take the training or to authorize a background check (Community or Family Directors), PLEASE DO NOT WAIT to complete! There were a few councils last year who had everything for the Star Council award except completion of all 4 positions requiring Safe Environment Training Compliance (Grand Knight/Program Director/Community Director/Family Director) or the Safe Environment Background Check Compliance for the 2 positions requiring it.

Did you know that one or two persons can serve in any or all of these 4 positions? If you have questions about the Safe Environment Compliance process, please contact me now! District Deputies will be receiving copies of the progress reports for their councils to help encourage the Safe Environment Compliance. This is a very important training component in your Council's operations.

As of 3-1-2019, here is an update on Delinquent Council Reports and I hope that we can help get to 100% compliance before June 1, 2019.

Form#185 Officers Chosen for the Term - report was due by 7/31/18.

12 Councils have no report turned in.

Form#365 Service Program Personnel Report - report was due 7/31/18.

28 Councils have no report turned in. (in order to get a Brother Knight in the process for Safe Environment Training or Background Check, a new Form#365 listing the Program Director, Community Director or Family Director would be filled out and sent to Supreme.

Form#1295 Semi Annual Audit for Period ending 12/31/2018;

18 Councils Delinquent Last 2 Periods - These councils are in danger of losing their bonding and face possible suspension.

13 Councils Delinquent Only Last Period

Form#1728 Survey of Fraternal Activity - report was due January 31st, 2019.

32 Councils still need one filled out and turned in (not too late). The best way to submit the **Survey of Fraternal Activities Form#1728** is via online submission by logging into Member Management. Supreme is also receiving a lot of old Form #1728 forms. They will process these; however, it requires extra time. Reminder that there is a new #1728 or use the online submission method.

Supreme has stated that they have received a large number of submissions for both the Form#1728 Survey and the **Special Olympic Report Form#4584**... More than they ever have at this point previously! Nearly two-thirds of the Form#1728 has been though the new online submission!

Reminder to all Councils who have not filled out and turned in the **Special Olympic Report Form#4584,** Please submit to Supreme even if you did not participate in any events.

I am writing this to you on Fat Tuesday and through prayerful consideration, I have a plan of action to spend this Lent preparing for Easter. I have found over the years that adding something worthwhile to my routine is much better for me than trying to "give up something". The best "action" that is now a daily routine was to go to the USCCB website and do the daily readings. Bishop Barron's "Word on Fire" also sends an email each morning that helps give me better understanding of the day's Gospel. I pray that your Lenten experience this year helps you and your family to be closer to our Lord.
