



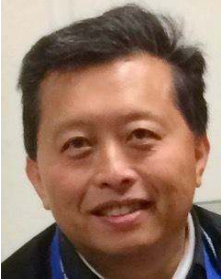

HALTON COLUMBUS CHARITIES (HCC)

The charitable organization that administers the funds for the K of C Council 5073 is Halton Columbus Charities

The role of the HCC is:

1. to supply and render services to poor persons as to their poverty
2. to establish training or educational centers and to train poor persons in gainful trades, professions, and occupations with a view to enabling said persons to become self sufficient
3. to give donations for charitable purposes to qualified donees as set forth in the Income Tax act
4. to co-operate with other organizations, which are also registered charities under the Income Tax Act, whether incorporated or not, which have purposes similar in whole or in part to the objects of this Organization
5. to do all such other things incidental and conducive to attainment of the above objects

The structure is a president, vice president, secretary, treasures, two (2) board members, two (2) ex officio members. All members of council are in fact members of HCC. The HCC meets regularly (typically monthly).

HELPING THE POOR IN THE WORLD

Mother Theresa of Calcutta was known for her work with the Poor in far away countries. When she met Dr. Andrew Simone years ago she told him that sending money would not be good because there was no food to buy there.

Listening to Mother Teresa's words inspired Dr. Simone to open a warehouse in 1984 located in Mississauga at Lakeshore and Orchard Roads, just beyond Port Credit. Many council members have joined me each Wednesday at the warehouse. There, we assist in the loading of shipping containers (size 8 ft. x 8 ft. x 40 ft.) whose final destination will help the poor around the world.

Dr. Simone and the Canadian Food For Children (CFFC) need volunteers to assist the loading preparation of the shipping containers.

We have had members going to the warehouse since 2011. Currently, we have two who help out but we need more. Our day will start at 7a.m. when we carpool from Burlington. The shift starts at 7:30 and ends at noon.

BURLINGTON KOLUMBUS CLUB NOMINATIONS

The Kolumbus Club is the holding company of the Knights of Columbus home. This company was formed to provide and maintain the property on Industrial Street. It is registered with the Government of Ontario and operates under Letters Patent. There are no shareholders in this company. All members of Council 5073 of the Knights of Columbus are members of the Kolumbus Club by virtue of their membership in the Knights of Columbus.

A Board of ten (10) Directors administers it.

- The Grand Knight and the Financial Secretary hold two (2) of the Director positions automatically by virtue of their office. That is referred to as "Ex-officio, Ipso Facto."
- The other eight (8) Directors are elected from the General Council Membership. The term of office is two (2) years.
- An executive of four (4) governs the Board of Directors: President, Vice-President, Secretary and Treasurer.
- These executive positions are elected from the group of eight (8) Directors each year by the Board of Directors.
- The term of the executive positions is one year.
- Although the Grand Knight and Financial Secretary have the same voting rights as all the other Directors, they do not serve on the Kolumbus Club executive.

NOMINATIONS AND ELECTIONS

To provide continuity, we elect four (4) Directors each year. The term of office is from April 1 to March 31.

Nominations for four (4) Directors will start at the February General Meeting. Elections will be held at the March General Meeting.

If you are interested in serving on the Board of Directors, ask a Brother Knight to nominate you or speak to the Grand Knight. If you think another Brother Knight would like to serve on the Board of Directors, speak to him and ask him if you can nominate him.

HALTON COLUMBUS CHARITIES NOMINATIONS

Halton Columbus Charities is a charitable organization registered with the Canada Revenue Agency of the Federal Government of Canada. It is responsible for managing the charitable activities of Monsignor James Corbett Warren Memorial Council 5073.

- All members of Council 5073 are members of Halton Columbus Charities by virtue of their membership in the Knights of Columbus.
- A board of six (6) directors manages the affairs of the Corporation.
- The elected Board of Directors of the Corporation operates via by-law and is accountable directly to the Grand Knight and the Council.
- The Grand Knight and the Financial Secretary hold two (2) of the Director positions automatically by virtue of their office. That is referred to as "Ex-officio, Ipso Facto."
- The other six (6) Directors are elected from the General Council Membership. The term of office is three (3) years.
- An executive of four (4) governs the Board of Directors: President, Vice-President, Secretary and Treasurer.

The Board of Directors elects these executive positions from the group of six (6) Directors each year. The term of the executive positions is one year.

Although the Grand Knight and Financial Secretary have the same voting rights as all the other Directors, they cannot serve on the Halton Columbus Charities executive.

NOMINATIONS AND ELECTIONS

To provide continuity, we elect two (2) Directors each year. The term of office is from July 1 to June 30.

Nominations for two (2) Directors will be held at the March 14 General Meeting. Elections will be held at the April 11 General Meeting.

If you are interested in serving on the Board of Directors, ask a Brother Knight to nominate you or speak to the Grand Knight. If you think another Brother Knight would like to serve on the Board of Directors, speak to him and ask him if you can nominate him.

PRAYER CENACLE

Have you ever wondered what happens at our monthly Prayer Cenacle on the last Thursday of each month at the Hall?

Over the course of an hour, we greet each other, and then we start with a song, usually singing *Come Holy Ghost*.

Then we pray the Rosary – always five decades of the Luminous Mysteries complete with all the prayers before and after.

Each decade is led by one person, and there can be a suggestion of whom to dedicate the prayers.

Following that, there are prayers for our Pope, and then the Litany of the Blessed Virgin Mary.

After the Litany, we select a reading from the works of Fr. Gobbi who speaks in the voice of Mary to us about current times and our need to be staunch supporters of our faith and the Church.

There is usually some discussion about the readings.

We wrap up with the Act of Consecration for Religious and Laity, and then sing a few verses of *Immaculate Mary*.

Our Cenacle Rosary usually starts at 6:30 p.m. but can be moved if an event interferes.

All are welcome – Knights, their wives, and friends – to come and meditate and pray for our brother Knights, their families, those in need of prayers for health, and those departed.

The family that prays together, stays together. This is an opportunity to meet and know your brother Knights much more closely.

ENGAGING IN SERVICE

Our work as Knights focuses on six service categories of Church, Community, Council, Culture of Life, Family and Youth. The K of C "Service Program" is organized around these topics. In this article we'll start to look at 'Council Activities' and ways that we can dedicate our support of this category.

Council programs and activities help foster a sense of fraternity and family in the Knight of Columbus

community. Members are our neighbours, friends and acquaintances. Opportunities are limited only by the imagination in this category.

SPECIAL OLYMPICS

This is a most rewarding activity — to volunteer our services and time to raise funds for this sports-training and competition program for people with intellectual disabilities. In recent years, Knights of Columbus councils have donated several million dollars and have volunteered several hundred thousand hours of volunteer services.

PUBLIC RELATIONS

First and foremost, it is important to keep our members up to date on council programs and activities. Another audience is the Catholic community — the parishes the council serves and the broader community in which the council is located. Ways a council can accomplish this include:

- Publishing a monthly bulletin or newsletter for its members
- Maintaining and updating our council's website
- Spreading the word through traditional media newspapers, parish bulletins
- Taking council inventory by completing Fraternal Activity Survey 1728

FRATERNALISM

The Knights of Columbus is a fraternity, a brotherhood; and it requires effort to strengthen those bonds. To do that, our council might:

- Encourage all members to wear their ID badges at all meetings and events
- Present degree certificates to the members of each degree immediately after the exemplification
- Select a "Knight of the Month" or "Knight of the Year" and present them with appropriate certificate(s)
- Have an active presence at all funerals of Knights whose loved ones have passed. Speak at the reception supporting Brother Knight and his council involvement
- Spearhead Columbus Day celebrations in the community
- Celebrate Founder's Day with special celebrations for Father McGivney, our founder
- Plan activities together as a group on a regular basis

K OF C 5073 BINGO PROJECT

Our Bingo Project is the Council's most consistent, yearly project whose main purpose is raising funds for the neediest in the community.

At present, we sponsor three monthly bingo events which are held at the Bingo Connection hall in Burlington.

Today, this project yearly brings in approximately \$13,000 NET for distribution to the registered local charities chosen by the Council's members and approved by the City.
