On October 2, I lost my older brother, Daniel Kasprzyk after a long battle with Dementia and Parkinson's Disease. It was hard to watch his life deteriorate to the point that he was totally dependent on everyone to take care of him and meet his daily needs.

We knew the day would finally come when he would leave this earth. I did not know how I would handle all of it. We had a small service at the funeral home in Brandon at which Father Tapp officiated. Father Tapp found the right words to lift my spirit. Father talked about how there would be an abundance of everything in heaven and that we would not want for anything.

My brother was then transported to Buffalo, New York for his final resting place. Rev. Dr. Czesław M. Krysa presided at the Funeral Mass in the Church of St. Casimir. This was our parish church growing up and was just down the block from where we lived.

Reverend Krysa stated that we celebrate our birth and look at death as an end, but it is not because it is our birth into our next life that will last forever. When we left the church, the church bells were ringing as if it was a celebration.

There will be an abundance of joy and love and they will no longer suffer from what ailed them on earth. I hope that I will be worthy to see my brother and family again in heaven.

Venerable Father McGivney

What Makes a Miracle?

Since Venerable Father Michael McGivney is at the stage of the canonization process in which a miracle is needed for him to be beatified, the Guild often receives questions about what exactly is needed for a miracle to be accepted. What standard does the Vatican use in declaring some events miraculous and others not?

A book could be written on the subject, but to put the issue in simple terms, what the Vatican is looking for in most cases is a physical healing that cannot be explained by medical science. Let's look a little more closely at the whole process of "making a miracle."

The first thing to understand is that only God can perform a miracle, since a miracle is understood to be a suspension of the created natural order. When we say that Father McGivney needs a miracle for beatification, what we mean is that a proven miracle must be attributed to his intercession before God.

<u>Identify</u>

With that important fact understood, we are ready to walk through the process of how a proposed miracle is brought to the Vatican's Congregation for the Causes of Saints. Step one is identifying a possible miracle for which people close to the situation prayed to a sainthood candidate — in this case, Father McGivney. The Congregation for Saints considers almost exclusively extraordinary physical healings and recoveries, since those incidents usually have verifiable facts such as medical tests and records, as well as objective and widely accepted measurements for diagnosing a serious condition and declaring a person healed. Examples of non-medical miracles that have been approved by the Vatican congregation include cases of survivors walking away unscathed from accidents that should have been fatal, such as falls from a church ceiling and mountain climbing mishaps. Certainly, there are other types of miracles that involve moral, psychological and spiritual phenomena, but physical healings are easier to investigate and prove in an objective, scientific manner.

Report

How would we identify a possible miracle through Father McGivney's intercession? Someone must report it. We cannot stress this enough. The only way for the Guild to learn about a possible miracle is for someone with knowledge of the case to report it to us. So, Knights, their families and anyone devoted to Father McGivney must be on the lookout for possible miraculous healings.

Pray

Next to consider is how a possible miracle would be attributed to Father McGivney's intercession. There must be positive evidence that people close to the event truly prayed **exclusively** to Father McGivney for the miracle. Again, therefore the Guild constantly urges prayer to Father McGivney, especially in cases of serious illness. When you know someone is facing a serious medical condition, start praying for a miraculous healing and ask family, friends and council members to do so too.

So, let's say we have an extraordinary physical healing of someone who prayed exclusively to Father McGivney (and Mary), as did all those close to him. We now have a strong case that is worth investigating.

Investigate

The initial investigation would be conducted by the vice postulator of the canonization cause in New Haven, who will interview people close to the case, including doctors. If there is a general sense that there is no apparent scientific or medical explanation for the healing and that Father McGivney was exclusively invoked, then the evidence will go to the cause's experienced postulator in Rome. If the postulator finds that the case is strong enough, he will send a request to the bishop of the diocese where the possible miracle occurred, asking him to form a tribunal to conduct an official inquiry into the case.

Tribunal

The diocesan tribunal is a formal ecclesiastical court, convened under the local bishop, that calls witnesses, gathers testimony, collects medical records and other supporting documents, and ultimately makes a judgment on whether to refer the case to the Congregation for the Causes of Saints. Once the case reaches the congregation in Rome, it is reviewed by experts in canon law, medicine and theology who meet in separate panels to examine and discuss the evidence and then vote whether to approve the case as a miraculous healing that involved the intercession of Father McGivney. The case would then go to a board of cardinals and finally to the Holy Father,

whose approval is needed for the acceptance of a miracle.

Join. Pray. Report.

The process is long and painstaking for good reasons. The Church does not want to declare as miraculous any event that may later be called into question. We hope and pray that a miracle will finally be attributed to the intercession of Venerable Michael McGivney. You can help the process with the simple formula: "Join. Pray. Report." Join the Guild. Pray the Prayer for Canonization daily. Report any extraordinary healings.

Together, we will move the cause forward.

Why We Offer Insurance

Two Problems, One Solution

The drive to offer financial protection for Catholic families comes from our venerable founder, Father Michael J. McGivney.

In the summer of 1873, as a young seminarian in Canada, he was forced to leave theological studies and return home to aid his family after the sudden death of his father, Patrick. "He was reeling," it says in his biography *Parish Priest*. "He packed his belongings, knowing that he would never return to Sainte-Marie, and went home."

"Money for tuition was no longer available," the authors continue. "Even if the McGivney family could survive without Michael's financial support, it was not clear that he could survive without help from them — or someone." Michael could continue his studies only after receiving a scholarship from the then-Diocese of Hartford.

Less than a decade later, as an associate pastor at St. Mary's Church in New Haven, Conn., Father McGivney was faced with an all-too-similar situation.

One of his parishioners, Edward Downes Jr., was forced to quit the seminary after his father died unexpectedly. He returned home to New Haven to support his mother and 12 siblings.

In those days, the court had the right to assign children to public institutions if it had reason to believe that their families could not properly care for and support them. Unless they were represented by a financially secure guardian in court, the teenage Downes boys would be removed from their family.

On Feb. 6, 1882 — the very same day as the first meeting for what would become the Knights of Columbus — Father McGivney appeared in court to stand as guardian for Edward's brother Alfred. The court accepted, yet Father McGivney was frustrated by the recurring nightmare of financial hardship.

"Even though he was only a young man," Parish Priest says of Father McGivney, "he was filled with a lifetime of anger and frustration at the sense of doom that settled over nearly every family that lost its wage earner. ... On the afternoon of February 6, he was more determined than ever that what had happened to the Downes family need not happen to anyone else."

The Mission Begins – And Continues

In that spirit, Father McGivney set off with "entrepreneurial zeal" to found the Knights of Columbus. In his own words, Father McGivney wanted the organization to "to unite the men of our Faith throughout the Diocese of Hartford, that we may thereby gain strength to aid each other in time of sickness, to provide for decent burial, and to render pecuniary assistance to the families of the deceased members."

He knew what life was like without that assistance. The initial system of "life insurance" designed by Father McGivney was a simple one, a pass-the-hat system through which each member could help support his brother Knights.

As the organization grew council by council, state by state, and country by country, so too did the insurance program. The pass-the-hat system was transformed into one of the largest and most highly rated life insurance programs in North America.

The Knights of Columbus has passed many milestones and received many accolades along the way: \$100 billion of life insurance in force, 40 consecutive A++ (Superior) ratings for financial strength from A.M. Best, 14 consecutive years of sales growth, and designation as a 2015 "World's Most Ethical Company," but all that is secondary.

What matters most is that we continue to fulfill Father McGivney's mission of offering and providing financial protection for Catholic families. 2015 is not 1882. Times are different. Laws are different. Economies are different. But even for those families who may have slightly more than next-to-nothing, insurance protection can be the difference between getting by and getting evicted. In its role as the premier Catholic life insurer, the Knights of Columbus continues to provide a valuable and noble service.

That's why we offer life insurance

It's not for the \$8 billion in annual sales volume, or the \$100 billion in force, or the 2 million policies on the books. It's not the amount that counts, but the impact of those dollars.
