Whats new in November...

This year Art Maher is the chairman responsible for the **Campaign for People with Intellectual Disabilities** drive. During October we will have at least one weekend in which we need volunteers to help raise money and hand out candy at Kentucky Oaks Mall. I've added an excerpt from the KOC webiste detailing the fundraiser.

“Campaign for People with Intellectual Disabilities”

One of the most popular and successful programs conducted by Knights of Columbus state and local councils for the benefit of people with intellectual disabilities is the fund-raiser in which councils collect donations outside stores and on street corners. In appreciation, the donor is offered a candy bar, often a Tootsie Roll. The high visibility of this program has led to the campaign being referred to as the “Tootsie Roll Drive.”

The nickname is understandable, but

misleading.

The Knights of Columbus has no official tie to Tootsie Rolls or their manufacturer. In fact, many councils participate in the same fund-raising drive, but distribute other items. References to this program should highlight the good the money does, not advertise a candy bar. **For these reasons, it is strongly recommended that this project be promoted as the “Campaign for People with Intellectual Disabilities” rather than the “Tootsie Roll Drive.”**

The 4th Degree Knights of Columbus, Father John Fallon Assembly 312 of Paducah is hosting two fundraisers for the Ft. Campbell, Kentucky, Little Soldiers/Holiday House Christmas Program. Donations and funds raised will be designed to help children of the 101st Airborne to receive gifts for this Christmas season.

The Knights will be serving tables from 5PM to close each night. The event dates are Tuesday Oct. 13th and Tuesday Nov. 10 at El Tequila Restaurant, located at 1407 East 5th Street, across from Ft. Massac in Metropolis, IL .

St. Mary's is having their bi-annual fundraiser the first Saturday in November, which is November 7th. Unfortunately some of us are going to be in Clarksville for the 4th degree exemplification but if anyone is in town and available, I know that the St. Mary's school system will appreciate the support.
