Every year in October, the Knights across the State of Missouri band together to raise money for those with Developmental Disabilities, by providing Tootsie Roll candy for donations. The proceeds collected each year are divided 50/50 between the local council deciding what organization should receive their funds (last year we gave our funds to Special Olympics) and the State KofC Council that funds the Knights of Columbus Developmental Center at SSM Cardinal Glennon Children's Medical Center in St. Louis.

The Knights of Columbus Developmental Center provides examinations, assessments and referrals for medical consultation for children with a number of developmental disabilities. The Center was opened in 1981, and is dedicated to treating children with access to a wide range of specialties.

We are asking every Knight to donate just two hours of your time that weekend as we expand our program to area businesses in addition to collecting after all our Masses.

## "SO, YOU'RE THINKING OF INVESTING"

Some facts to consider before you make your investment:

- 1. Make sure your investment is placed beyond the reach of your creditors and those of your beneficiaries - a judgment proof investment.
- 2. Make sure that the value of your investment at death will not be subject to probate cost, legal fees and usual delays of court proceedings a probate proof investment.
- 3. Make sure that your investment guarantees that principle and interest will always be available in the amounts and in the installments called for and that the investment will never go sour regardless of downtrends in the economy a depression proof investment.

- 4. Make sure that your investment guarantees that you can always borrow 95-100% of the value as stipulated in your investment without delay or requirement of cosigners.
- 5. Make sure that, as your investment appreciates each year, the gain will not be subject to federal income tax a favorable tax investment.
- 6. Make sure your investment contains a clause which guarantees that proceeds payable upon your death will be delivered entirely free of income tax liability for your beneficiary.
- 7. Make sure that your investment contains a clause which guarantees that your investment program will stay intact and continue to grow even though you are unable to continue to work and earn as a result of total and permanent disability a guaranteed investment.
