And it is particularly saddening when I learn that some of these Knights did not have Knights of Columbus insurance. Most of them had some sort of insurance, and that is good. Yet the benefits of the Knights of Columbus insurance go way beyond the monetary benefit. Please read this. The major benefit of having an insurance policy or an annuity with the Knights, is that besides having excellent rates, your family gets the benefit of having a Field Agent to help the family with the processing of paperwork, helping with arrangements and knowing how to traverse the many decisions the surviving family members have to make. When you pass on to your heavenly reward, your family has to deal with your loss and make a lot of decisions regarding your viewing, funeral mass, burial, filing for insurance benefits and veterans benefits. Also, if the Knight was a military member, policeman, fireman or first responder who died in the line of duty, his children may be eligible for scholarships. These are important decisions that come at a very devastating time. Our, YOUR Field agents are trained and have years of experience in dealing with assisting the Knights families. Also know that if you do not have a K of C insurance policy or annuity, there is very little the Field Agent can do for your family.

If you think you have it all planned with an insurance policy outside of the Knights, please re-think this and consider taking out even the most modest K of C policy or annuity so that the Field Agent can assist your family in their time of grief. See the Field Agent's article for more

As Catholic gentlemen, prayer is (or should be) a big part of our daily lives; and a large part of that is remembering our Brother Knights, their families, and others who are sick, suffering, or who have passed away.

Our new website (www.kofc10947.org) offers Brother Knights the opportunity to submit Prayer Requests, anonymously for all Brothers to view and consider as we go through our daily prayer rituals. It's an electronic form of the Prayer Book that so many Councils maintain.

Once you post a Prayer Request (instructions below), it remains on the site for 30 days as a reminder that someone in our midst is in need of our spiritual assistance.

To submit a prayer request, you need only your Member Number (found on your Council membership card) and your password – which is always your

birthday.

After opening the Council Website, click on Prayer Requests (the third item on the left-hand side of the site) then click on the SUBMIT YOUR PRAYER REQUEST button, then enter your member number, password (mmddyyyy) and click SUBMIT. On the next screen, enter the person or persons for whom you want to offer prayers, and then click in the larger window and (if necessary) type the reason you are requesting prayers for that person. Scroll down, click submit and voila! You've submitted a Prayer Request.

On the main Prayer Request screen, by the way, you can also print the current Requests so that you can take them with you to a church or quiet place away from technology...

4th Degree Exemplification October 26th -Preliminary Information

The Exemplification will take place on October 26, 2013 at the Cavalier Hotel in Virginia Beach. The Master of the Calvert District has blocked off 200 rooms for Friday and Saturday night and additional rooms for Thursday and Sunday night for folks who want to spend additional nights. The special rate for the Knights of Columbus is \$99 plus taxes. Reservations can be made by calling the hotel and requesting the special Knights of Columbus rate. The telephone number is 1-757-425-8555 or 1-800-446-8199. Again, make sure everyone registers as a member of the Knight of Columbus. Navigators and candidates are encouraged to register as soon as possible as there are two other groups using the hotel facilities that weekend. Reservations must be made as soon as possible but no later than October 12.

With regard to Exemplification costs:

Candidate costs are set by Supreme (there has been no change): They are \$70 and it includes the banquet ticket. Clergy is \$60.

Ladies Luncheon and Program: Cost is \$25 and includes choice of seafood or chicken salad croissant, fruit, and potato salad.

Banquet: Cost is \$50 and the entrée menu choices are: Beef Strip Steak, Dijon Encrusted Chicken Breast, and a Mahi Mahi fish selection. Dinner includes a chef's choice salad, rolls, butter, potato, vegetable, dessert, iced tea, coffee, etc.

The Prodigal Son

Recently, we heard the parable of the prodigal son. In my opinion, this is the richest parable that Jesus gives us, each detail important to the lessons that are being taught.

At the start of the parable, the younger son asks for his share of the estate. This passes so quickly that it's easy to miss exactly what is being asked for. The father's estate would only come to his sons when he died.

The younger son is as good as wishing his father was dead in his greed.

He takes all that was given to him and spends it on a life of dissipation, leaving him nothing when a famine strikes. The fair-weather friends he made have deserted him now that his money is gone. It is when he realizes that in the eyes of those around him, he is of less value than the swine which he feeds (unclean animals to the Pharisees to which this parable was addressed), that he realizes the depth of the mistakes which he has made.

He practices his speech as he returns home. He identifies that he has sinned. He recognizes his own unworthiness, and asks for a small measure of forgiveness. When he sees his father, he begins to say what he has planned to say, but his father cuts him off before he can finish. The father's forgiveness is total, far beyond what the son had expected and what almost any of us would say that he deserved. Certainly, the older son felt that way, and his refusal to come to the celebration was enough to bring the father outside to plead with him.

The older son has followed his father and been a good son, but with the return of his brother, everything has been up-ended. We don't know what is in his heart, though his words give us some clues. He focuses on his hard work in contrast to his brother's life of pleasure. In essence, he asks "Don't I deserve more?" Could it be that he is envious of his brother, who seems to enjoy all the privileges of being the son of a wealthy man with none of the work? In the back of his mind, might he be thinking "He already got his share of the estate; what remains is mine." and thereby commit the exact same sin that his brother already made? But perhaps it is hurt feelings, a mistaken belief that his father does not love him, or loves him less than his brother. And so the father comes out to reassure him of his love, and asks him to come and make the family whole again.

The striking thing about this parable is how open-ended it is. The prodigal son doesn't even get a chance to finish his speech before he swept up into a celebration of his return. When the father pleads with his older son, we don't hear the response. In a sense, it allows us to step into both sons' roles.

The younger son:

When we sin, we take the God-given gifts of our bodies and minds and use them to mean end. Our inheritance is eternal life with God, and it is squandered when we turn away from Him. We see how to seek the gift of forgiveness — with a humble heart, mindful of our failures and aware of our unworthiness. We see the mercy of God and how he rejoices when we return to him. We

his humility; may we hold onto ours.

see that in sin, we are as if dead, and that returning to sin is returning to death, and therefore to be avoided at all costs. We do not know if the younger son held onto

The older son:

It is easy for us to compare ourselves to others and say "See, I'm not as great a sinner as they are". We envy the empty pleasures they felt, in contrast to our own lives. We hold past sins against others, and wonder if they are sincere in their repentance. In doing so, we fall into the vice of pride, the root of all sin. If God can forgive them, who are we to do otherwise? Unlike the father's estate in the parable, God's mercy is infinite. It does no harm to us if all sinners return to God; on the contrary, it builds us up into a greater whole, a community of believers, an example to all the nations. We do not know if the older son joined in the celebration; may we rejoice as God does when sinners repent.

Organ Donation

(The following was presented as a lecture by our Worth Lecturer, James Auwaerter, PGK at our business meeting on October 1, 2013)

We've all seen the bumper stickers which say "Don't take your organs to heaven – heaven knows we need them here." But what does the Catholic Church have to say about organ transplants?

It's important to remember that organ transplantation is relatively new, only having been regularly successful since the 1950s. The good news is that organ transplants from a deceased donor pose no moral concerns, beyond the informed consent of the donor-to-be or his or her next of kin, and of course, the assurance that a potential donor is not "left to die" in order to harvest organs. The Catechism is clear that "[i]t is morally inadmissible directly to bring about the disabling mutilation or death of a human being, even in order to delay the death of other persons" (#2296).

Organ transplants from one living patient to another pose a greater moral concern. Theologians debated how the principle of totality should come into effect. The principle of totality relates to what constitutes mutilation of the body – for example, amputating a gangrenous limb preserves the totality of life, while amputating a healthy limb would be mutilation. One side of theologians held that the removal of a healthy organ and potential health problems that might occur constituted mutilation. The other side argued from the perspective of fraternal charity, making a sacrifice to preserve life as Christ commanded us at the Last Supper ("There is no greater love than this: to lay down one's life for one's friends." -John 15:13). From this perspective, the risk of harm to the donor can be weighed against the potential good to the recipient. The principle of totality, rather than applying strictly to the body's structure, could instead be applied to the body's function. So while a kidney could be

donated with little loss of function, the donation of an eye would still violate the principle of totality.

Pope Pius XII agreed with the latter group of theologians, a position repeated by Pope John Paul II. The conditions put forth for a morally valid donation are the following: (1) the risk to the donor must be proportionate to the good achieved, (2) the removal of the organ must not seriously impair the donor's health or bodily function, (3) the prognosis of acceptance by the recipient must be good, and (4) the donor must make an informed and free decision, recognizing the potential risk.

"Informed and free", by its nature, includes no monetary compensation for the donation. Doing so threatens to eliminate the fraternal charity that is the foundation of living organ donation, and implies that those who have more money deserve better access to transplants. Instead, donation should be based first and foremost on prognosis of acceptance of the organs.

As an aside, xenotransplants (transplants from nonhuman species) are permitted by the Church, so long as the transplant is expected to work (having a record of success in general, and is not unduly risk for the recipient) and does not impair the genetic or psychological integrity of the recipient.


Respect Life Month
