Upcoming Charity Street Collection

Charity---the first principle of our order, was it the reason you joined the Knights? Is it the reason you are a member today? Are you a worker in any of our council's charity programs? Yes or no, here is what you should do, work a shift during our after Thanksgiving charity street collection on November 26-27th.

This is our most important annual project. It helps so many people that need help. It is what I call new money. Money from other people—not money from parishioners or the Knights. Also, it is the most productive per hour time spent on any of our projects. Last year the average income per worker per shift was a little over \$250.00. That means that each of my brother Knights that work a shift this year should collect approximately \$250.00 toward the \$10,000 that we want to reach this year. So you see, we need 40 or 50 to work the street the Friday and Saturday after Thanksgiving. This is an all council project—not just a few of you.

Brother Knights, do not ignore my asking each of you to work a shift. You will be proud of yourself and the council for this charitable work. Going out of town or unable to physically work the street, fine, you have a choice either write a check for \$250.00 or recruit a brother Knight to work in your place. Please inform me of anyone you recruit so I can assign them a time slot on Friday or Saturday.

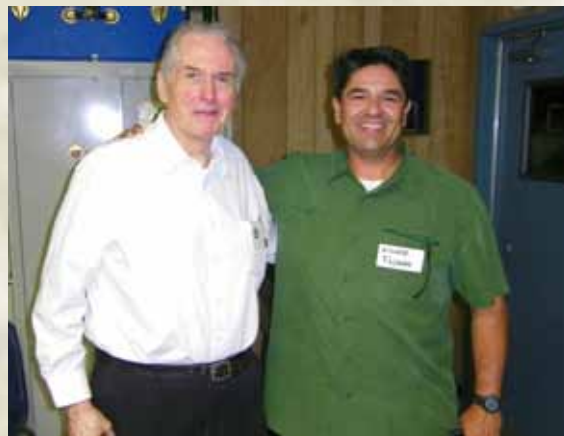

I _____ am over the age of 18 years of age and, have upon my own free will, requested a permit to solicit for charitable contributions upon the public streets and roadways of the City of Denton, Texas under the provisions of Section 25-5 of the Code of Ordinances of the City of Denton, Texas. I fully understand the possible dangers of this endeavor and assume all such risks by entering into this release and indemnification. If the undersigned is an officer or employee of the City of Denton, I fully agree and understand that in performing such solicitation activities upon the public streets, I am not acting within the course and scope of my employment with the City of Denton. I am soliciting contributions on behalf of KNIGHTS of Columbus Council 12553, which I represent and warrant to be a charitable organization.

I fully understand that the City of Denton, Texas may legally prohibit any such solicitation upon the public streets, pursuant to State law and City ordinance, absent my execution of this document. I further understand that the City of Denton, Texas is not a sponsor of the charitable organization for which I am soliciting, and that the granting or refusal of a charitable solicitation permit does not constitute either an endorsement or condemnation by the City of Denton, Texas or its agents, officers, servants, successors, assigns, sponsors, volunteers, or employees of this charitable organization or its stated or unstated mission or missions.

As a condition of, and as consideration for this permit, I voluntarily and knowingly execute this release and indemnification with the express intention of effecting the extinguishment of any and all future claims against the City of Denton, Texas, its officers, employees, agents, successors, assigns, sponsors and volunteers assisting in City activities, which may result from my participation in this endeavor.

I, with the intention of binding myself, my heirs, executors, administrators, and assigns, do hereby expressly release and discharge, all claims, demands, actions, judgments, and executions which I ever had, or now have or may have, or which my heirs, executors, administrators, or assigns may have, or claim to have, against the City of Denton, Texas, its agents, officers, servants, successors, assigns, sponsors, volunteers, or employees, created by, or arising out of personal injuries, known or unknown, and injuries to property, real or personal, worker's compensation, or lost wages or benefits, caused by or arising out of, any sequence of events which may occur from the agreement as herein designated

above, or which may arise directly or indirectly from the performance of or created by or arising out of my participation in this endeavor or this indemnity agreement AND INCLUDING, WITHOUT LIMITATION, CLAIMS AND DAMAGES ARISING IN WHOLE OR IN PART FROM THE NEGLIGENCE OF THE CITY OF DENTON, TEXAS, ITS EMPLOYEES, AGENTS, OFFICERS, SUCCESSORS, ASSIGNS, SPONSORS, AND VOLUNTEERS.

Furthermore, I agree to indemnify and hold harmless the City of Denton, its officers, agents, servants, employees, successors, assigns, sponsors, or volunteers from any liabilities or damages I may suffer as a result of claims, demands, costs, or judgments against the City of Denton and/or its officers, agents, servants, or employees, created by, or arising out of the agreement herein designated above and from my participation in this endeavor. If the City of Denton and/or its agents, officers, servants, employees, successors, assigns, sponsors, or volunteers in the enforcement of any part of this indemnity agreement, shall incur necessary expenses, or become obligated to pay attorney's fees or court costs, I agree to reimburse the City of Denton, Texas and/or its agents, officers, servants, employees, successors, assigns, sponsors, or volunteers for such expenses, attorney's fees, or court costs within thirty days after receiving written notice from the City of Denton and/or its agents, servants, employees, successors, officers, sponsors, assigns, or volunteers of the incurring of such expenses, costs, or obligations.

Additionally, I shall fully defend, protect, indemnify, and hold harmless the City of Denton and/or its agents, officers, servants, employees, successors, assigns, sponsors, or volunteers from and against each and every claim, demand, or cause of action and any and all liability, damages, obligations, judgments, losses, fines, penalties, costs, fees, and expenses incurred in defense of the City of Denton and/or its agents, officers, servants, or employees, including, without limitation, personal injuries and death in connection therewith which may be made or asserted by myself, my agents, my successors, my assigns, the charitable organization, or any third parties on account of, arising out of, or in any way incidental to or in connection with the performance of this agreement and from my participation in this endeavor, INCLUDING, BUT NOT LIMITED TO, CLAIMS AND DAMAGES ARISING IN WHOLE OR IN PART FROM THE NEGLIGENCE OF THE CITY OF DENTON, TEXAS AND/OR THE PARTIES TO THIS AGREEMENT. IT IS UNDERSTOOD AND AGREED THAT THE INDEMNITY PROVIDED FOR IN THIS SECTION IS AN INDEMNITY EXTENDED BY ME TO INDEMNIFY AND PROTECT THE CITY OF DENTON, TEXAS AND/OR ITS AGENTS, OFFICERS, SERVANTS, OR EMPLOYEES FROM THE CONSEQUENCES OF THE NEGLIGENCE OF THE CITY OF DENTON, TEXAS, AND/OR ITS AGENTS, OFFICERS, SERVANTS, OR EMPLOYEES, WHETHER THAT NEGLIGENCE IS THE SOLE OR CONTRIBUTING CAUSE OF THE RESULTANT INJURY, DEATH, AND/OR DAMAGE.

I further authorize the City of Denton, Texas or any other City employee or agent to secure medical care for me in the event of injury. I promise to assume liability for payment, and hold harmless the City, its officers, employees, sponsors, volunteers, or agents, of medical expenses arising from said medical care for said injury.

I, the undersigned, have read this release and indemnification and understand all its terms. I execute it voluntarily and with full knowledge of its significance.
