

- 5. Volunteers spoke up about supporting the raffle locally but reminded the Council that their jobs comes first.
- 6. An overall chairman would be needed.
- 7. t was decided to poll the Council by US Mail, request commitments for team participation and have a special meeting to reveal the results and make a decision.
