In 1882, when Father McGivney began our organization, his primary concern was the care of widows and orphans. Even though 130 years have passed, we should never forget his mission. Last month we talked about widow benefit. This month it's a benefit that most don't think about.

As you can imagine, we gets lots of correspondence at the Supreme Council Office, but every now and then a letter or email stands out from the rest. That is what happened when the widow of a member wrote us.

While the name of the person writing has been changed to protect her privacy, the letter appears nearly word for word. This is what she said:

Dear Supreme Knight,

When my husband became a Knight, we were introduced to our insurance agent, Mike Walther. We could sense right away that he thought of his career as more of a 'ministry' than a sales position. Little did I know then how much his sense of ministry would mean to me.

During our meetings, we weren't easy to persuade. Never willing to give up, Mike worked to show us that we had a need, and he was able to help us understand the value of being protected with life insurance.

My husband died suddenly last fall. His death was a shock to everyone. Although from a medical standpoint it shouldn't have happened, I guess God felt his work on Earth was done. Mike was there for me imme-

diately. He was at the wake and the funeral, and then stayed by my side and helped with whatever I needed. He cried for my husband just like I did

I think that in this world where everyone is focused on the bottom line, I saw what the Knights are truly about. They were there for me when I needed them the most.


Father Michael J. McGivney, Founder of the Knights of Columbus

On Oct. 2, 1881, a small group of men met in the basement of St. Mary's Church on Hillhouse Avenue in New Haven, Connecticut. Called together by their 29-year-old parish priest, Father Michael J. McGivney, these men formed a fraternal society that would one day become the world's largest Catholic family fraternal service organization. They sought strength in solidarity, and security through unity of purpose and devotion to a holy cause: they vowed to be defenders of their country, their families and their faith. These men were bound together by the ideal of Christopher Columbus, the discoverer of the Americas, the one whose hand brought Christianity to the New World. Their efforts came to fruition with the incorporation of the Knights of Columbus on March 29, 1882. They were Knights of Columbus.

Father Michael J. McGivney was an assistant pastor at St. Mary's Church, when he founded the Knights of Columbus in 1882. Father McGivney's holiness, devotion to priestly ministry and work to protect family life

provide a powerful spiritual influence for Knights, their family members and a growing number of other Catholics.

The cause, or process, for Father McGivney's sainthood, was opened by Hartford Archbishop Daniel A. Cronin, in December 1997. The cause was presented to the Vatican in 2000, where it has been under review by the Congregation for the Causes of Saints. With the authentication of a miracle at Father McGivney's intercession, the priest could be beatified. A second miracle would be required for canonization. On March 15, 2008, Pope Benedict XVI approved a decree recognizing the heroic virtue of Father Michael J. McGivney. The pope's declaration significantly advances the priest's process toward sainthood and gives the parish priest the distinction of "Venerable Servant of God."



Prayer for the Canonization

God, our Father, protector of the poor and defender of the widow and orphan, you called your priest, Father Michael J. McGivney, to be an apostle of Christian family life and to lead the young to the generous service of their neighbor. Through the example of his life and virtue may we follow your Son, Jesus Christ, more closely, fulfilling his commandment of charity and building up his Body which is the Church. Let the inspiration of your servant prompt us to greater confidence in your love so that we may continue his work of caring for the needy and the outcast. We humbly ask that you glorify your servant Father Michael J. McGivney on earth according to the design of your holy will. Through his intercession, grant the favor I now present (here make your request). Through Christ our Lord. Amen. Our Father, Hail Mary, Glory be.
