In the process of coming to the rescue of her friend, Jerica was knocked over by the other boy. When I questioned her about the incident, she seemed happy to have been able to come to the aid of her friend. Lesson #2 – Stand up for the little guy and never be a bully. In life we have too many cruel individuals. On a daily basis, strive to be a thoughtful and compassionate person.

As many of us do, my daughter has quite a sweet tooth. If she spies me eating a piece of cake, she will crawl into my lap and give me the most innocent look and say, "It's good to share." Lesson #3 – Share your blessings with others. Maybe what you share is your time by going to visit a friend that you haven't seen in a long time. Maybe what you share

is a prayer with a friend who just lost someone they love. Maybe what you share is a piece of cake with your adorable daughter. Whatever you share with others will bring goodness into your life and theirs.

Chaplain's Message **Be Merciful:** **Instructing the Ignorant and** **Giving Drink to the Thirsty**

Brother Knights:

As I am mentioned in my last article, the Church depends very much on organizations such as ours to be on the "front lines" of demonstrating and witnessing to the Catholic faith. This is especially true of the Works of Mercy. The Knights of Columbus can and must always demonstrate these both as individuals within the community and as Catholic fraternal organization.

The second Spiritual Work of Mercy is: "Instructing the Ignorant." Ignorance in this context of course, is different from our normal understanding of ignorance. It has nothing to do with people who do not behave well socially or who find it difficult to learn things academically. The kind of ignorance this work of mercy addresses is a spiritual ignorance, an ignorance of truths that one must know to save their souls.

The work that we do as Brother Knights lends itself to responding to this work of mercy in a very direct way. We must be as it were, a moral and spiritual compass within the Church and within society. When we reach out to those who have been scandalized away from the Church or for some reason have withdrawn from

the community of faith, we must demonstrate to them how important it is to receive the Sacraments; especially Reconciliation and Eucharist. We must also be vigilant with issues such as protecting human life. We must encourage and lead others to Baptism and catechize others as the situation calls for in the ways of the faith.

When scandal has impacted itself upon the Church, we must help others understand the difference between the Church as the mystical Body of Christ and Her members who individually are wounded by sin. In short, we must do all we can to ensure that others both within and outside our community of faith are lead to know, love, and serve God in this life so that they can be happy with Him in the next.

The importance of prayer, Mass, and of course devotion to Our Lady have a rightful place in instructing the ignorant as well.

The second Corporal Work of Mercy is "Giving Drink to the Thirsty". This seems like a "no-brainer", but it is nonetheless an act of charity that brings refreshment to a person and thus a weary soul.

What is said of "feeding the hungry" also applies to drink. Whether it is offering a stranger or neighbor a drink on a hot day, giving a baby its bottle, helping to provide drinks at the dinner table, refreshing those who visit us, or simply helping a small child or elderly person get a drink from a water fountain, it is a simple and practical act of kindness that pleases our Lord because it satisfies a physical need of others and brings them refreshment. Christ himself sought this work of mercy (*cf. John 4:7 and John 19:28*).

How we instruct the ignorant or when we are able to provide refreshment to the thirsty depends of course on the situation in which we find ourselves. But we will always be able to recognize them with the help of the Holy Spirit as well as Mary, Mother of Mercy and Star of the Sea.

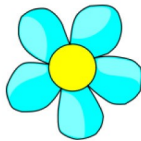
