Last month I talked about the "House that Ruth Built "I don't know if anyone is aware that the Knights of Columbus were the owners of the land that Yankee Stadium stood on from 1953 to the mid 1970's. During the time that the Knights owned the land, Yankee stadium hosted the All Star Game only once, on July 13, 1960.

That day more than 38,000 fans went through the turn stiles to see Willy Mays, Hank Aaron, Mickey Mantle, Roberto Clemente, and all the other baseball stars, a total of 17 future Hall of Famers. The National League won the game, 6-0.

The Knights of Columbus was able to buy the nine acres beneath "The House that Ruth Built" as part of the Order's Lease Back Investments. According to then Supreme Knight, Luke Hart, the Knights met with the Bankers Trust Company and wrote a check for \$2,500,000.00. Hart wrote in his diary that it was the largest check he has ever signed. The Knights ownership ended when the city of New York decided to renovate the stadium in the mid 1970's and acquired the property by eminent domain. Supreme Knight Virgil Dechant said "It was not our wish to sell it, but we had no choice". My research could not find the selling price.




