### Chaplain's Message

## **The Faithful Departed**

Brother Knights:

In the 31 years that I have been a Priest, I have found that one of the most frequently misunderstood teachings of the Church by the faithful, as well as non-catholics, is without question, the teaching of Purgatory. The misunderstandings range anywhere from confusing it with "limbo" to some sort of a "third option" when we pass from this life. Fortunately for us, neither is the case. That is a good thing.

A more theological treatment of Purgatory, as well as the scriptural basis for it, is given in the Catechism of the Catholic Church, Numbers 1030-1032.

Actually, Purgatory is not a very complicated dogma of our faith. Unlike Heaven or Hell, Purgatory is not eternal. It is temporary. It is not a place so much as it is a process of purification that is experienced by those who will eventually enter Heaven, but must first be cleansed of imperfections and transgressions which they incurred in this life, not sufficient to put them in Hell. The Church refers to this as temporal punishment, or punishment for a time. The anguish, the longing, the intense desire to finally enter eternity with our Lord is the "punishment" that is being referred to.

So, how can we help the faithful departed? We can do so by lessening that time of purification, that time spent in Purgatory. We do this by prayers and good works on their behalf. We remember them daily and every time we participate in Mass. We offer Masses for them. It is never a frugal or ineffective thing to pray for the faithful departed. If they have already entered into the Kingdom of God, others will benefit from our prayers and good works; especially those who have no one to pray for them, or those to whom we refer to as: "the poor souls in Purgatory".

During this month of November particularly, the Church asks us to focus on the faithful departed. We celebrate those we believe to be in the presence of God by the lives they lived on this earth on November 1<sup>st</sup>, the Feast of All Saints. We remember those who are in Purgatory—particularly those who have no one to pray for them—on November 2<sup>nd</sup>, the Commemoration of All Souls.

As Knights we give tremendous witness to our belief in a merciful and loving God by remembering in our thoughts, words, and deeds "...those who have gone before us marked with the sign of faith." May all the souls of the faithful departed, through the mercy of God, rest in peace. And may all those who have gone before us be assisted by our prayers and the intercession of our patroness and mother—Mary, Star of the Sea.

Later on in my life I met and married a beautiful loving wife of 9 years as of yesterday. I can clearly remember our 3<sup>rd</sup> date when I told her I had MS and her response was "Oh is that all", at that point I knew she was the girl for me. Throughout the years I've run into countless friends who've accepted me "As I Am" and that includes the members of this council who helped me with fundraising, awareness and probably the most beautiful memorial service I ever attended

which was for my service dog Painter. Each and every one of you have accepted me "As I Am" and that is why I say having MS is a blessing not a sentence".

So what am I driving at? I'm not up here trying to just talk about myself when I say "As I Am". As brother knights and catholic gentleman we should strive to accept each and every person just as they are no matter what the issue. In fact it is one of the main reasons I joined the Knights and because of our core values".

So as I wrap this up some of you are aware of my foundation and maybe some not, but that is not what I'm up here to promote. Some of you and again some not, aware of the musical CD I was a part of writing about my MS, again not what I'm trying to promote, but then well than again sort of. ## Chaplains Summation:

Father read and discussed an article entitled "Guardian Angels" by Father Damian Towey, CP. October 2, 2014 is the feasts day of Guardian Angels.

I guess that a lot of people think that guardian angels rank right up there with Santa Claus and the tooth fairy – fine for children, but not for grownups. And yet Saint Thomas Aquinas, a Doctr of the Church, thinks otherwise. He is known as the Angelic Doctor for the considerable amount of space he devotes to angels in the Summa Theologica. He certainly believed that God assigns a guardian angel to each person - and he cited today's gospel passage as proof that on our behalf, this angel prays for us and protects us from evil. (Mt 18:10).

Angels are pure spirits and exalted beings. And yet they are like children! What other type of being exerts a greater pull on our heartstrings than a child? "Guardian Angel" could be a grim concept, conjuring up the picture of a stern-faced prison guard. Instead our Guardian Angel remains forever the companion with whom we shared a seat in the First Grade. That is appro-

priate, for angels are the ministers and representatives of the One who made himself a child

so that we might better comprehend the true nature of God, a nature that is lovable, approachable, unpredictable, full of surprises..... The late Saint John XXIII was a great believer in his Guardian Angel. When he had a meeting scheduled where there was likely to be a conflict, he would ask his Guardian Angel to precede him and in conjunction with the other party's angel smooth the way for a more successful dialogue. That's a practice we might consider adopting.

And when our lives come to completion may we be laid to rest with the beautiful prayer of the Church: "May the angels lead you to paradise; may the martyrs welcome you and take you to the holy city, the new and eternal Jerusalem" (Rite for Christian Burial)
