Chaplain's Message

"The Month of October in the Year of Faith"

Brother Knights:

As the Year of Faith draws to a close next month, the month of October is especially important to us as Knights of Columbus. It is of course, the month that we observe the celebration of our namesake—Christopher Columbus. But October is also regarded as a Marian month (cf. Our Lady of Fatima apparitions of October 13). It is also considered the month of the Rosary (October 7).

The official Year of Faith schedule issued by the Vatican designates October 13 as a day of special importance and celebration for the Year of Faith.
