One Nation Under God

On 8 Feb, 1954, U. S. Rep. Charles Oakman from Michigan introduced a Joint Resolution (H. J. Res 371) to add the words "Under God" into the pledge, explaining:

Mr. Speaker, I think Mr. Docherty hit the nail squarely on the head. One of the most fundamental differences between us and the Communists is our belief in God.

Two days later, on February 10th, Senator Homer Ferguson from Michigan introduced the Senate Joint Resolution (S.J. 126), explaining to the Senate:

Our nation is founded on a fundamental belief in God, and the first and most important reason for the existence of our government is to protect the God-given rights of our citizens. . . . Indeed, Mr. President, over one of the doorways to this very Chamber inscribed in the marble are the words "In God We Trust." Unless those words amount to more than a carving in stone, our country will never be able to defend itself.

Dwight D. Eisenhower: "Statement by the President Upon Signing Bill To Include the Words "Under God" in the Pledge to the Flag.," June 14, 1954.

"FROM THIS DAY FORWARD, the millions of our school children will daily proclaim in every city and town, every village and rural school house, the dedication of our nation and our people to the Almighty. To anyone who truly loves America, nothing could be more inspiring than to contemplate this rededication of our youth, on each school morning, to our country's true meaning.

Especially is this meaningful as we regard today's world. Over the globe, mankind has been cruelly torn by violence and brutality and, by the millions, deadened in mind and soul by a materialistic philosophy of life. Man everywhere is appalled by the prospect of atomic war. In this somber setting, this law and its effects today have profound meaning. In this way we are reaffirming the transcendence of religious faith in America's heritage and future; in this way we shall constantly strengthen those spiritual weapons which forever will be our country's most powerful resource, in peace or in war."

Our Bishop Most Reverend Mitchell Rozanski and Parish Priest on his left Father Jim Proffitt

Wherever he went it was "long enough for the people to love him"

Bishop Mitchell Rozanski came to St. John the Evangelist in May 2000 for the funeral mass for our long time pastor Monsignor Edward Staub. At this time our parish was undergoing extensive renovations and the story goes that a fellow priest said to him "I pity the sucker who has to come here". As you know Bishop Rozanski became our next pastor! He spent four years here and left a lasting impression.

Bishop Rozanski was born and raised in Baltimore, grew up in this archdiocese, went to school here, and became a priest in 1984. His first assignment as priest was at St. Michael the Archangel in Overlea. His decision to become a priest started when, as a boy of twelve, he began attending mass at Sacred Heart of Mary in Graceland Park. He stated that he was very impressed by the priests devotion to the people and how much joy they showed in being a priest. He served as altar boy and lector and also worked in the rectory. During his freshman year at Mount Carmel High School he wrote to the archdiocese asking about the priesthood. The reply was to come back after he had finished high school. When asked by his mom what his college plans were he replied "Mom, don't worry about it. I know what I am going to do. It will be taken care of."

Did you know he was the first Polish-American Bishop in Baltimore and he will be the first Polish-American Bishop in Springfield? He thought it would be good to have Priests that could speak in Spanish for the Latino communities. He even took Spanish lessons so he could say mass in Spanish. He was a supporter of the DREAM act. The motto on his coat of arms states "Serve the Lord with gladness" but I think Father Jim sums him up the best when he said "He was here less than four years, but long enough for the people to love him". 



Victory at the Supreme Court

On June 30, the United States Supreme Court, in a 5-4 decision, ruled in the case of *Burwell v. Hobby Lobby* that closely held for-profit corporations cannot be required to provide contraception coverage. The Court found that the mandate as applied violates the Religious Freedom Restoration Act of 1993. Since the justices found that the mandate "'substantially burden[s]' the exercise of religion" and that there are easier ways to achieve the same objective, it to not have to rule on whether the mandate serves

a compelling government interest and whether assuring women's access to contraceptives is a common

good.

This was a narrowly structured decision, and does not affect the suits brought by Priests for Life and Little Sisters of the Poor, as well as by religiously-affiliated hospitals, colleges, and charities, which are still to be decided when the Court resumes in October. The Hobby Lobby case has immediate implications for the 2016 election. Two of the justices in the majority are 79-years old (Antonin Scalia and Anthony Kennedy) and one justice in dissent is 81 (Ruth Bader Ginsburg). If all three justices continue in office for the next two years, the next president will likely replace all three—and thus have long-term implications for the nation.

The Demise of Abortion Clinics

Operation Rescue reports that so far this year, preliminary numbers indicate that twelve surgical abortion facilities have closed along with six medication abortion clinics and five abortion referral centers. More are expected to close as new abortion laws in several states, such as the requirement that

abortionists maintain local hospital privileges, go into effect. Last year, a record number of abortion facilities shut down, including 87 surgical centers and six that offered only medication abortions. For the full story.

Presently, nationwide there are 577 surgical abortion clinics, 177 abortion pill clinics, and 839 abortionists. Of these, 19 abortion clinics and at least 17 abortionists are operating in the Maryland,. To
