Political Science, he took a job working for then-Congressman Tim Penny. However, he

took a leave of absence from his job in the Congressional office to enter the seminary in Winona before taking four more years of theology studies at the University of St. Thomas. He was ordained in 1995 and assigned to his home parish of St. Pius in Rochester. After three years, he moved to Winona to become Parochial Vicar at the Cathedral of the Sacred Heart and Immaculate Conception, Wilson. He also served as Chaplain for Winona State

University. However, that hunger for more knowledge pulled him back to study in 2000 at Catholic University of America. He received his degree in Canon Law in 2002 before returning to serve as Pastor of parishes in Rollingstone and Minneiska, Minn. However, Fr. Mike took a leave of absence in 2005 after a series of three heart attacks. He returned to Washington, DC and worked in the US House of Representatives office of the Inspector General. Fr. Mike was called back to work in the priesthood in 2011 at the Cathedral in Winona until getting assigned to Sacred Heart in Owatonna in July 2012.

Fr. Mike joined the Knights while still a sophomore in Collegeville. He said he joined because he always had an affinity for the organization. "My father was a member of the Fourth Degree, so I had a lot of exposure to it growing up." Through all of Fr. Mike's career stops, he says he's always made time to stay connected with his brother Knights. Even though the demands of the priesthood are many, he still finds it important to help the KC's in their works. "I look at it as a way to join other people in common cause, and the fraternity is great," Fr. Mike said. "It's a good thing for men and the Church."

Fr. Mike says he's been blessed to have traveled to many interesting locales like Egypt, Israel, Rome, and most recently Poland, Austria, Hungary, and the Czech Republic. Other past times include photography, spending time with family, and an eclectic taste in many different genres of music. While he enjoys riding a bicycle, he doesn't push himself to extremes. He saves that for his faith, quipping, "It's not rocket science, but it is an extreme sport."

LEADERSHIP SNAPSHOT -- THE GRAND KNIGHT AND TRUSTEES



The *Grand Knight* is the highest ranking elected officer and is responsible for observing the laws of the Order and the Council. Elected annually by the membership, the *Grand Knight* provides leadership to the Council officers, program directors, activity chairmen and Council members. More specifically, his duties include: presiding over Council meetings, convening officers for a monthly meeting, working with the officers on setting the agenda for the month and year, and making sure that all reports and reporting forms required by the state or Supreme Council offices are submitted on time.

In Council 945, the *Grand Knight* is first elected as a Warden, and then moves through the officer chairs (Warden, Advocate, Chancellor, and Deputy Grand Knight) until finally serving as the *Grand Knight*. This provides all the needed knowledge and orientation for the *Grand Knight* to be successful. 2235435

The *Trustees* serve for an additional three years and are *Past Grand Knights*.
