Brother Knights:

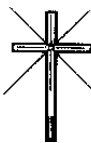

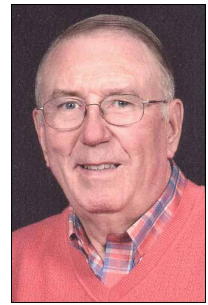
Tim Rice elected as Supreme Convention Delegate

The 109th Minnesota State KC Convention held in St. Cloud on May 15-16 provided a special surprise and reward for District Deputy Tim Rice. Through the efforts of PGK Joe Elbert from Council 945 and the other Councils in District #32, Tim was elected to serve as one of the delegates from Minnesota to the 128th KC Supreme Convention to be held in Washington, D.C. on August 3-5.

Joe Elbert, after making the speech at the State Convention for Tim's nomination, said, "I was sort of concerned about making the nomination presentation in front of 400 KC members. But, I had plenty of great material to cover. So it was easy, once I got started. On May 1, 1930, 10,000 VFW members staged a rally at New York's Union Square to promote patriotism. Through a resolution adopted in 1949, May 1 evolved into Loyalty Day. Observances began in 1950 on April 28 and climaxed May 1 when more than five million people across the nation held rallies. In New York City, more than 100,000 people rallied for America. In 1958, Congress enacted Public Law 529 proclaiming Loyalty Day a permanent fixture on the nation's calendar.

Council 945 and Msgr. Henry Speck Assembly have demonstrated the fourth principle of the order, patriotism, for many years by participating in the VFW Memorial Day parade. Again this year, the

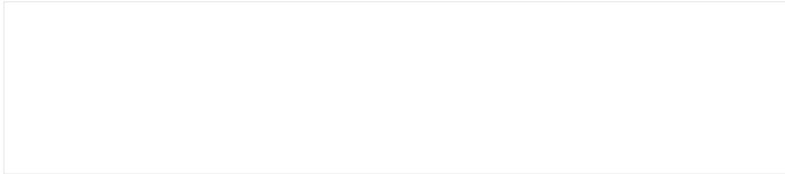
