Attentiveness to the Church's liturgical cycle gives us the spiritual basis on which to build a life in the changing seasons of our lives – personal, familial, work, and political. 4286949

We learn the teaching of Jesus; we ponder the mystery of his Church and the coming of the Kingdom of God. In each of their unique lives, now finished and surrendered to God, we can see in Kateri, Francis, Catherine, Leo, Anastasia and so many others how God moves us by grace through the events of our lives to a providential conclusion. In the mercy of God we seek to cooperate with that plan of Creation and Redemption.

May Christmas in particular fill us with hope and joy giving us strength and vision to bear the cross and look forward to the resurrection. May our families and friends be filled with peace and blessed with grace and favor.


