John lists his favorite KC project as Smokin' In Steele, but he rarely misses one of the benefit breakfasts where he is a proficient griller and a regular on the closing


John and his wife Donna are members of Sacred Heart Church and they have four children; two sons Cole and Lucas and two daughters Gretchen and Hannah.
