# Grand Knight's Message by Wade Schroeder

Matt Birk, former Baltimore Raven center, took a principled stand for life in response to the President's remarks to Planned Parenthood and his support for unrestricted abortion, and quietly did not attend the post-Super Bowl photo opportunity at the White House. I propose his action to the Knights as an example for us of how to live faith and patriotism in our time.

As we approach Independence Day our country is facing a maelstrom of constitutional and cultural questions that have been simmering for over 40 years and now have new attention with the IRS intrusive oversight, the roll out of the Affordable Health Care Act which is not respectful of conscience let alone the wallet, and the on-going disputes about right to life and the nature of marriage: What is a Knight to do? 3293553

It is patriotic to dissent. Matt Birk did so in a quiet and respectful way. In the midst of the storm we are in the world as Christ. With his word, the sea can be calmed, especially the storm tossed heart. We take up with Christ the standard of innocence, love and justice. With Christ there is no question of destruction of the sinner, but of repentance and regeneration. Thus all anger must be given away.

When the press picked up on Birk's absence, the criticisms began. Folks will walk away from the Church in part because the stand we take for life, for marriage in our imitation of Christ.

Others will charge us with hypocrisy because we don't live perfectly the faith we profess or the love we seek to live. That simply points more deeply to the mystery of Christ. The death of Christ delivers from all sin, even the sins of his followers. Apart from Christ we are simply a faction, another opinion, or passing fad. With Christ we need not despair. Christ has won the victory, this too shall pass. But that does not give us excuse for complacency for we are indeed called to witness.

So this summer let us reflect on our treasured freedoms and how fragile they are in the light of the glory of the grace of God in Christ through the power of the Holy Spirit. We are called to give witness to the values that endure and lead us and all to eternal life.

The William Warner Scholarship was established on May 10, 1972 by the William Warner Family and the Knight of Columbus. The original funds came from the William Warner Family, whose son died at a young age, and the KC members have also contributed funds over the years. The Council is responsible for Fund investments and administration of the scholarships.

To be eligible ... applicants must:

- be a member of the Catholic Church
- plan to attend a Catholic College or University.
- be average or above in academic achievement.
- be an active participant in school, church, and community activities.
- be a member of the current senior class of a Steele County High School.
- Sons or daughters of Knights of Columbus or deceased Knights shall receive preference.

The Council Trustees review application and select recipients. Currently the fund stands at \$29,733 as of January 1, 2013, and is supported by KC members through their voluntary donations in addition to their annual dues. Total voluntary collections from KC members for the William Warner Fund contributed in 2012 totaled \$1,229. These funds are invested and managed through "The Hartford" family of funds. Knights who would like more information about the scholarship fund, the candidates, or the process of selecting recipients are welcome to contact any of the trustees.

# Benefits Corner by Kevin Gallagher

A couple nights ago I woke at 3 am and my immediate thought was... what am I going to write about this month? After thinking about it for a few minutes, for whatever strange reason, Lynn Cain came to mind. I've thought about her often over the years and have referenced her story to many of my clients. Her story made an impact on me and countless people. I just learned she passed way at age 63.

In a nutshell, Lynn's husband Martin died in his 40's, leaving behind Lynn and their two or three children. The impact his death had on her and her children prompted her to write a book titled "Widow" which became a best seller, and from that came a documentary with the same title.

Martin died of a heart attack and left the family with inadequate life insurance. One thing that really stood out in her book and movie was that Lynn often said she was angry with Martin--and herself-for putting her and her kids in the awful state they were in. In the documentary, you could "feel" her anger, fear, and hurt. She was basically saying..."Hey look...don't let what happened to me and my kids happen to you...this should never have happened and now we'll pay dearly for a long, long time. At one point she tells about how their life insurance advisor proposed additional coverage on Martin and she responded by saying "Oh…that's peanuts". She said she regretted that statement more than anyone will ever know, because--in her words--it wasn't peanuts...it was peanut butter, clothes, medical and dental bills, phone bills, school expenses, and onand-on. 3668451

I believe I have her video somewhere and possibly a copy or two of her book, which I am now going to find. If anyone would like to view it please let me know.

Thanks Lynn, for having the courage to speak up and tell your story. Hopefully we will listen...
