## Chaplain's Message by Rev. Edward McGrath

With Pentecost upon us, Easter has wound down, and ordinary time about to begin again with the advent of early meteorological summer. With summer come many outdoor activities and vacations. Please remember to keep prayer and Mass as the center of your travels and recreation.

Planning is much easier in our day and age with the internet. You can book transportation and lodging ahead of time. For example you can check masstimes.org for Sunday Mass near where you might be going. I suggest you consider religious housing as an alternative to the usual motel or hotel. Most monasteries and some convents and priories have guest houses or retreat houses that can be rented, and then you have the advantage of daily Liturgy of the Hours and Mass, but lack a pool and waterslide!

Folks are a bit more aware of this in Europe, but the idea is spreading in the USA. Friends of mine have stayed at Leo House in New York City which is very economical and very free, and is an apostolate of the Sisters of St. Agnes and lay coworkers. Rooms begin around \$120 for single and \$240 for family (rates increase this summer). There may be similar guesthouses in other larger cities of which I am not aware.

My favorite is Christ in the Desert Monastery near Abiquiu, New Mexico, to which I will return this summer. I enjoy a few days of monastic prayer and life in a canyon of stunning beauty. The hospitality is quite simple.

Brother Knights, do consider summer as a time to renew and deepen prayer. Even the outdoor activity can be drawn into a deeper prayer life in gratitude to God for the wonder and beauty of nature. This is a time when youngsters can learn the value of prayer and be schooled in its discipline in the family. I always remember our family picnics beginning with prayer, and even the township picnics began with singing the doxology!

We have one ordination this year, and with retirements at least two pastors will not be replaced. The next possible sacerdotal ordination will be in three years with three candidates currently. A number of our parishes are in transition from parish to oratory and Mass schedules will be rearranged in the coming year or so. Keep praying for vocations. Encourage our young people to engage in discernment of God's call to priesthood or to consecrated life as a religious sister or brother.

Dan Pirkl is a native of the area. He was born and raised in the area. He graduated from what was then known as St. Augustine's Catholic High School in Austin. ## Benefits Corner by Luke J. Rennie

#### Long Term Disability Awareness Month

According to the United States government, a staggering one in four of today's 20-year-olds will become disabled before reaching the age of 67.1 The nature of the job is irrelevant. According to the Social Security Administration, 95 percent of all disabling illnesses and accidents happen outside of the workplace.

Consider a typical male, age 35, a non-smoker, who works at an office job with some outdoor responsibilities and leads a very healthy lifestyle. He has a 21 percent chance of being injured or becoming ill and unable to work for three months or longer prior to retirement.

And what happens once that occurs? What happens if your last paycheck is your last paycheck?

If your illness or injury is among the 95 percent that happen outside of work, workers' compensation will be of no assistance to you. If you plan to rely on the government, you may find that you are among the 64 percent of Americans - including severely disabled Americans - who do not receive any assistance from the government or governmental programs, including Medicare, Social Security, and Supplemental Security Insurance.
