It's party time! After forty days of Lenten penance the Church gives us fifty days of Easter joy! Although the flowers in the sanctuary begin to droop and lose their blooms the Easter season continues through Pentecost.

Contemporary society is better about preparation than lingering. Think of Christmas with decorations appearing in November and trees on the street corner the day after Christmas. The Church has a different logic. We take time to prepare but then we also celebrate the great mysteries of salvation that are at the heart of our liturgical year. We take the 12 days of Christmas to ponder and rejoice in the incarnation and 50 days to revel in the joy that comes from the Passion, Death and Resurrection of Jesus.

I invite you, during these fifty days of Eastertide, to keep the joy of Easter in your heart. Reflect on the ways that Lent helped you to conquer sin. Ponder what it means that Jesus died and rose for us. Think about what it means that we are freed from the chains of death and given the opportunity to enter the heavenly kingdom. At the Easter Vigil we sang the Exsultet, an ancient hymn that gives voice to our joy. Let it be the song in our heart throughout this season. "Rejoice, heavenly powers! Sing, choirs of angels! Exult, all creation around God's throne. Jesus Christ, our King is risen!"

#### Benefits Corner by Kevin Gallagher

This month, I would like to address those of our members who might consider doing something really beneficial and unique for your church, our schools, members of the clergy, or religious orders.
