Chaplain's Message by Rev. Edward McGrath

In this Year of Faith, the work of the Knights of Columbus to promote understanding of the Catholic faith has been and continues to be valuable. I think we need to be equally clear about civics. In the various controversies running up to the election there is a concerted effort to isolate faith from politics. We can see that in the language of some politicians who are Catholic and oppose abortion, but are unwilling to impose their religious views on others. That presumes that abortion is a religious issue in the same way that a Catholic politician would declare support for the corporal and spiritual works of mercy and not want to enshrine them in law, which would be quite correct. I think all would agree that the practice of our faith or any religion should not be required or favored in law. But that does not mean that our faith or religion in general does not have something to say about law and public policy which is in itself not simply religious or about our faith. I am personally opposed to theft, and I expect any reasonable person would agree that theft should be illegal and not simply because it is in the Bible and church moral teaching. Even the thief would not want to be a victim of theft, and we can presume that even the pro abortion person is glad they survived the womb! 1312028

These are tough and emotional issues. The right to life of one is pitted against the right to life of another. Many seek to transform marriage from a fundamental cultural institution anchoring the family to a right of free association. We need to continue to speak to these with conviction and with the kindness and mercy of God.

So what is the civil role of religion? May we be as familiar without founding civil documents and legal tradition as we seek to be as a Catholic about the Sacred Scriptures, the patristic writings, the councils, the catechism and the traditions of our faith. So we can recall that the Declaration of Independence acknowledged that our basic rights, by consensus among the Colonies declaring their independence of the British Crown, life, liberty, and the pursuit of happiness come from the Creator. The ratification of the Constitution was agreed to by the states with the promise of a Bill of Rights, the first ten amendments to the Constitution - and the first freedom guaranteed is the freedom of religion. Note the importance of a preposition: "of" religion, not freedom from religion, against which Congress is to make no law. Reading the Federalist Papers helps us understand the importance of religion and the growth of tolerance in the revolutionary period. Contrast that with the violence and anti religious spirit of the French Revolution.

Unfortunately, in my opinion, the catchy phrase of Thomas Jefferson, "wall of separation" between church and state, it seems to me, colors the current interpretation of religious freedom to relegate religion to the margins of private choice along with an emerging intolerance of the way in which religion has a formative role in the culture that supports the state. Dismissing the Ten Commandments from parks and courtrooms will tend to support a legal system and a culture that is militantly secular and increasingly intolerant of religious diversity. Thus Catholic hospitals and institutions will be tolerated as long as they follow the prevailing social and legal norms which may, and in some cases now, do restrict religious freedom.

We do not live in a democracy, we are a republic with democratic institutions. A republic is limited government. Our faith and every faith has prospered in the constitutional, legal, political, and civil traditions established in our founding as a nation. I think we are seeing some erosion of that in an atmosphere of political correctness that mirrors the excesses of mob rule. We certainly live in challenging times. Read the Declaration of Independence. Read the Constitution and its amendments. Read the Federalist Papers. Reflect on the founts of law and good government.

Benefits Corner by Kevin Gallagher, LUTCF, FIC

We just ended "Life Insurance Awareness Month" (September) and I'm afraid it had little impact on you and me. A very recent study showed that on a national basis, the gap between the amount of life insurance a primary breadwinner should own and what they do own is...a mere... mind-boggling...20 trillion dollars. In addition, this gap is increasing year by year so it is not surprising that life insurance ownership is at a 50-year low. This study provided some additional interesting observations. 1249486

First, 80% of underinsured households named affordability as one of the main reasons they have not purchased more life insurance, yet 80% overestimated what it would cost to purchase the much-needed additional coverage. The majority of families believe life insurance is more important today than at any time in the past, yet most said they were "not confident" in the amount of coverage they had.

Why?

Why is it virtually every homeowner insures his or her home for at least 100% of replacement cost, but insures his or her economic value

to those he loves for only a fraction of his or her worth? The odds of your house being destroyed are a very small percentage. What's the chance of your dying? I'll give you a hint...it's more than 99.99%.

Studies continue to point out that there are fewer and fewer people like me out there meeting with people one-on-one. I also believe we are not successfully educating and communicating to people about the need for proper planning. Simply put, we have to do a better job.

But when it's all said-and-done, it is your responsibility to make sure you have what you should have- that in your own personal situation there is no "gap". And that, of course, is where I can help. You might be surprised how affordable life insurance is. But, please don't wait until it's too late. The statement, "I'd rather buy it 10 or 20 years too early than try to get it 1 day too late" is good advice for all.

Associated Press Broadcast Board of Directors.

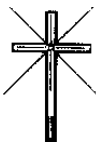
Dan is a member of Sacred Heart with his wife of 16 years, Tracy. Together, they have three boys. 4337888

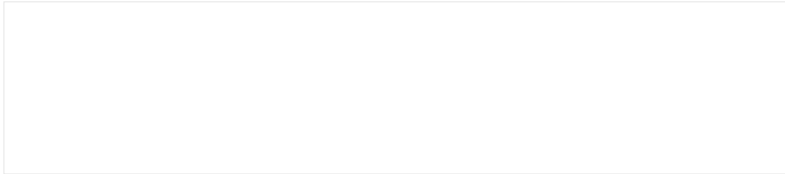
