Chaplain's Message by Rev. John Sauer

The month of November is traditionally a time in which the Catholic Church remembers those who have died. We begin the month with the companion feasts of All Saints and All Souls. While much of contemporary society seems to be uncomfortable talking about death (except when it is splashed across the screens of the movie theaters) the Christian community reflects on death in light of the Passion, Death and Resurrection of Jesus Christ. His experience has changed our perspective on death and has given us hope for a future of eternal life.

Some years ago, as Cardinal Joseph Bernardin of Chicago died, Newsweek magazine featured a cover story on the Cardinal entitled, "Teaching Us How to Die." The authors reflected on the life and very public death of this man. Even his dying became a moment of teaching and witness. He reminded us that death is a "transition from earthly life to life eternal." And while our heads might tell us that is true, we often live in fear of death. We fear the unknown, the possibility of an end to our existence. We are concerned with what happens to us — not as a physical body — but as a person, a human being with a soul and a life which has meaning.

In his own death, Jesus experienced all that we do when confronted with the reality of death. He felt the darkness, the threat, the loneliness. He knew the powerlessness and suffering. What is unique and salvific is the response of Jesus in the face of his own death. In his struggle Jesus accepts death. He places his hope in the Father, overcoming death itself. By his submission to God's will Jesus begins to live fully with God. In speaking of the death of Jesus, Jesuit theologian Juan Alfaro states, "the very event of death, the disintegration of man's existence in the world, has become the personal meeting with God who 'gives life to the dead.'" There is really nothing in the human experience of death that would lead one to proclaim faith in eternal life with God. The insistence of the Christian community that we have such faith is a constant affirmation of our confidence in the power of the Risen Christ.

I encourage you to take the opportunity to visit the graves of your loved ones and our brother Knights and their loved ones this November. Pray for them. Pray for the grace of a happy death. But above all, be confident that the power of Christ overcomes even death itself.

Also this month we will be bringing to a close the Jubilee Year of Mercy. I hope you had an opportunity to open yourself to the special gifts of God's love and mercy. We have been blessed to have a holy door here in Owatonna at Sacred Heart. If you have not already done so I encourage you to avail yourself of the indulgences attached to passing through a holy door. Attend Mass, receive forgiveness in the Sacrament of Reconciliation, pray for the intention of the Holy Father, and recite the Creed. It is a kind of spiritual, if not physical, pilgrimage.

PRESIDENTIAL/VICE PRESIDENTIAL CANDIDATES

Where Do the Candidates Stand on Abortion?

U.S. PRESIDENT



Donald Trump

Hillary Clinton ABORTION ON DEMAND

The 1973 Roe v. Wade and Doe v. Bolton Supreme Court decisions legalized abortion on demand throughout the United States. There have been more than 59 million abortions since then.

"Let me be clear - I am pro-life. _ I did not always | hold this position, but I had a significant personal experience that brought the precious gift of life into perspective for me."

In 2003, Hillary Clinton voted to endorse Roe v. Wade, which allows abortion for any reason, In 2016, Clinton said, "The unborn person doesn't have constitutional rights, "later adding she believed this to be true even on the unborn child's due date.

PARTIAL-BIRTH ABORTION

The partial-birth abortion procedure — used from the fifth month on — involves pulling a living baby feet-first out of the womb, except for the head, puncturing the skull and suctioning out the brain. The Partial-Birth Abortion Ban was upheld by the U.S. Supreme Court in 2007 in a 5-4 decision.

In 2000, in his book The America We Deserve, Donald Trump wrote that after consulting with doctors about the partial-birth abortion procedure, he concluded that he would support a ban on that method.

In 2003, Hillary Clinton voted against the Partial-Birth Abortion Ban Act (voting to allow partialbirth abortions to continue) every chance she got.

NOMINATIONS TO THE U.S. SUPREME COURT

The next president may have the opportunity to appoint three or four justices to the U.S. Supreme Court.

In May 2016, Donald Trump released a list of eleven conservative judges whom he would consider for a Supreme Court vacancy, saying, "By the way, these judges are all pro-life."

Hillary Clinton has said that she would only nominate Supreme Court justices who would uphold the decision that legalized abortion on demand. "I would not appoint someone who didn't think Roe v. Wade is settled law."



VICE PRESIDENTIAL CANDIDATES



Mike Pence

Mike Pence had a solid pro-life voting record on abortion during 12 years in the U.S. House, including votes for passage of the Partial-Birth Abortion Ban Act. As governor of Indiana, Mike Pence championed many pro-life measures.

Tim Kaine voted against the pro-life position in the U.S. Senate every chance he got. He voted against the Pain-Capable Unborn Child Protection Act. Tim Kaine co-sponsored a bill (S. 217) that would nullify virtually all state limits on abortion, including late abortions.

CONGRESSIONAL CANDIDATES RESPOND TO SURVEY

Candidates for the U.S. House of Representatives were asked the following questions. A short explanation precedes each question.

PRO-LIFE LAWS

ABORTION INDUSTRY FUNDING

The federal government is often asked for funding for the abortion industry, including subsidies for abortion and abortion providers as well as foreign aid for such purposes and abortion advocacy. Even many who support abortion are not supportive of using taxpayer funds to support abortion.

a.Will you vote to limit and/or prohibit taxpaver funding of the abortion industry?

LIFE-DESTRUCTIVE RESEARCH

4. Would you vote for legislation to prevent federal support of research that harms or destroys human life at any stage of development. or that uses cells or tissues that are obtained by harming or killing human life at any stage of development?

DENIAL OF LIFESAVING MEDICAL CARE

Some hospitals have implemented formal policies authorizing denial of lifesaving medical treatment against the will of a patient or the patient's family if an ethics committee thinks the patient's so-called quality of life" is unacceptable, even though the patient and family disagree.

5. Will you vote to prohibit involuntary denial of lifesaving medical treatment against the will of the patient?

ASSISTED SUICIDE

Across the country, there are increasing efforts to legalize assisted suicide.

FREE SPEECH RIGHTS.

ANSWER MCCL SURVEY

Following are responses of candidates for the Minnesota Senate and House of Representatives to the questions on this page. Use the response key below to interpret the chart. You are represented by one senator and one state representative.

Incumbents' pro-life voting records for the last term (2015-2016) are listed following their responses to the MCCL questionnaire. You may wish to compare incumbents' responses with their pro-life voting record.


- 1. MCCL has supported the passage of many pieces of lifesaving legislation. These include, but are not limited to, parental notice for minors seeking an abortion; informed consent, including information on fetal pain and the offering of pain reducing drugs for the unborn child during an abortion; abortion reporting requirements, and providing grants to organizations that offer positive alternatives to abortion. Will you vote against any attempts to weaken or rescind previously passed MCCL-supported laws and provisions?
- 2. MCCL has a proven record of lifesaving victories at the Legislature, each carefully crafted to further our strategic plan for creating a pro-life Minnesota. This strategic plan involves an incremental approach which allows for the greatest number of lives saved while working toward our ultimate goal of establishing respect for human life in our laws and culture. Will you


vote for lifesaving legislation that advances MCCL's incremental approach and provides protections for the unborn and their mothers?

- 3. Even many who support abortion are opposed to taxpayer funding of abortion. Will you vote to limit and/or prohibit taxpayer funding of abortion in Minnesota?
- 4. Biological-related technologies have been advancing rapidly in recent years. While most of these developments offer great promise, some require that another human life at an early stage of development be harmed or killed (e.g., embryonic stem cell research, human cloning). Do you believe that the state should provide protections for nascent humans against biological research and technologies?
- 5. MCCL has worked with elected officials to protect vulnerable Minnesotans and those who are nearing the end of their lives. Many protective laws have been passed including a prohibition on assisting suicide or assisting an attempted suicide (MN Statute 609.215), and a provision requiring health care providers to "take all reasonable steps" to comply with requests for nutrition, hydration or health care that "has a significant possibility of sustaining" a patient's life and allowing for transfer of such patients to receive care elsewhere if the provider is unwilling to provide the care (MN Stat.

145C.15). Will you vote against any attempt to weaken or rescind the MCCL-supported laws cited above?

- **6.** Legislation was recently introduced to legalize assisted suicide (S.F. 1880/H.F. 2095) for certain individuals. Will you vote against any attempts to legalize assisted suicide in Minnesota?
- 7. MCCL respects the right of patients and/or their proxies to make medical decisions. Additionally, MCCL is opposed to any efforts that seek to force medical decisions on others which are based on quality of life criteria. Will you oppose efforts that replace the patient (or proxy) with government standards in regard to medical decision-making, resulting in rationing of care?
- 8. As a grassroots advocacy organization that is committed to working within the legislative and judicial processes, MCCL has always had an interest in issues that affect elections. We are strongly committed to maintaining free-speech rights in order to maximize our ability to communicate with our members and the public without restrictive administrative burdens, and we support fair, secure elections between competing candidates.
