Summer is winding down and what a summer it has been. As we dig our sweatshirts back out we also begin planning and looking forward to the start of school, fall harvest, fall sports (Skol Vikings!), and other autumn favorite activities and events.

An important event coming this fall is the upcoming presidential election and two important Minnesota ballot initiatives. The Minnesota marriage amendment is a specifically hot button topic this election as both sides of the issue are gearing up early to get their message out. The opponents of the amendment talk about equality and bigotry while the supporters of the amendment talk about the importance of family structure and the definition of a family. I am hearing a lot of opinions on the matter but few people seem to be talking about the facts. I will share some thoughts on the opinion side of the vote in the October newsletter but for now, here are some simple facts every voter needs to be made aware of during the upcoming election.

1. From the verbage used on the ballot to the structure of the vote itself, the entire process can be confusing to anyone.

- a. If you support same sex marriage you would vote "NO"
- b. If you support marriage being defined as between a man and woman only, you would vote "YES"

2. The vote is to decide if the state of Minnesota should create a constitutional amendment reaffirming the current law that defines marriage as being between a man and a woman. Because same sex marriage is not currently legal in Minnesota, no rights that anyone currently have will be taken away from them with an amendment. 3005564

3. The amendment is intended to avoid having the issue decided in the court system; potentially by a single judge. The amendment instead allows the people of Minnesota to decide the matter. Although it still is not completely immune from judicial review in the future, the chances of it being changed go down considerably with the passage of an amendment.

4. The voting rules are set up in such a manner that if you vote on the rest of the ballot but choose not to vote on the marriage amendment, your ballot will automatically be considered a "NO" vote which is to mean you will be supporting same sex marriage.

While it would be irrational to think all of the council's KC members think alike, it should be reasonable that all of us know and understand the issue before we vote in November. Please plan to take the time to vote on the issues this year, define your position before you vote and understand how the voting rules are set up so you can make your vote accurately and make it count for your convictions. 
